Product specific:

Soldering:

The solder profile must comply with the technical product specifications. All other profiles will void the warranty. All other soldering methods are at the customers' own risk.

Cleaning and Washing:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. 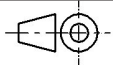
