Typical Insertion Loss:



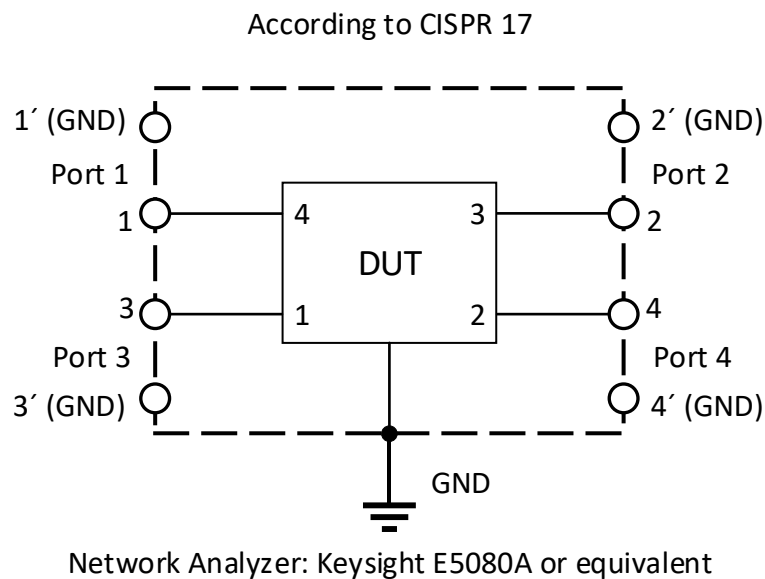

Soldering

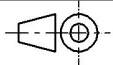

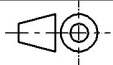
