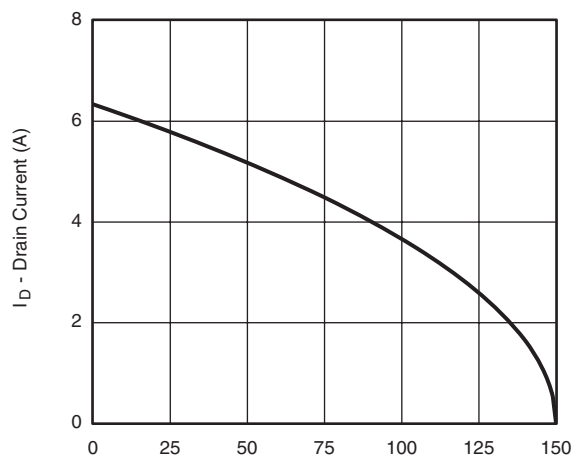

Safe Operating Area, Junction-to-Ambient

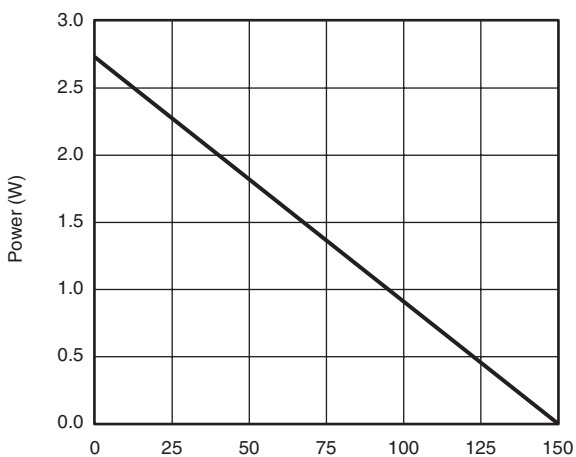

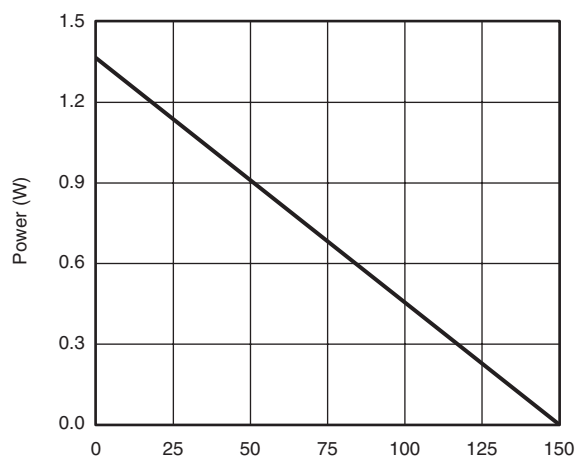
T_C - Case Temperature (°C)

T_C - Case Temperature (°C)

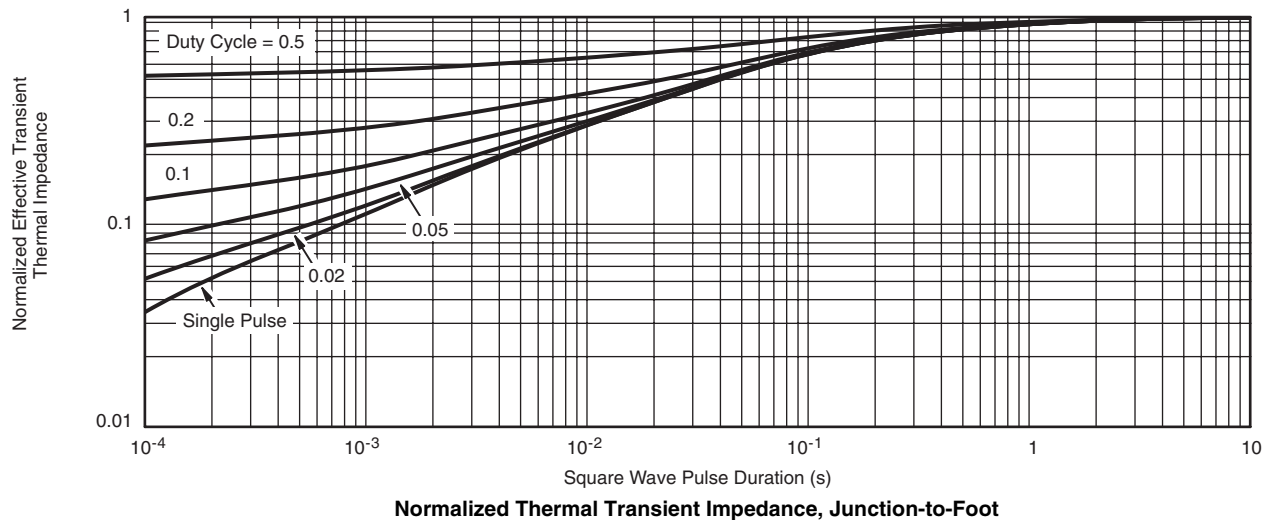
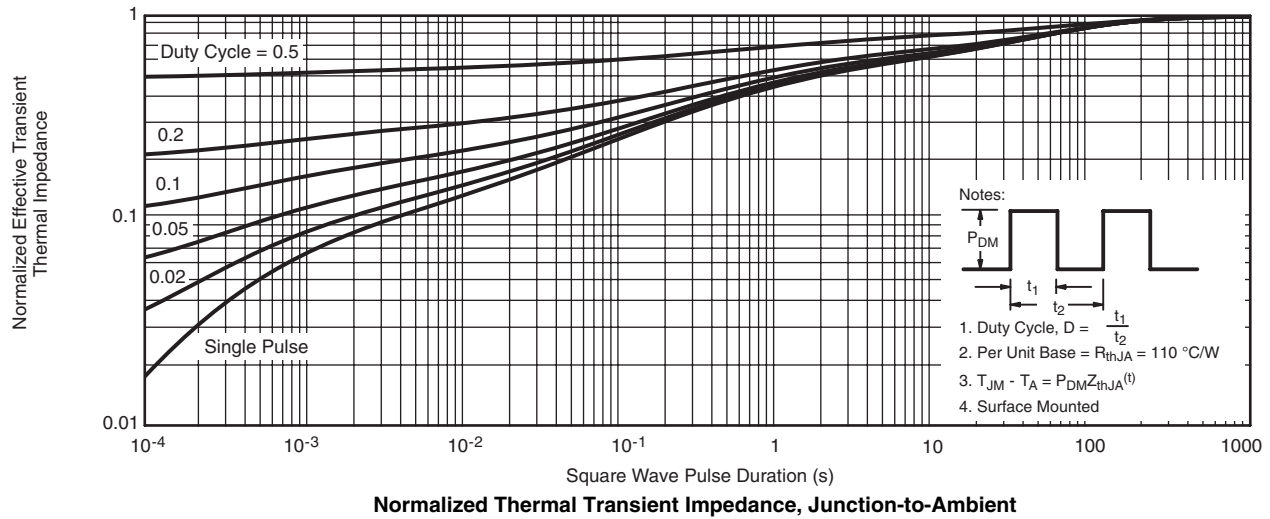
Power, Junction-to-Case

Power, Junction-to-Ambient

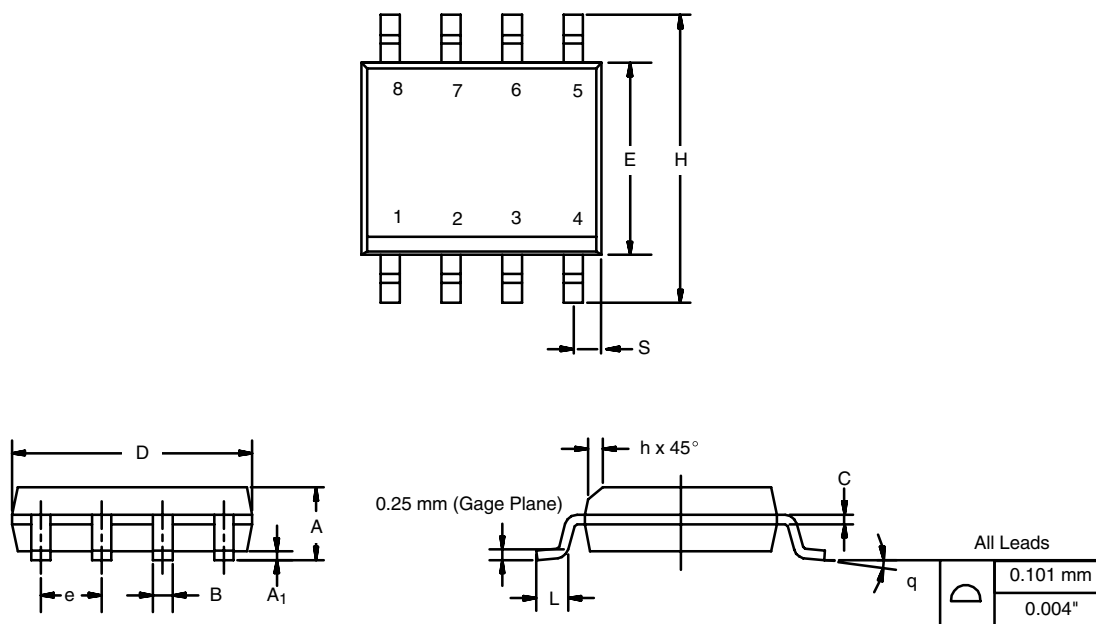

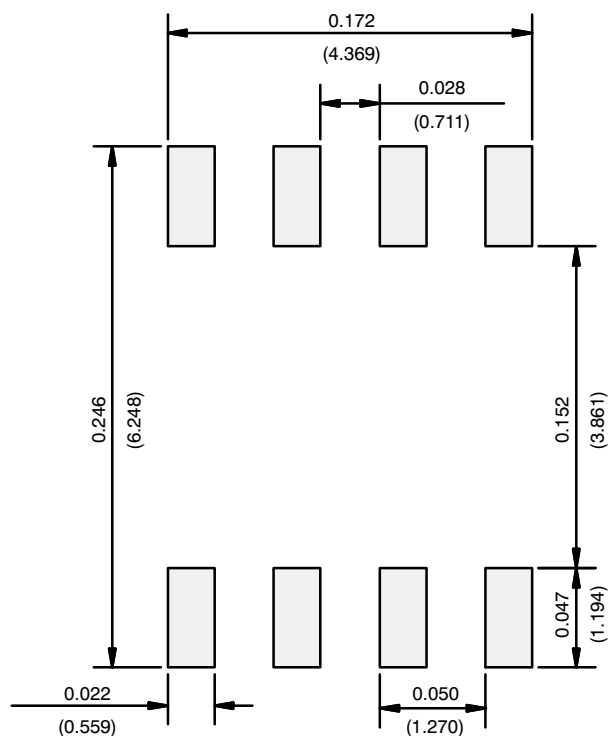
