Transmission Line Pulsing (TLP) Measurement:



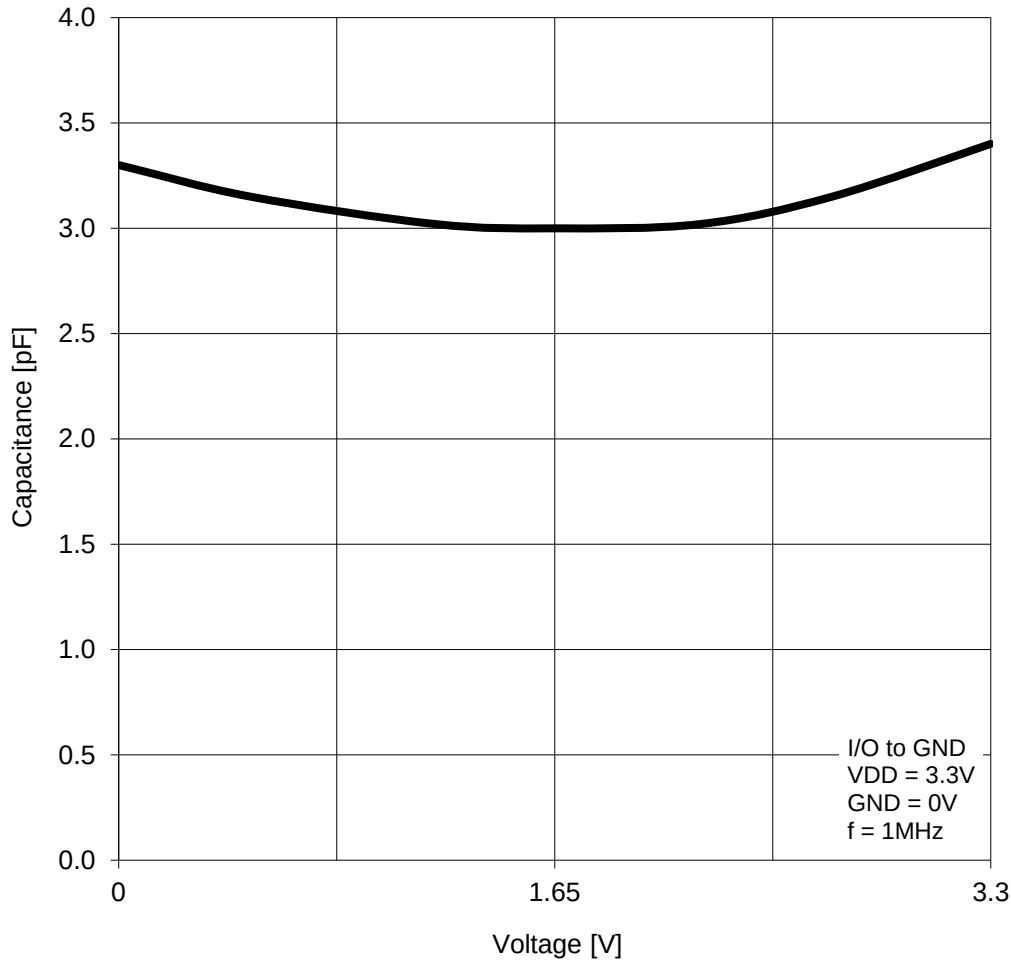
Clamping Voltage vs. Peak Pulse Current:



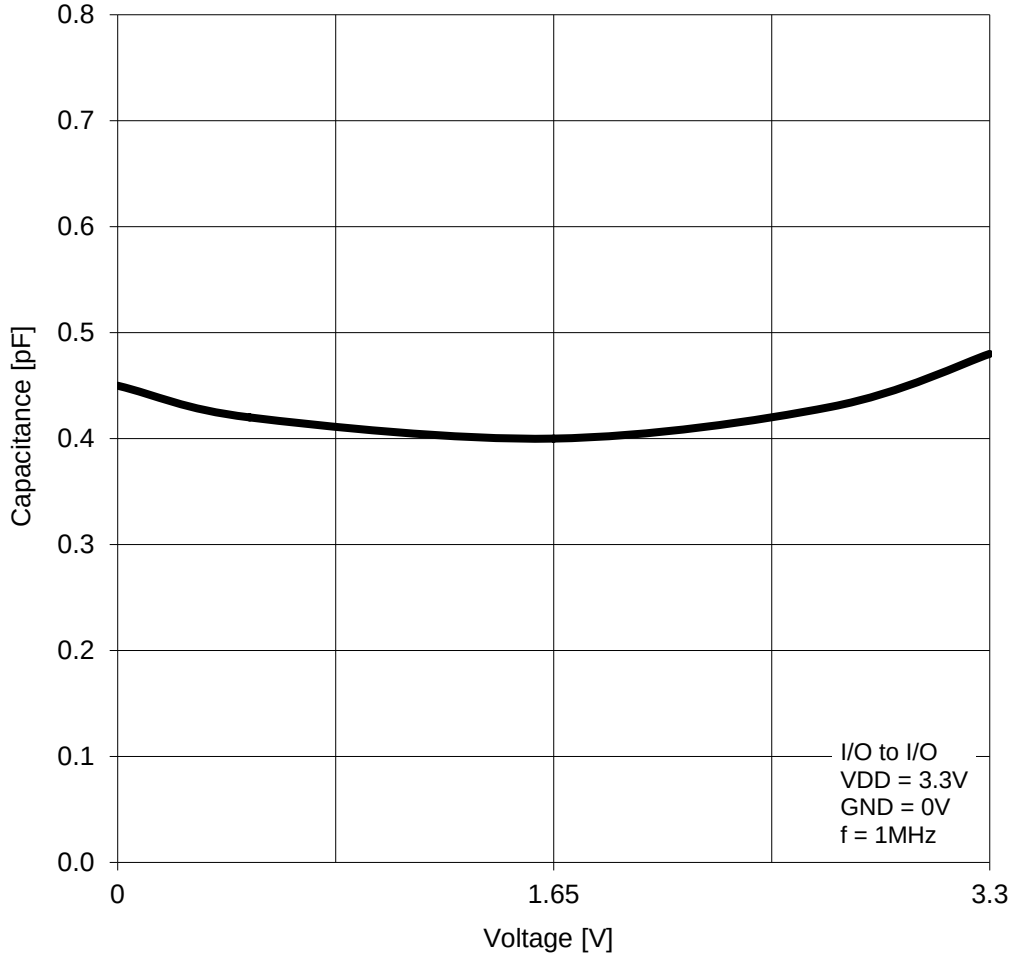

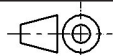

Variation of CIO vs. VIO:



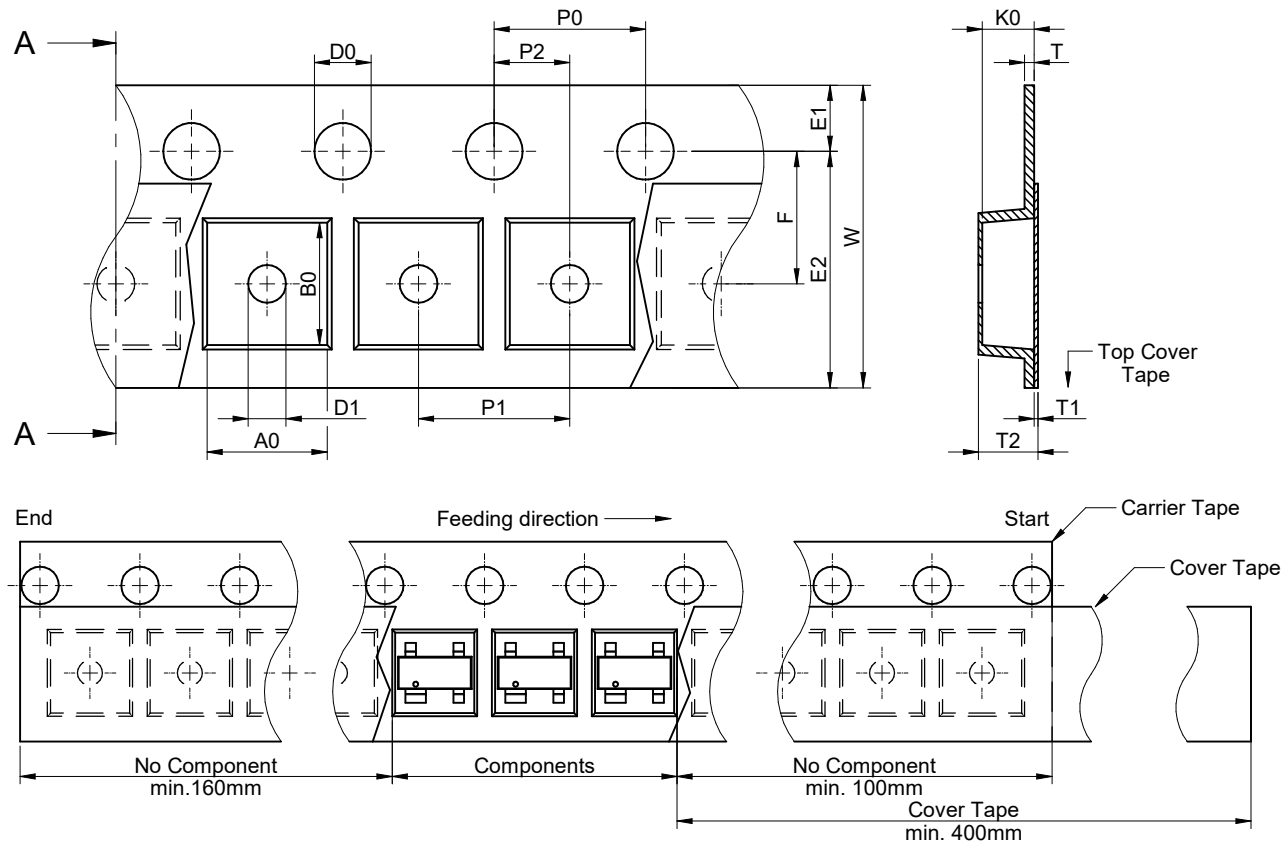
Variation of CX vs. VIO:
