Typical Attenuation:



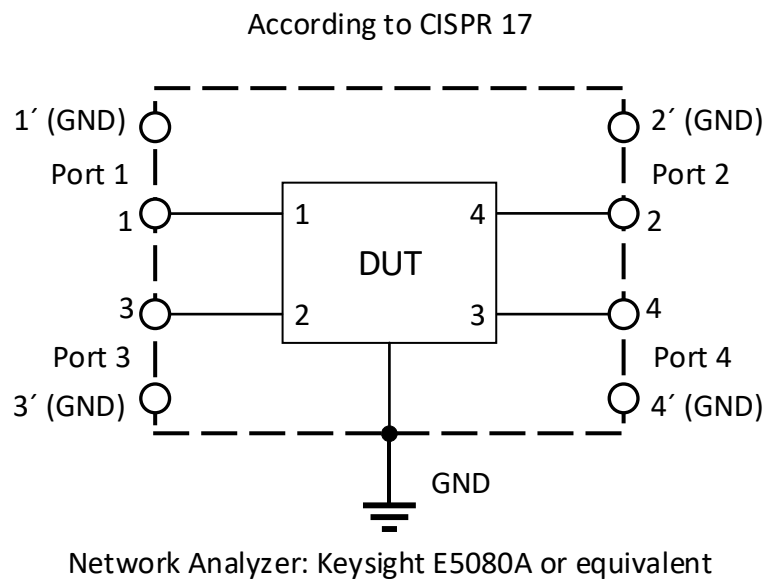
