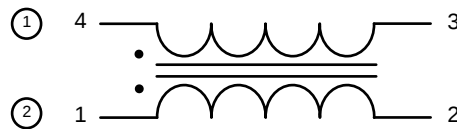


Recommended Land Pattern: [mm]

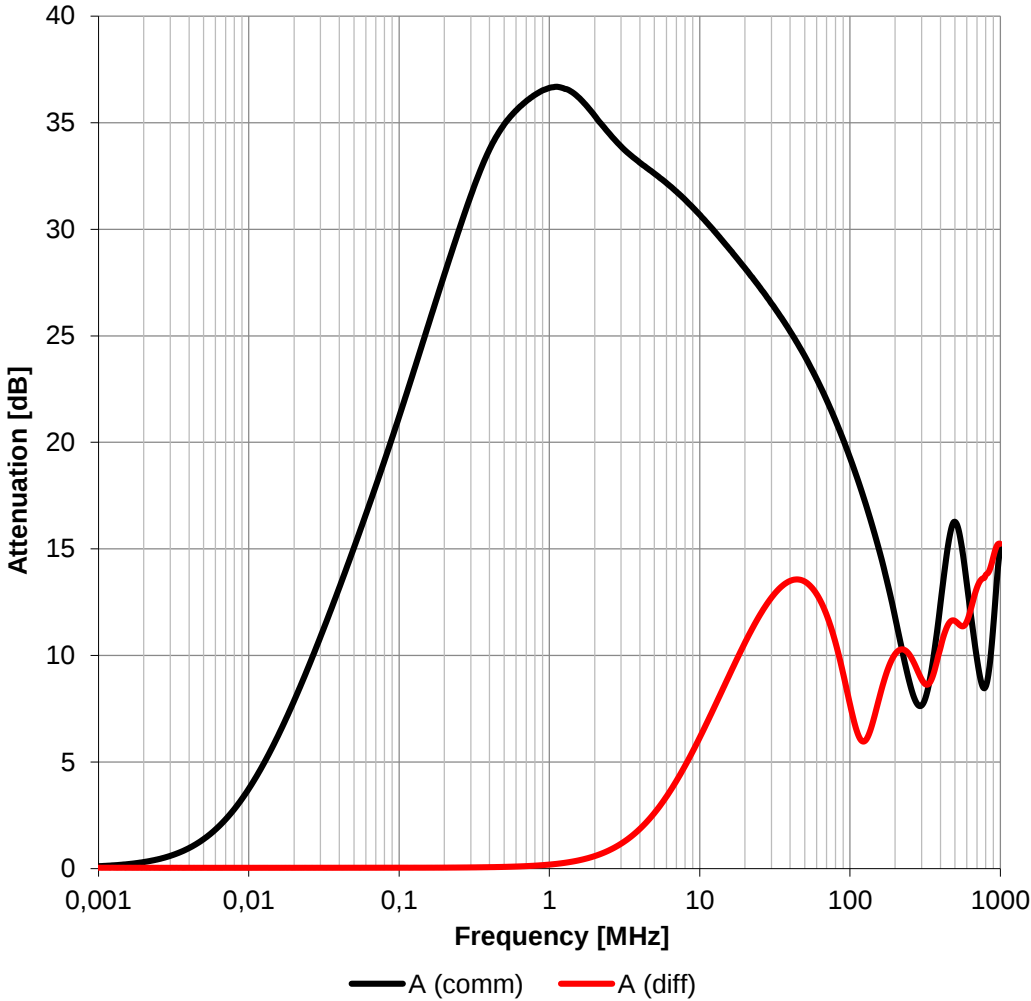

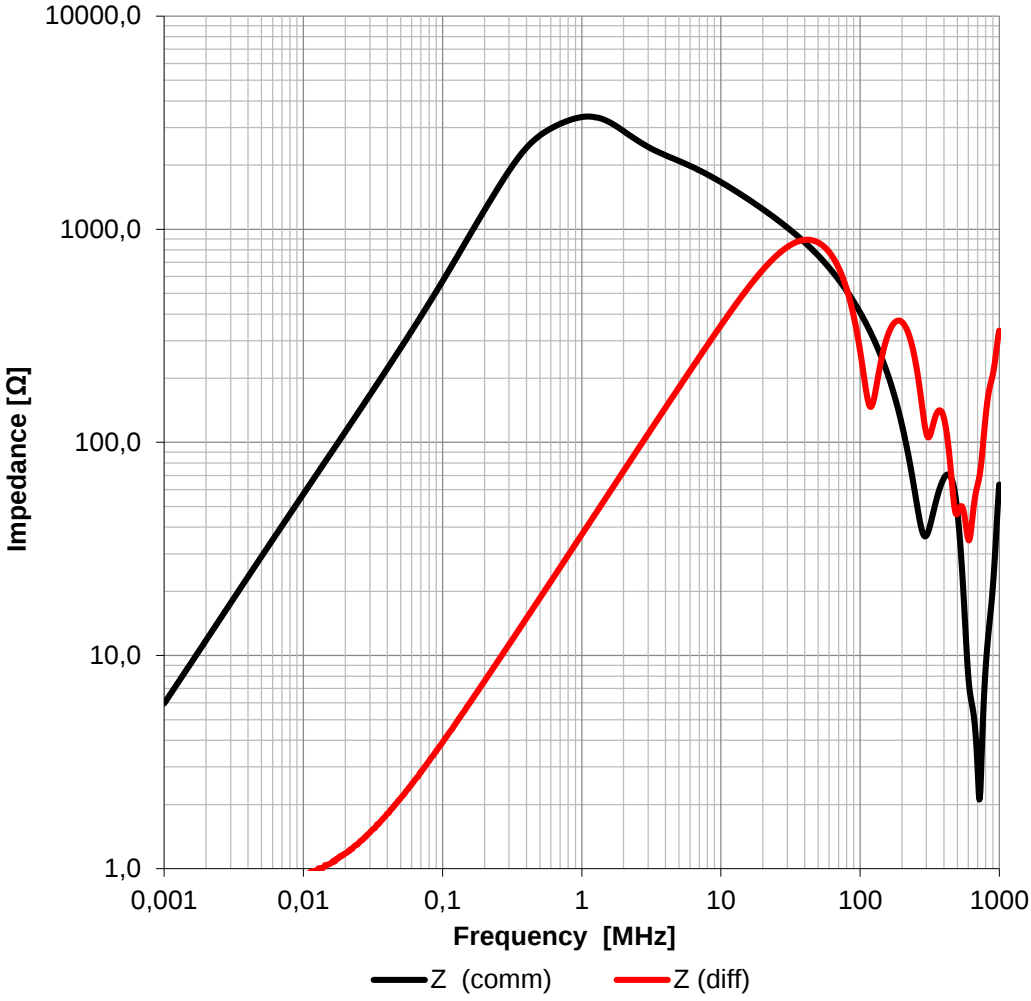

Typical Insertion Loss:



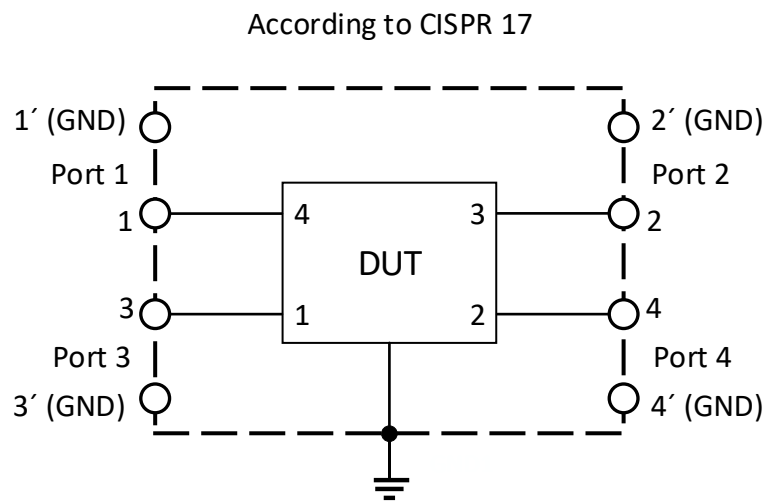
Typical Impedance Characteristics:

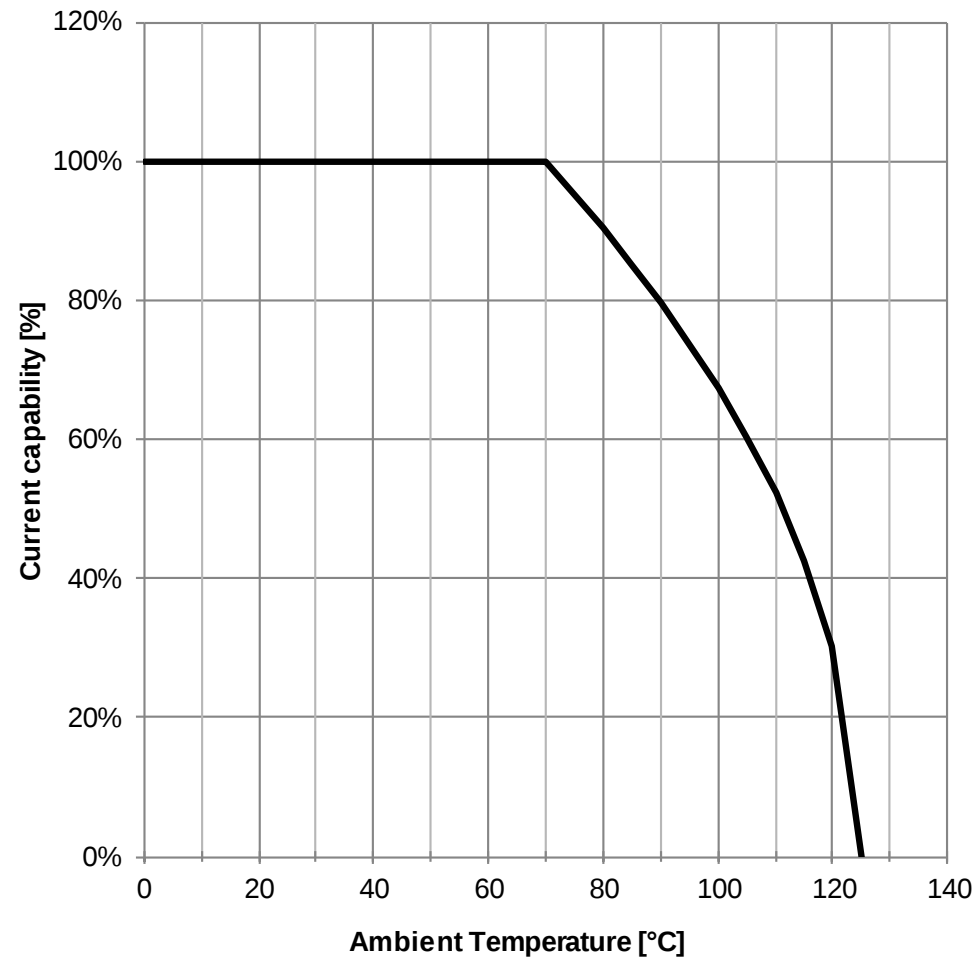

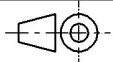

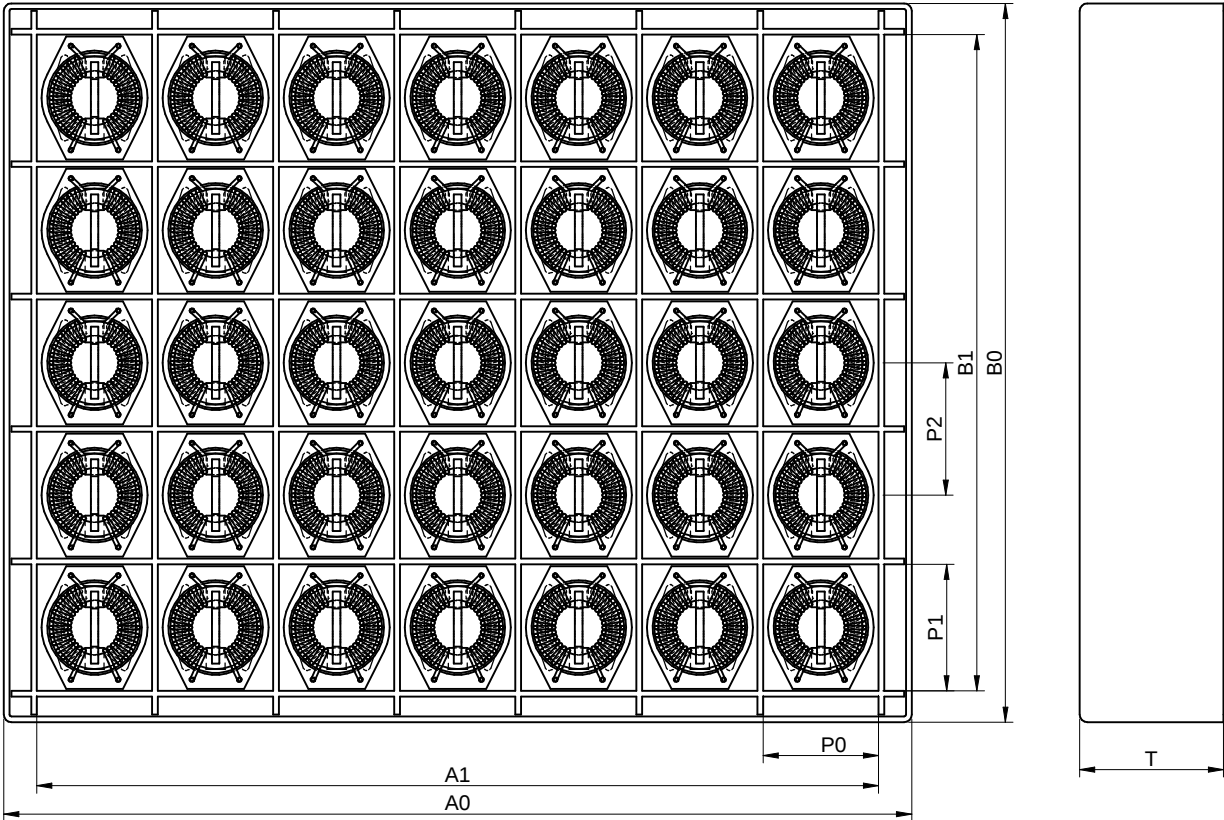
Derating Curve:



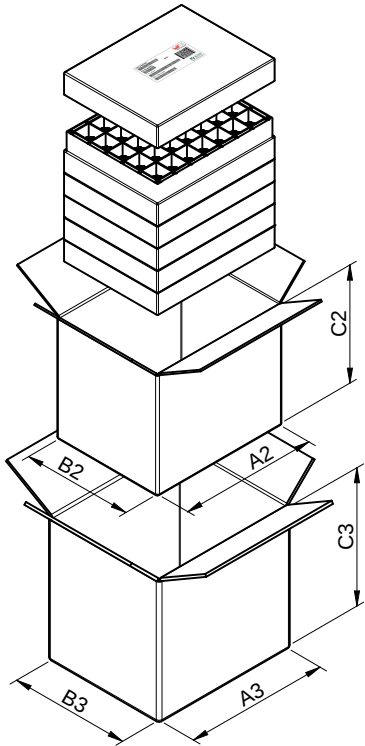

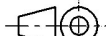
