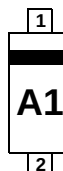

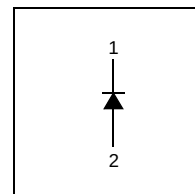
Small Signal Diode

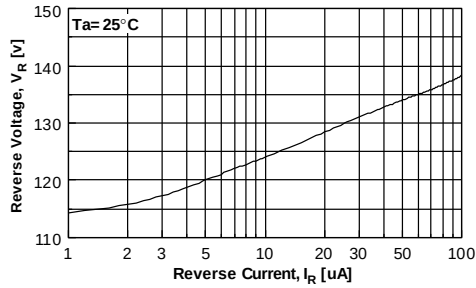


Figure 1. Reverse Voltage vs Reverse Current
BV - 1.0 to 100 μ A

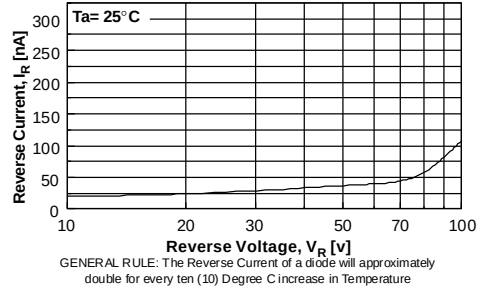


Figure 2. Reverse Current vs Reverse Voltage
IR - 10 to 100V

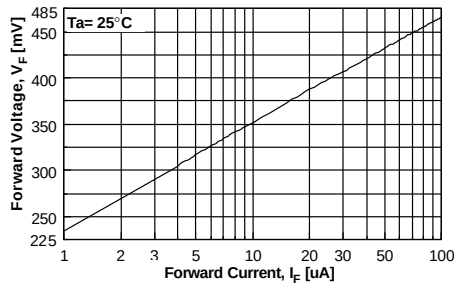


Figure 3. Forward Voltage vs Forward Current
VF - 1.0 to 100 μ A

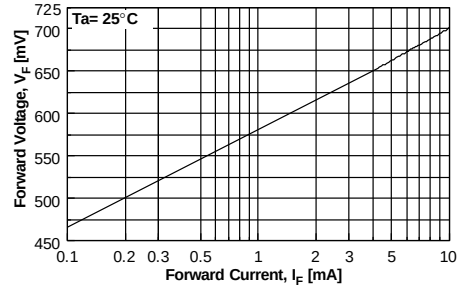


Figure 4. Forward Voltage vs Forward Current
VF - 0.1 to 10mA

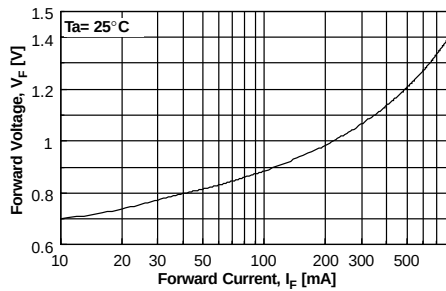


Figure 5. Forward Voltage vs Forward Current
VF - 10 - 800mA

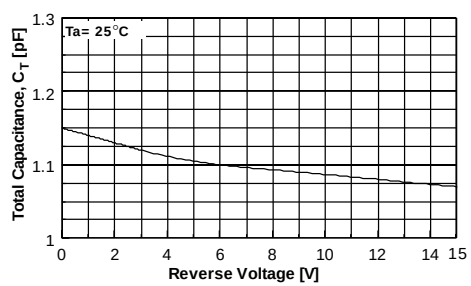


Figure 6. Total Capacitance

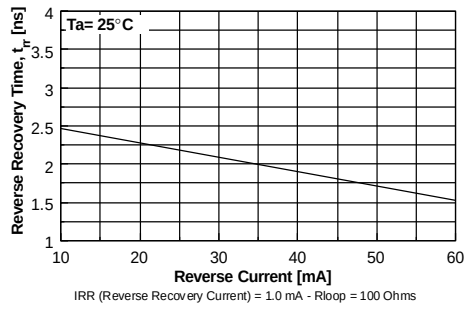


Figure 1. Reverse Recovery Time vs Reverse Current
TRR - IR 10mA vs 60mA

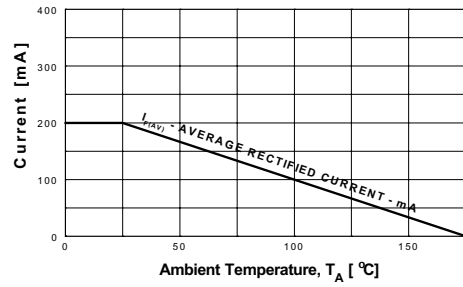


Figure 2. Average Rectified Current ($I_{F(AV)}$) vs
Ambient Temperature (T_A)

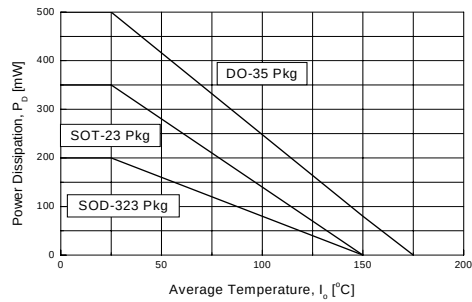
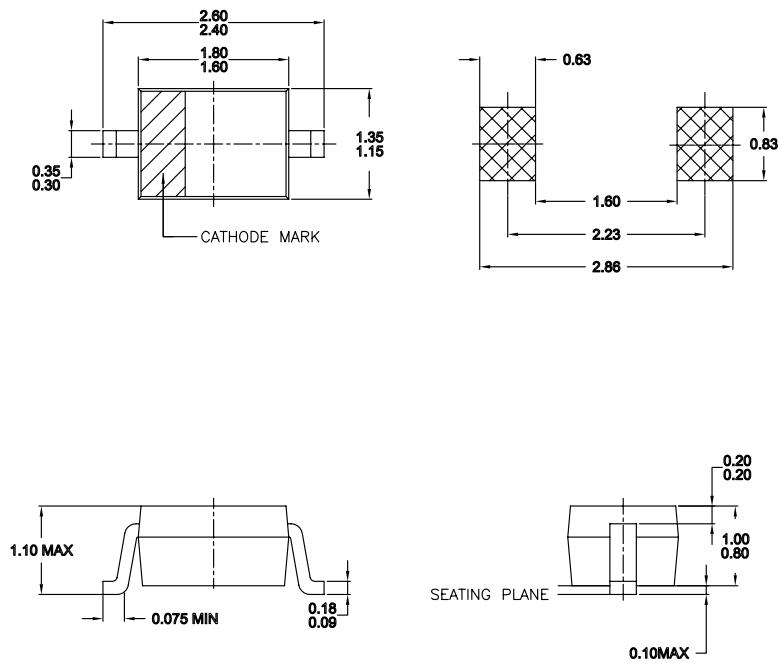


Figure 3. Power Derating Curve

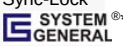
