Typical Inductance vs. Current Characteristics:



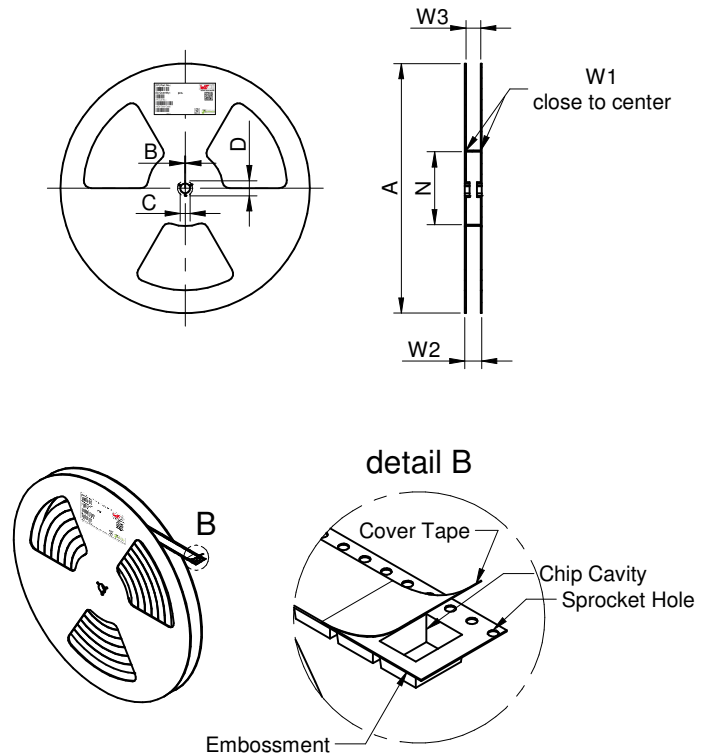
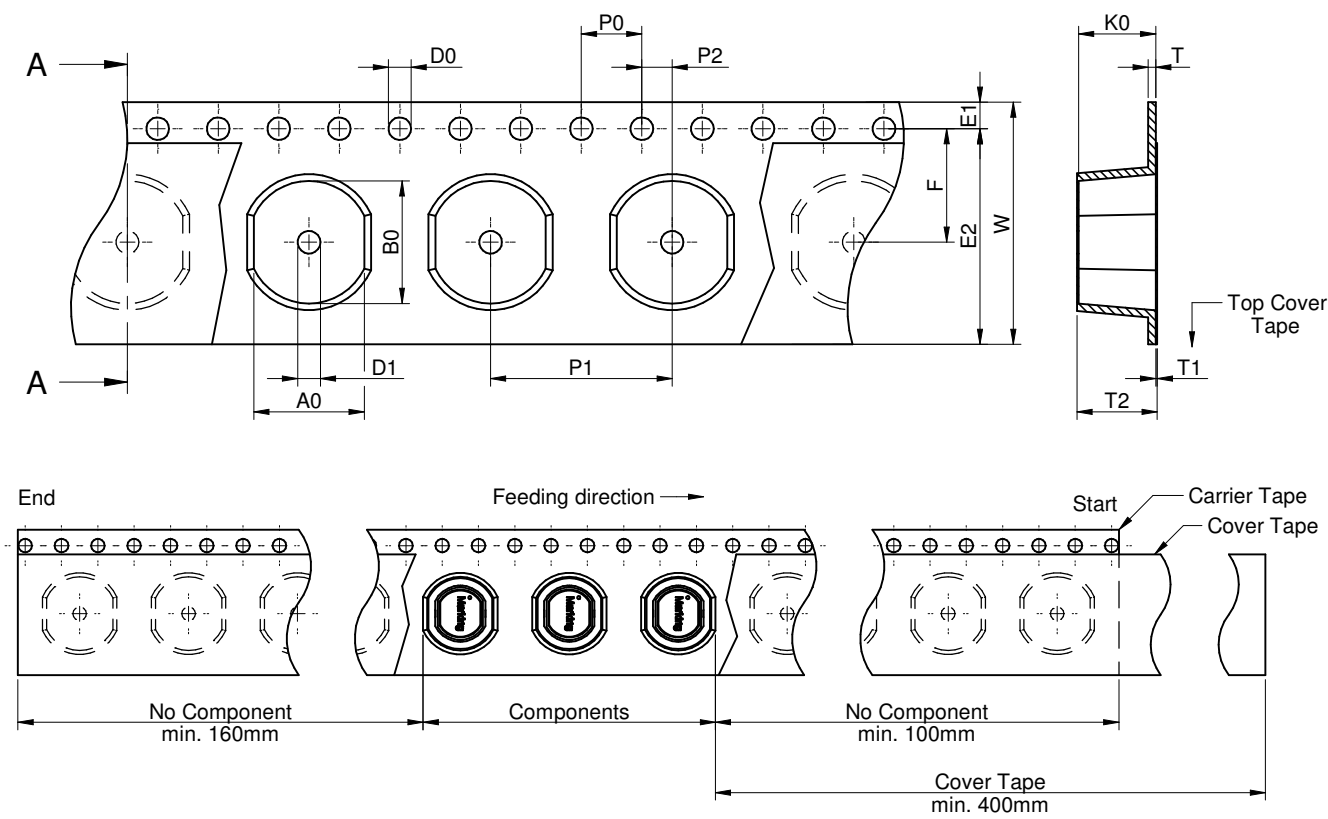

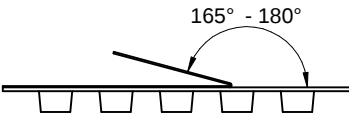

### Soldering:

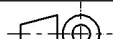
### Packaging:
