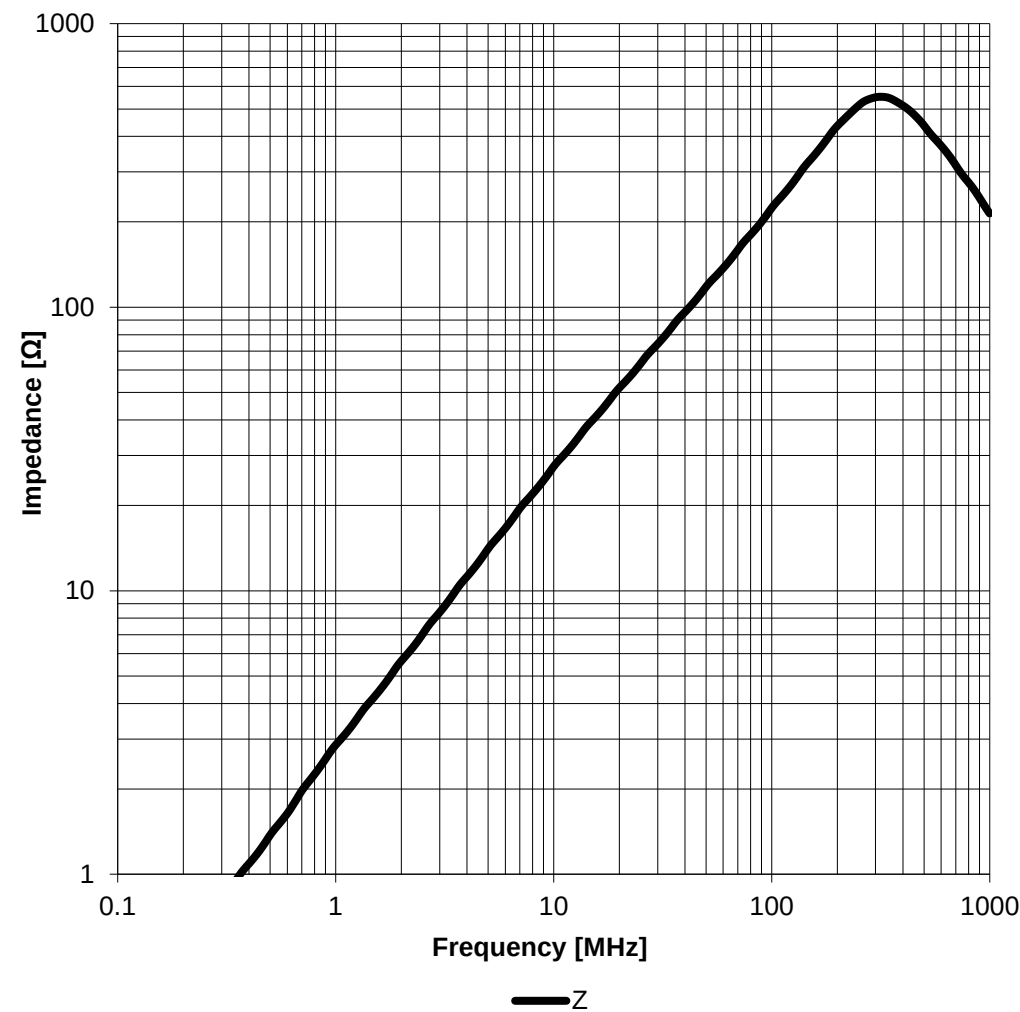

Typical Inductance vs. Current Characteristics:



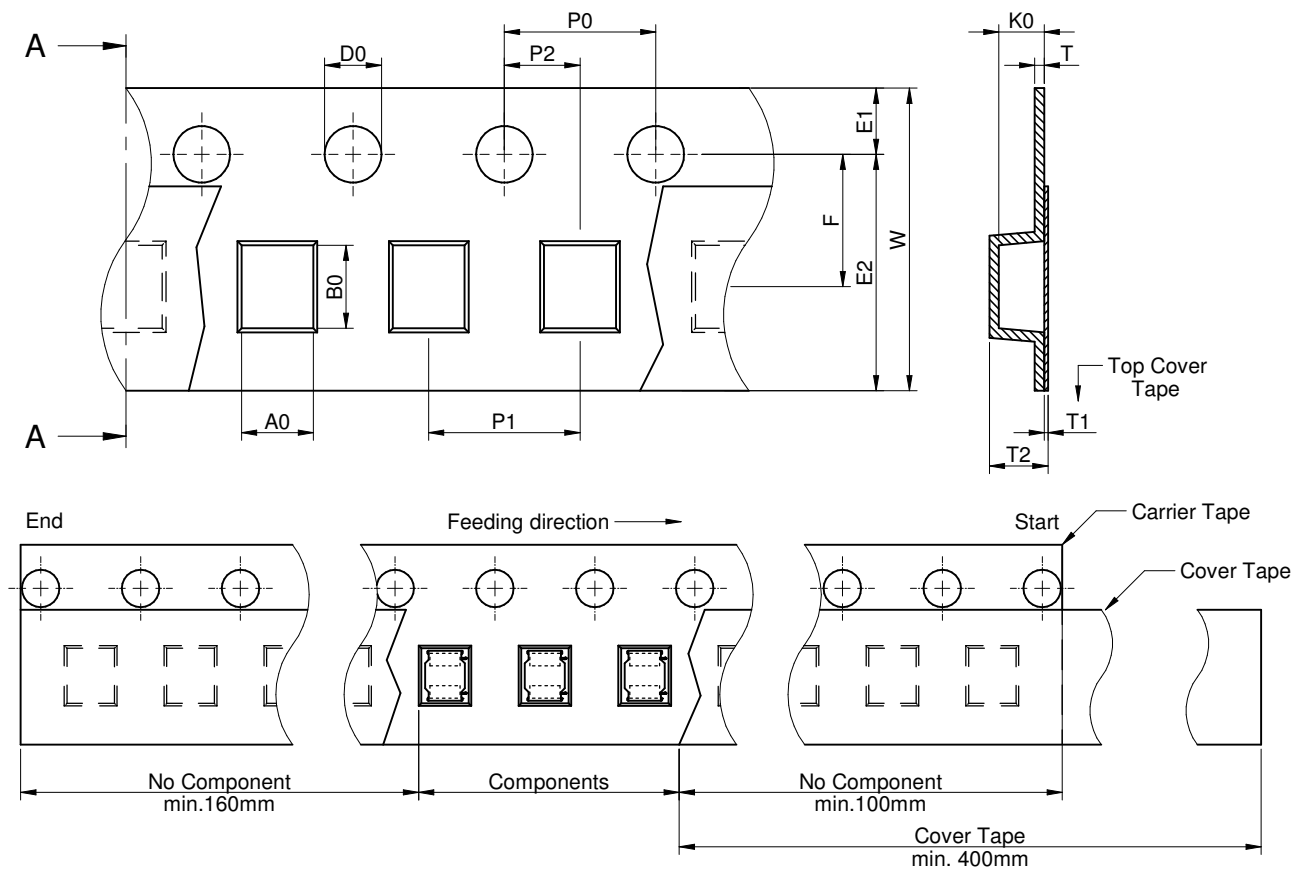
Typical Impedance Characteristics:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

Cleaning and Washing:

Potting:

Shrinking could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the components. We recommend a manual inspection after potting to avoid these effects.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad solderability. Therefore, all products shall be used within the period of 12 months based on the day of shipment.

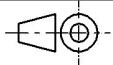
Packaging:

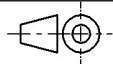
