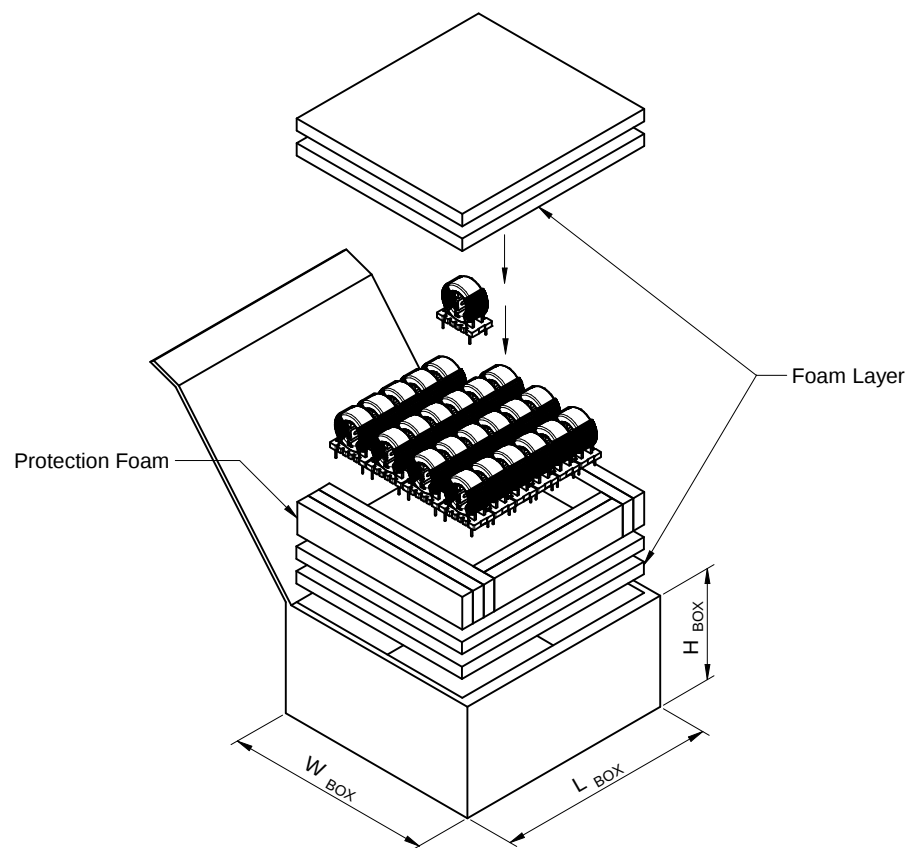
Derating Curve:



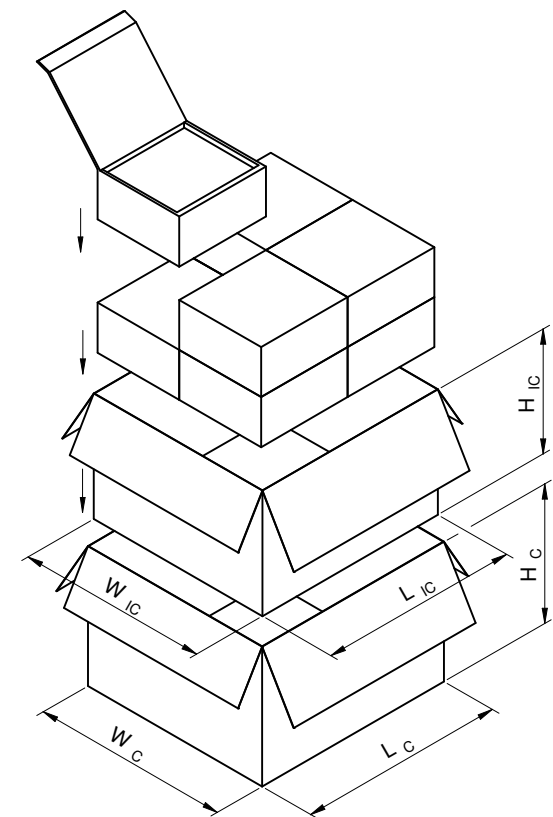

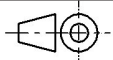

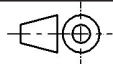

Soldering

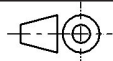
Packaging:
