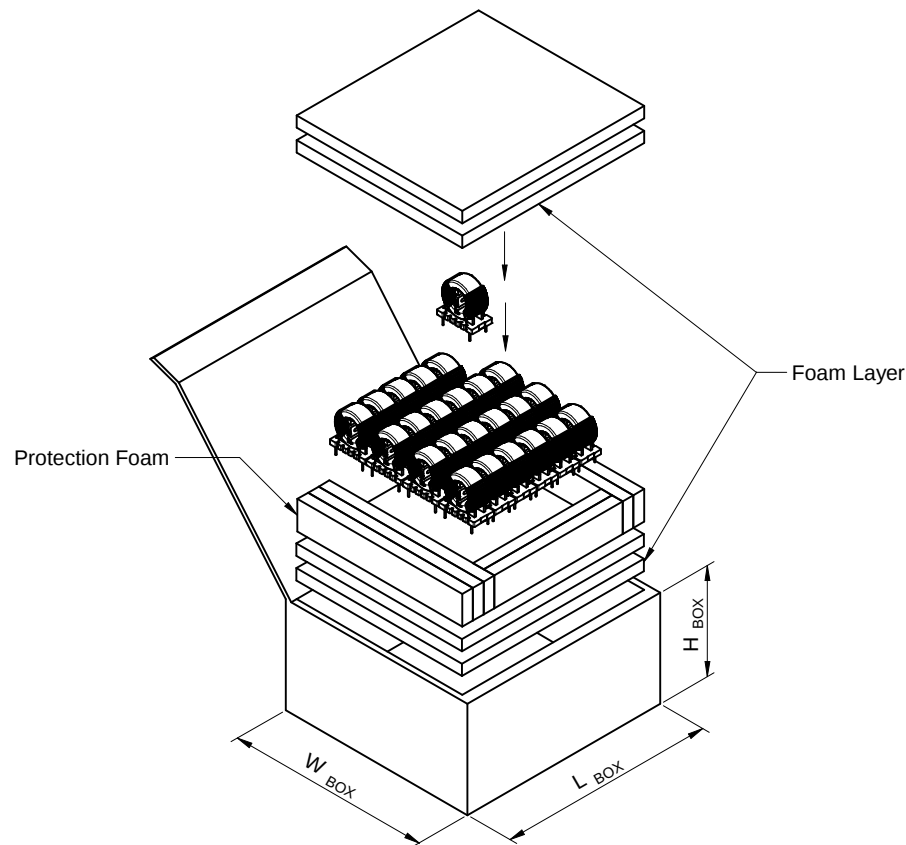

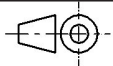

Soldering

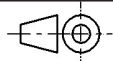
Packaging:

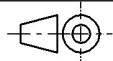
