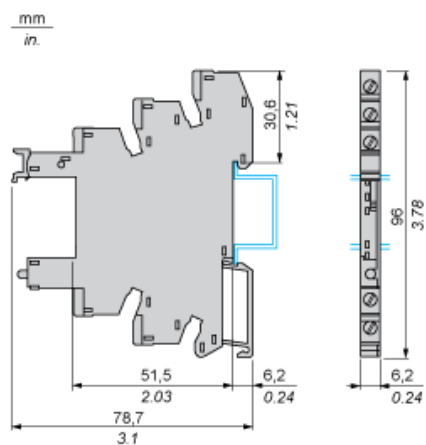

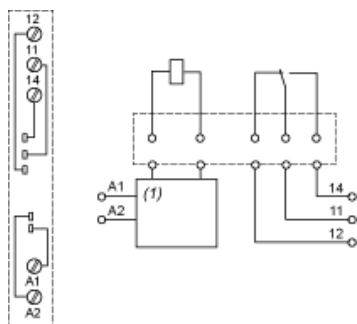

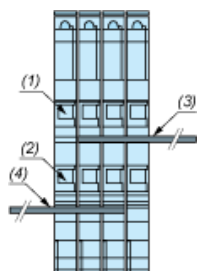
Wiring Diagram
