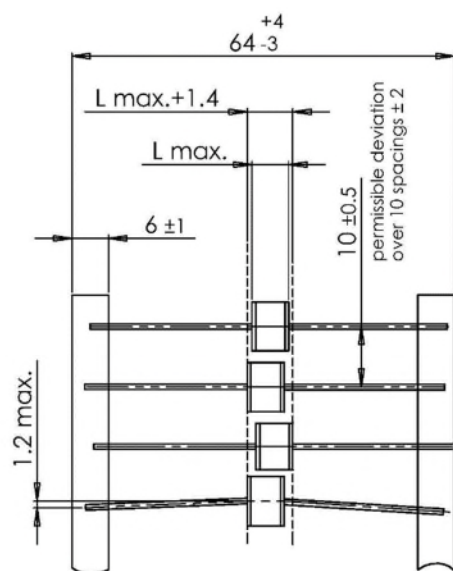

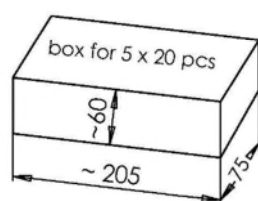

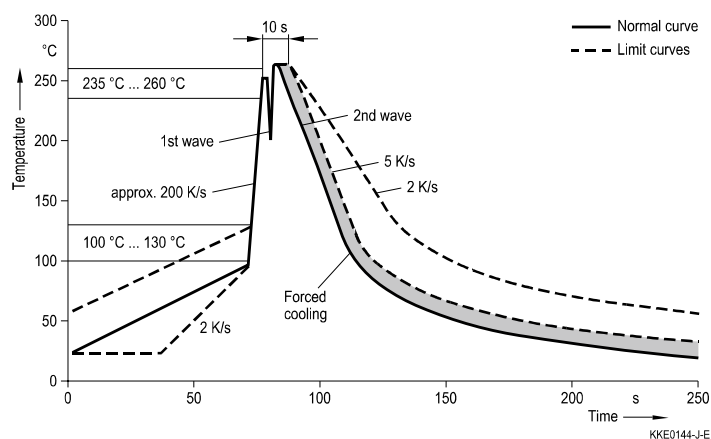

Cautions and warnings
