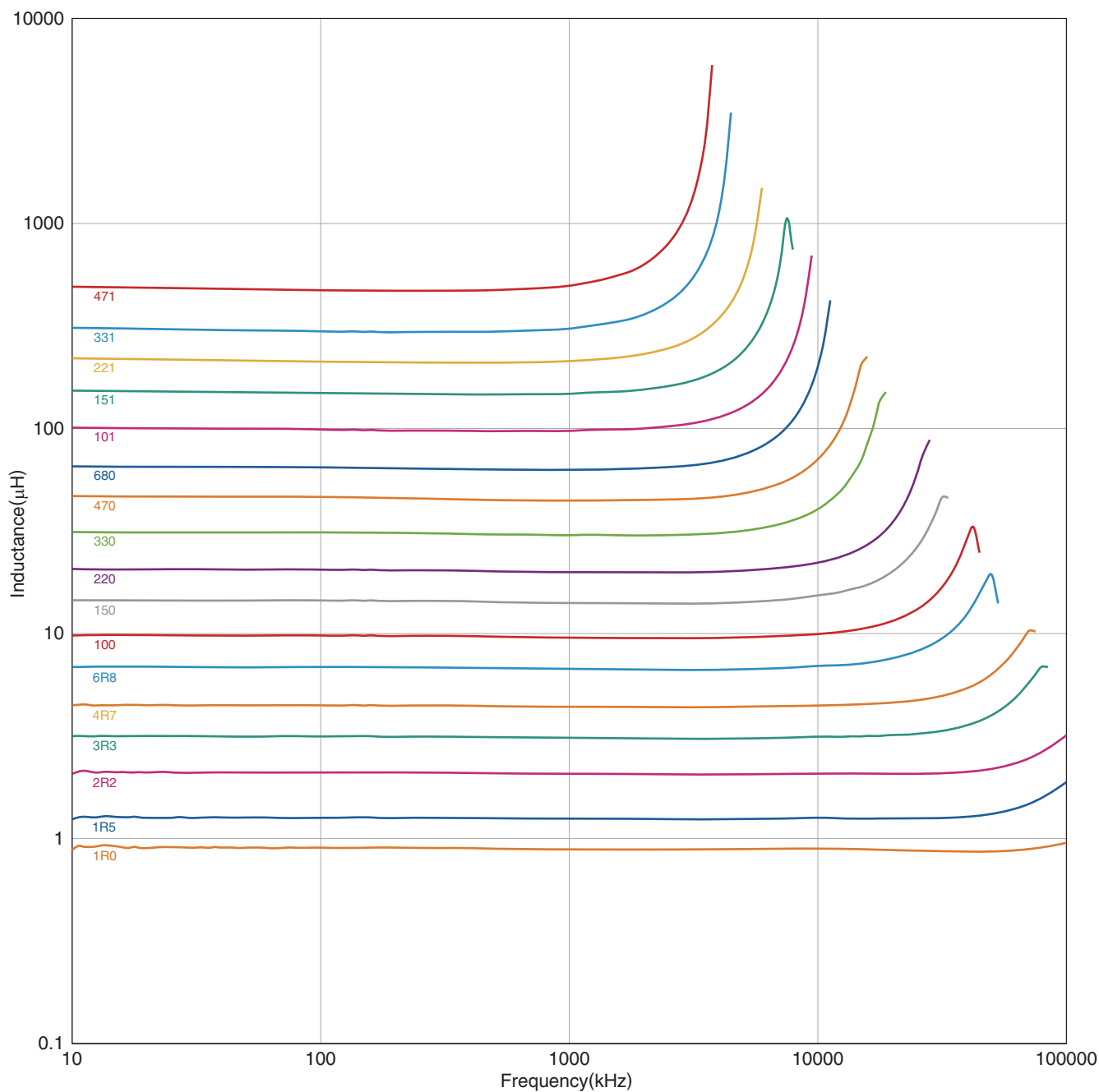

L FREQUENCY CHARACTERISTICS



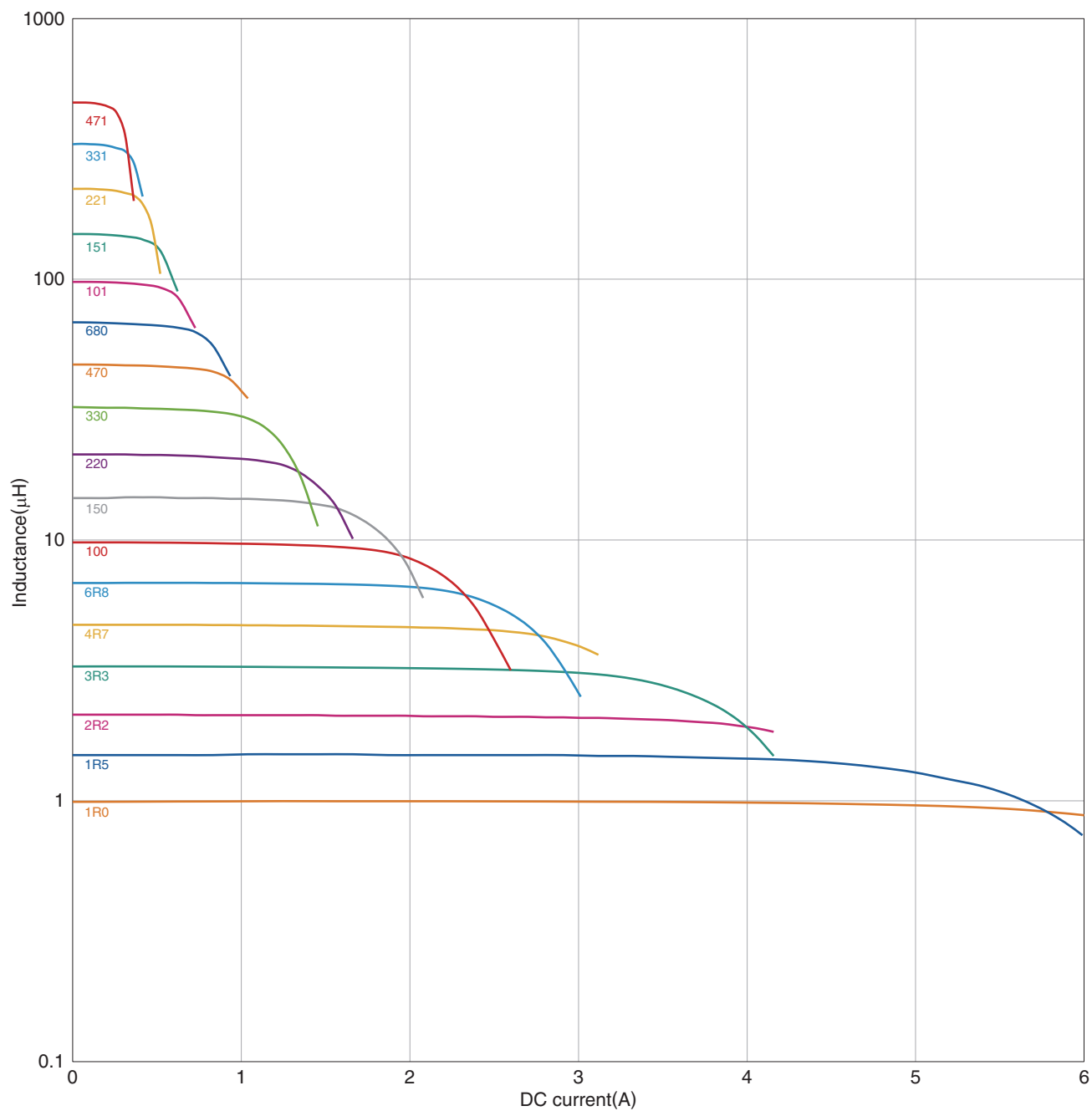
