### Typical Insertion Loss:



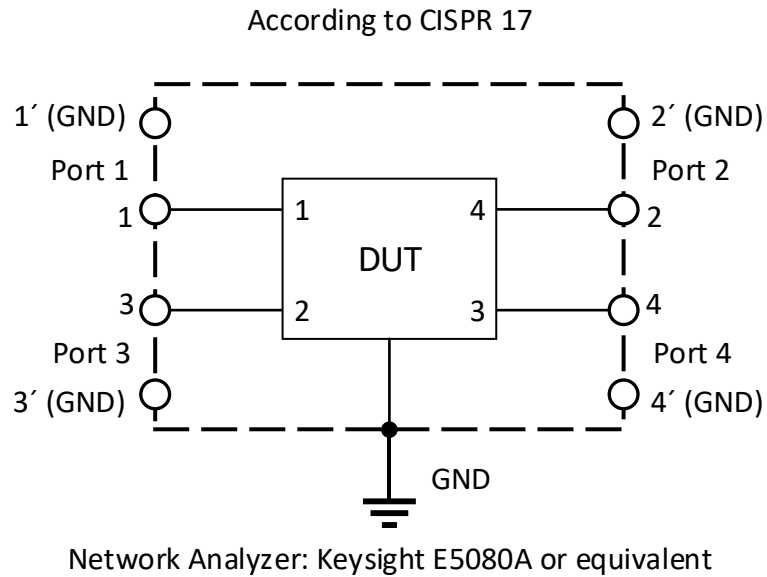
### Typical Impedance vs. Frequency:



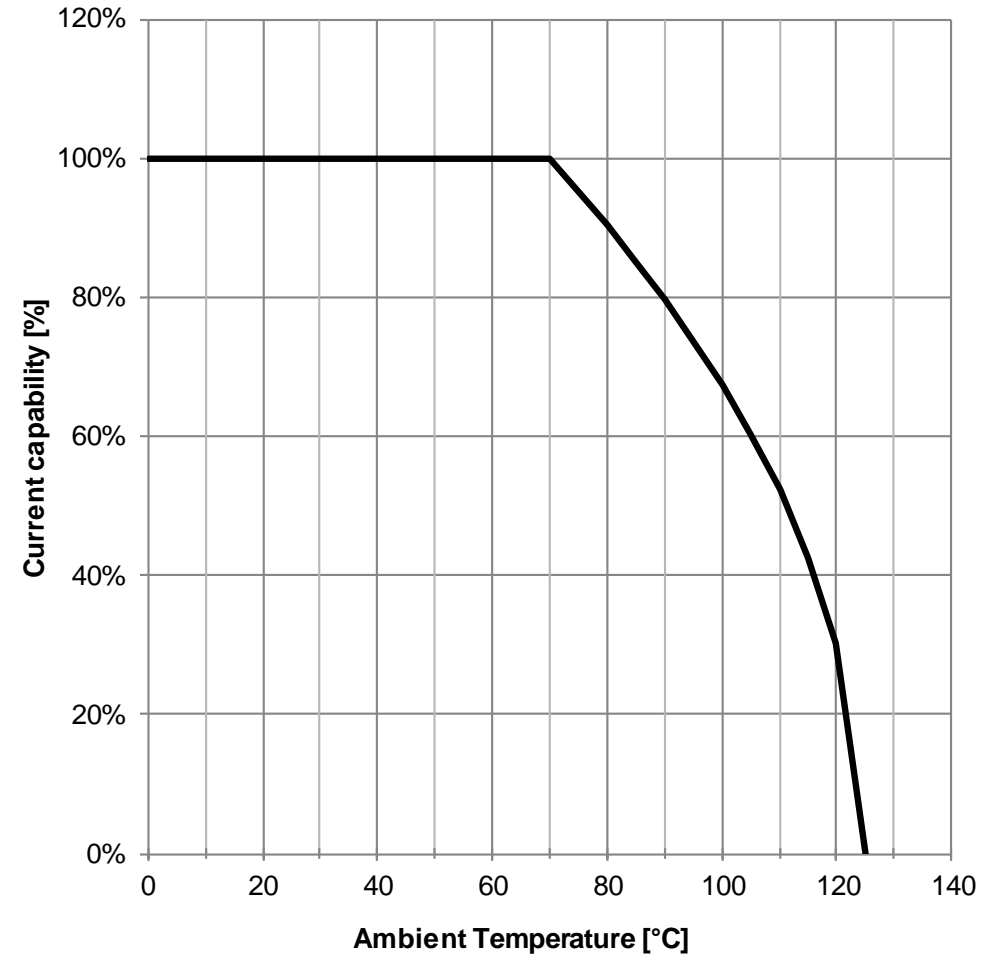

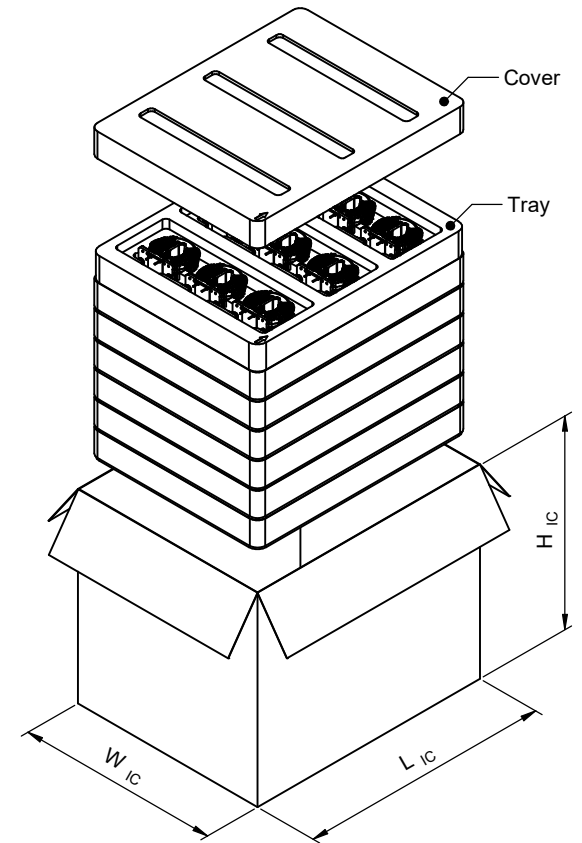
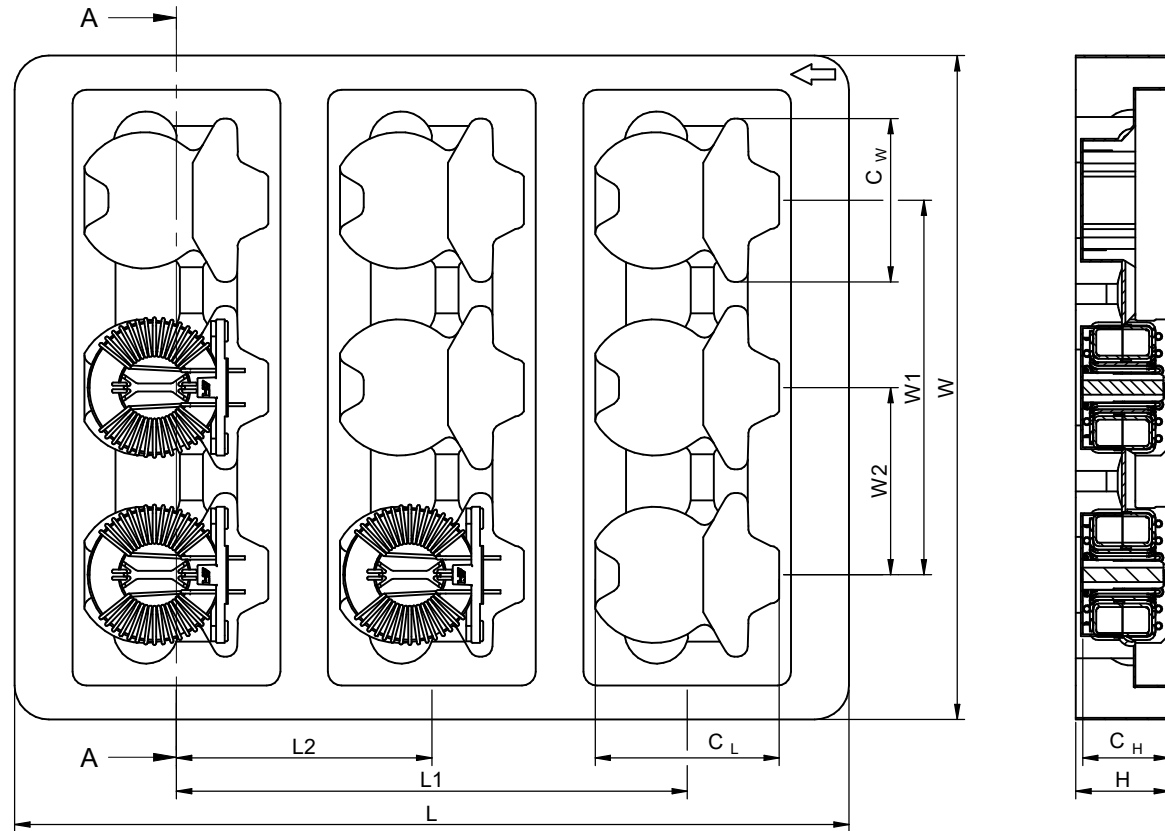


## Derating Curve:

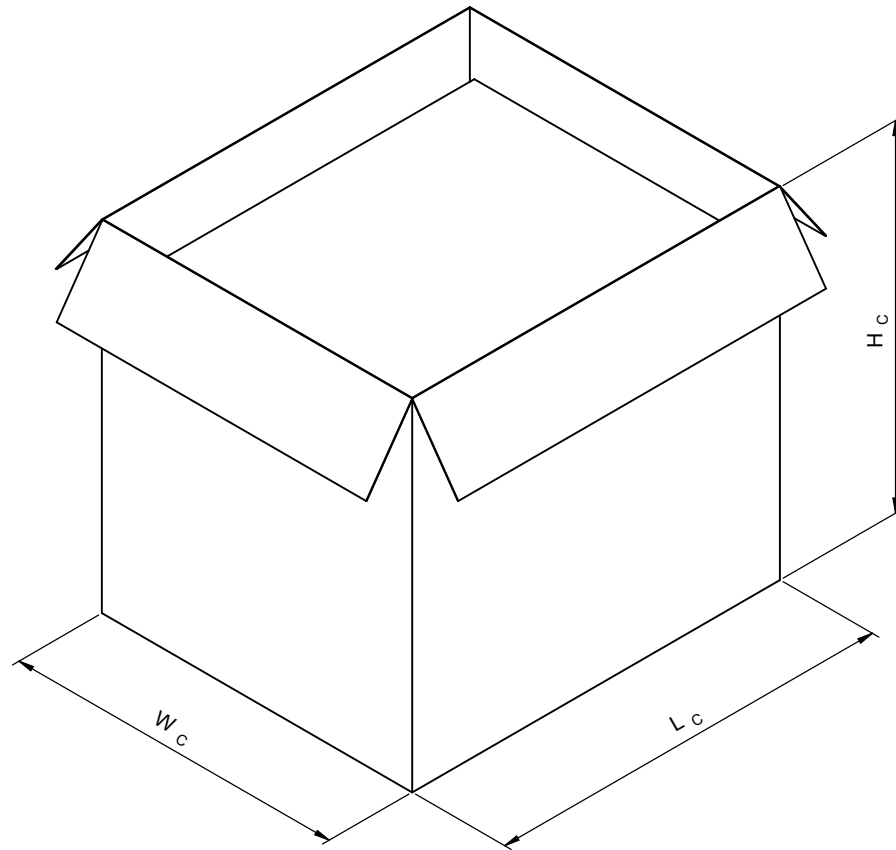



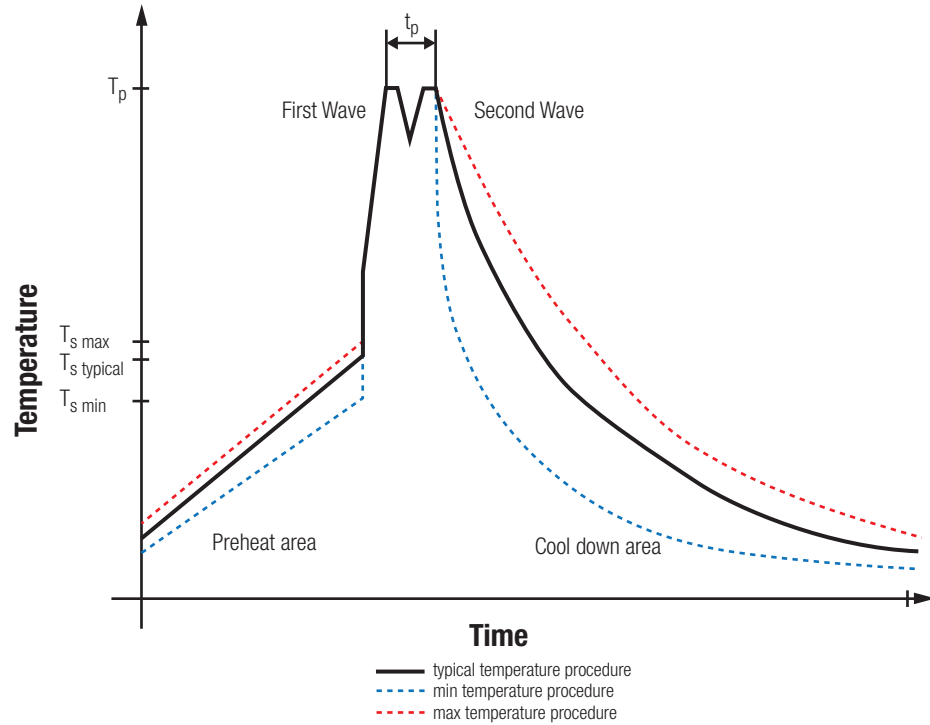

#### Soldering:


