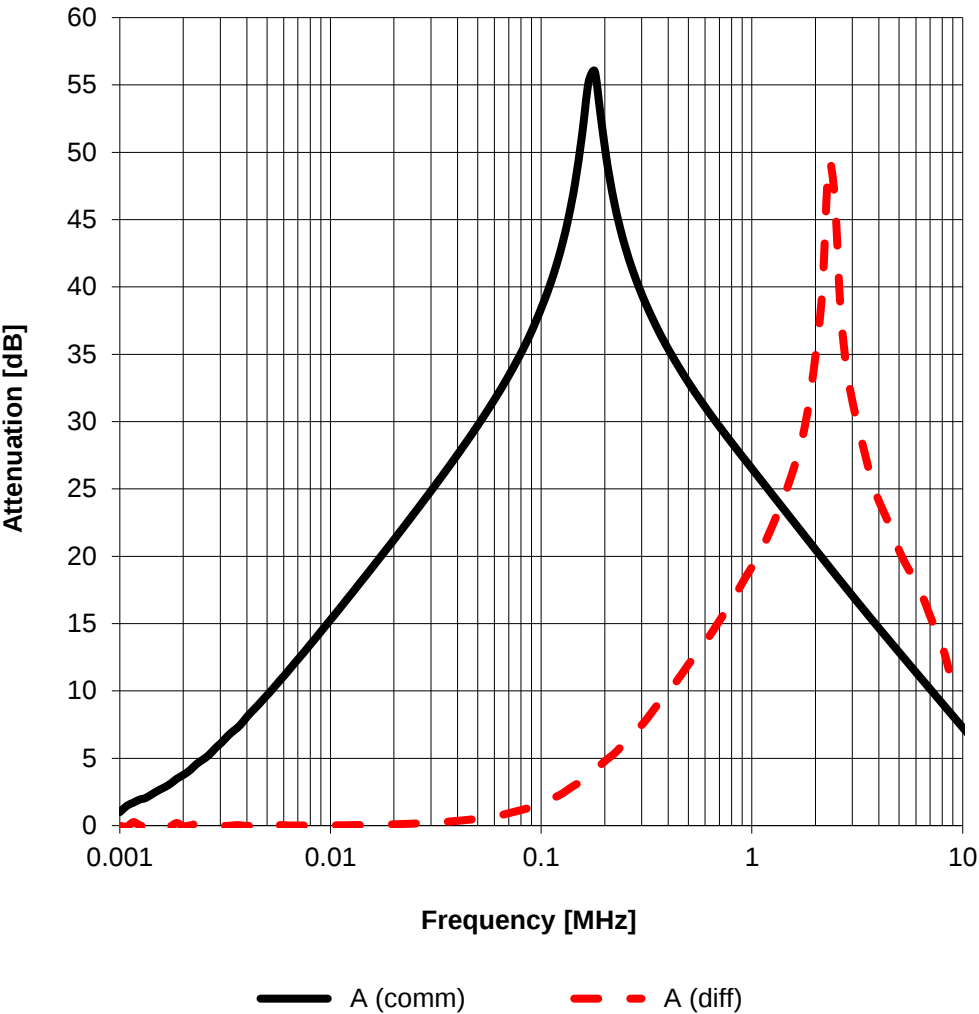
Common Mode



Differential Mode



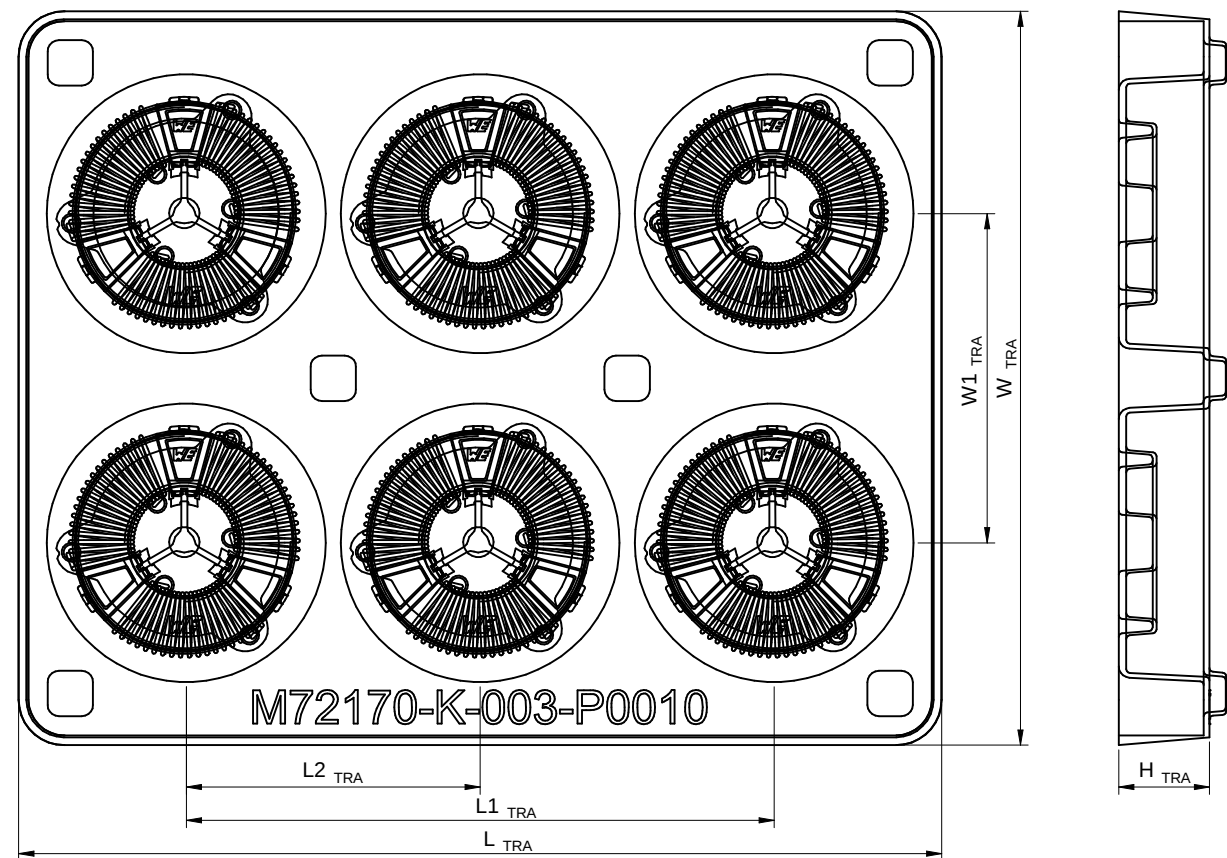
