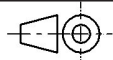


Differential Mode



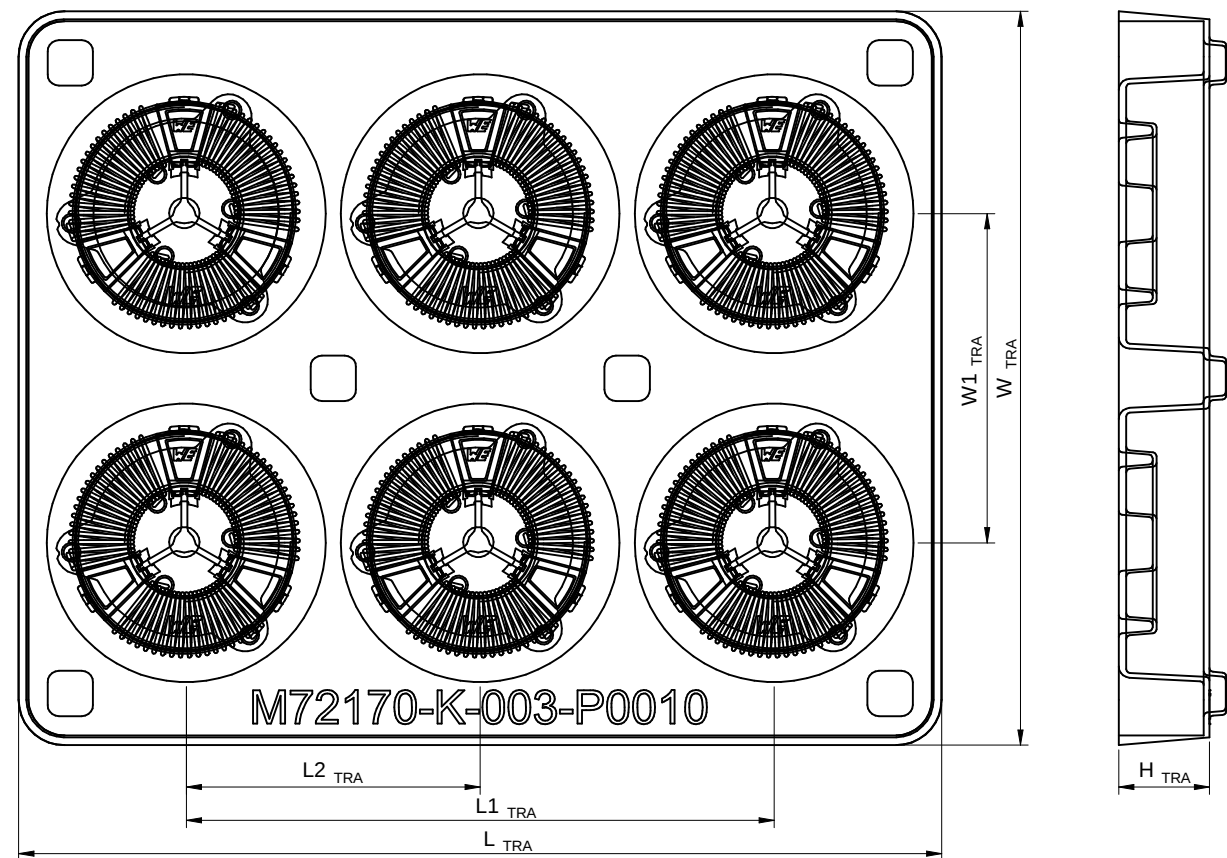
Typical Insertion Loss:



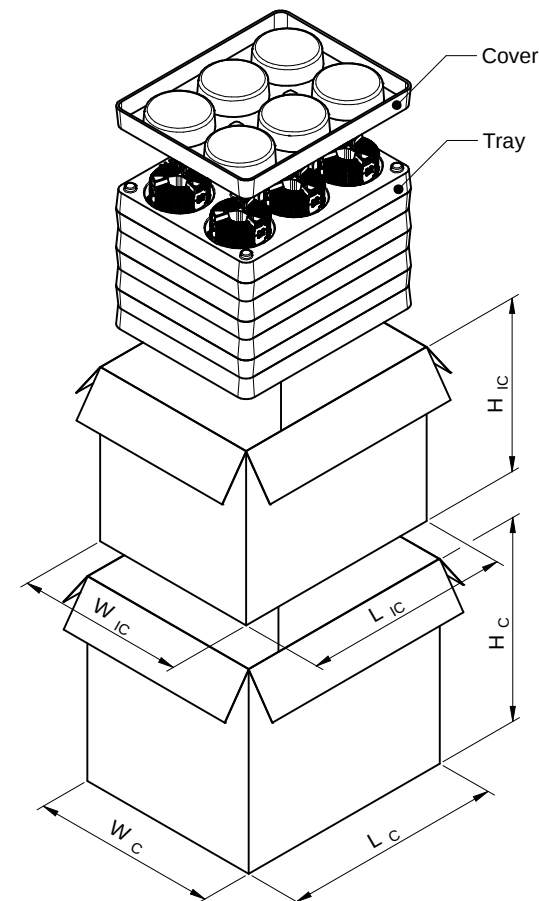
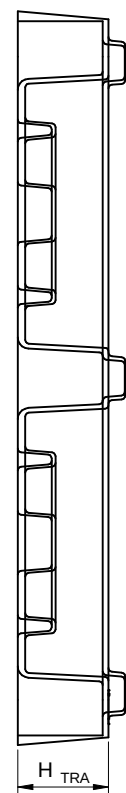

Soldering:
