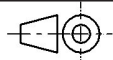


Differential Mode



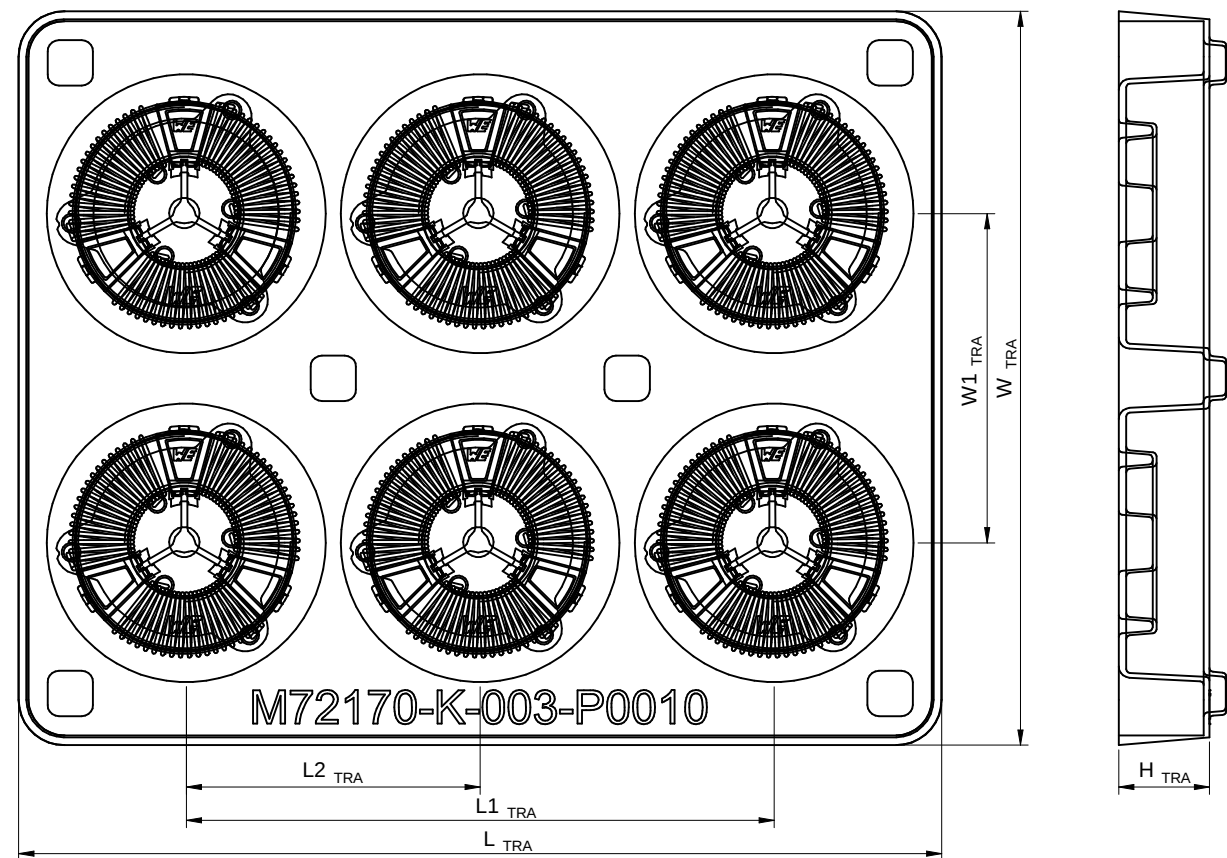
Typical Insertion Loss:



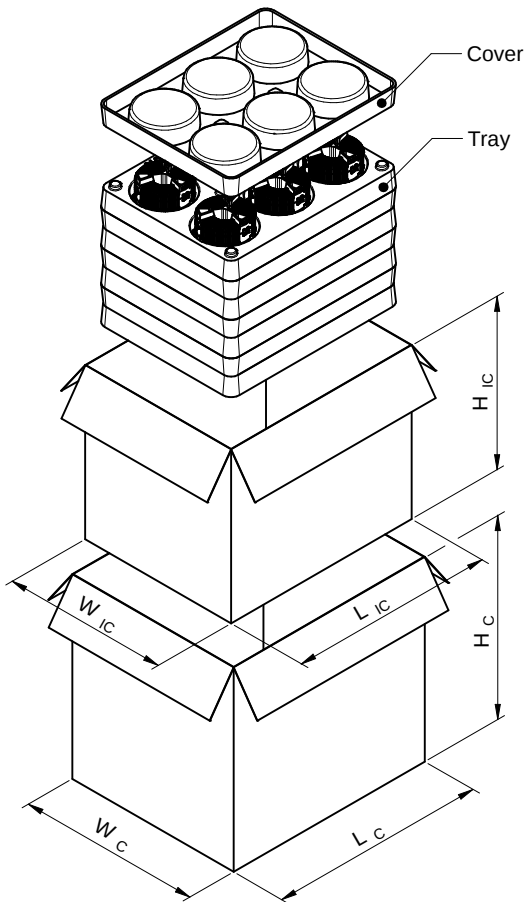

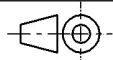

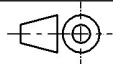
Packaging:

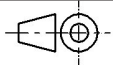
