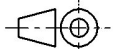


Differential Mode



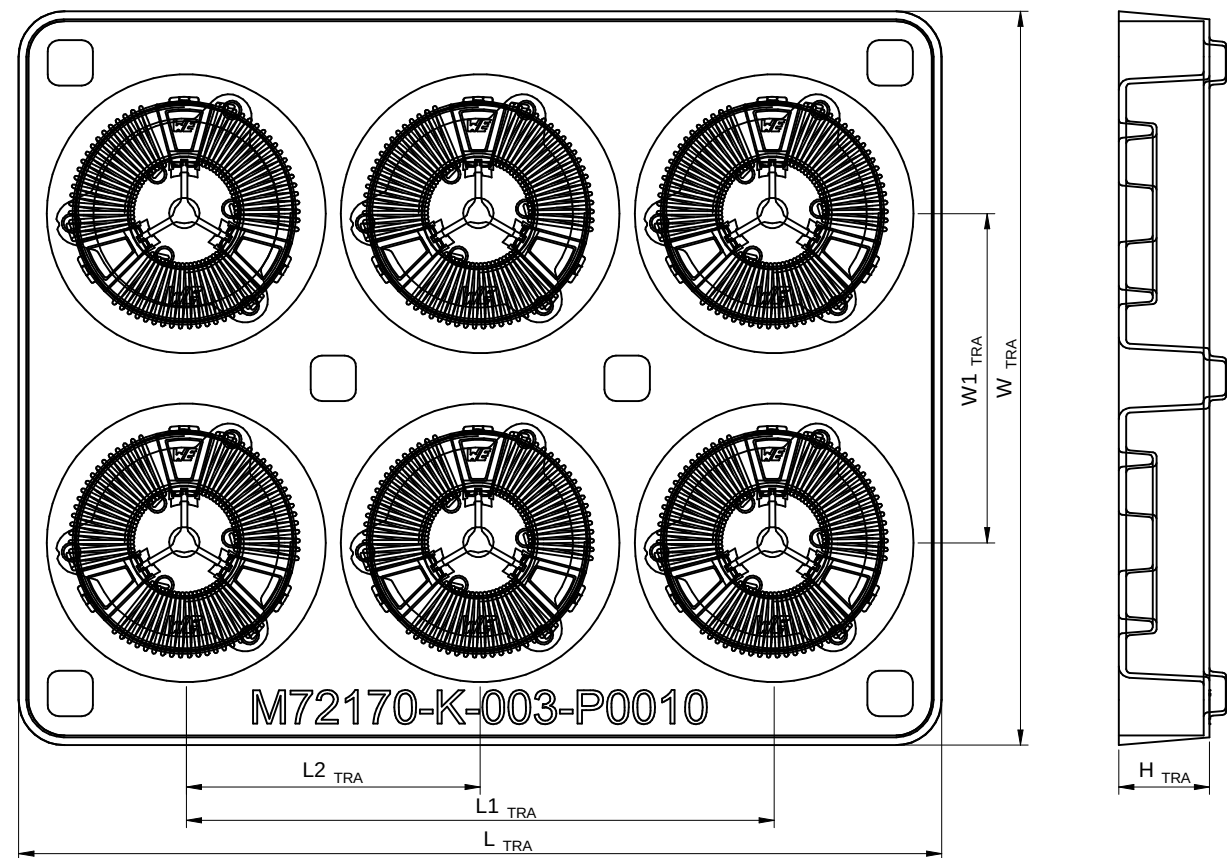

Soldering:

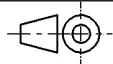

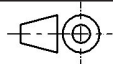
