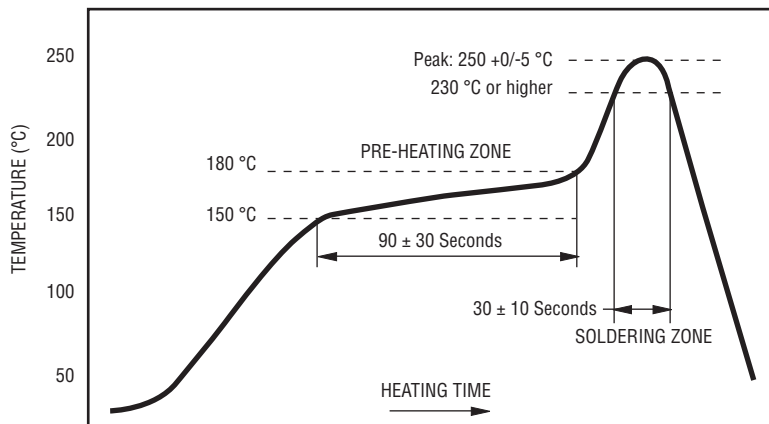

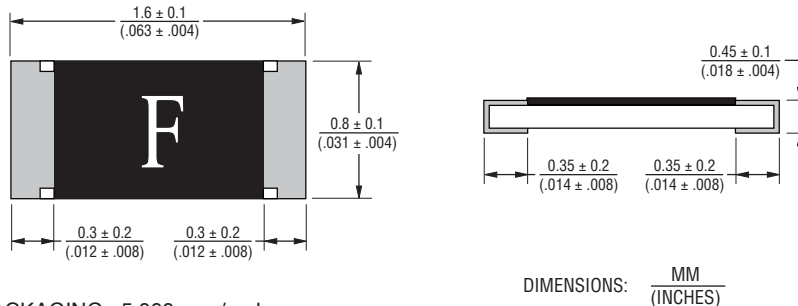

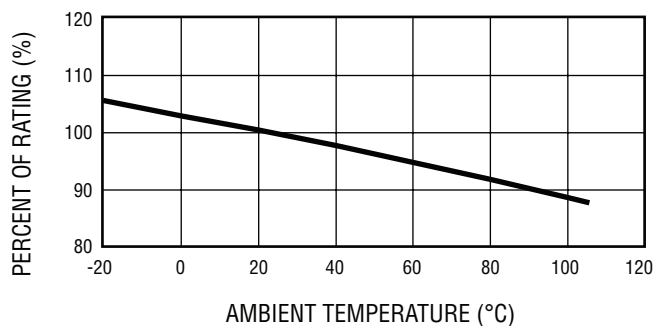
PEAK: 250 ± 0/-5 °C, 5 seconds

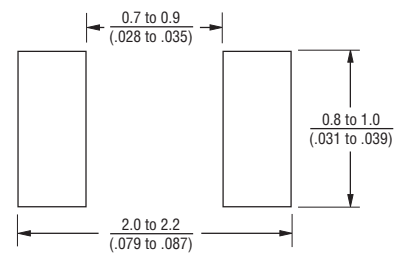

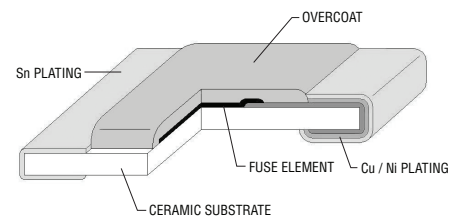
Thermal Derating Curve

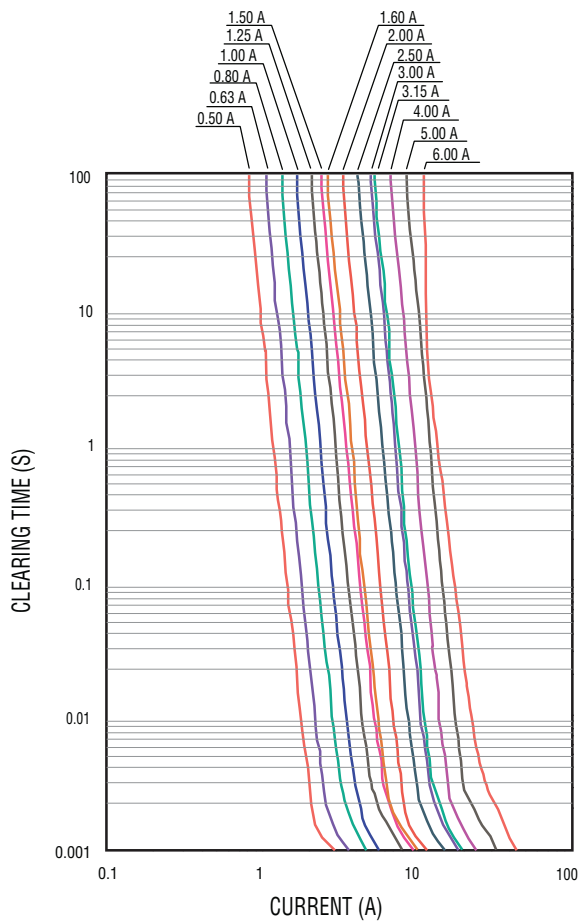

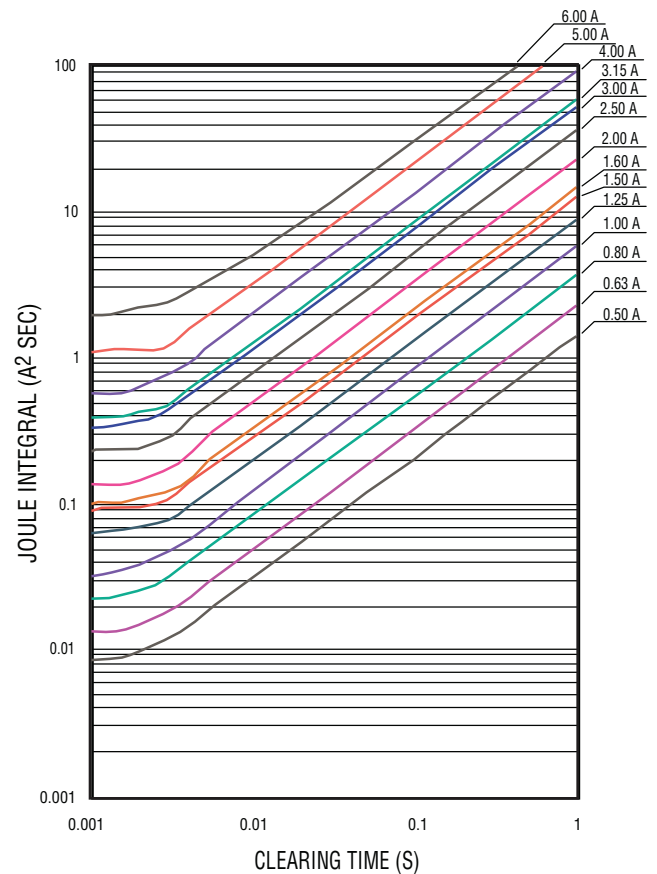

Average Time Current Curves

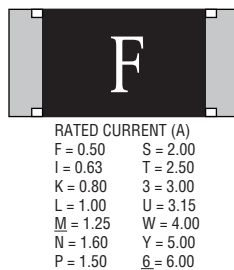


Minimum I²T V Clear Time Curves

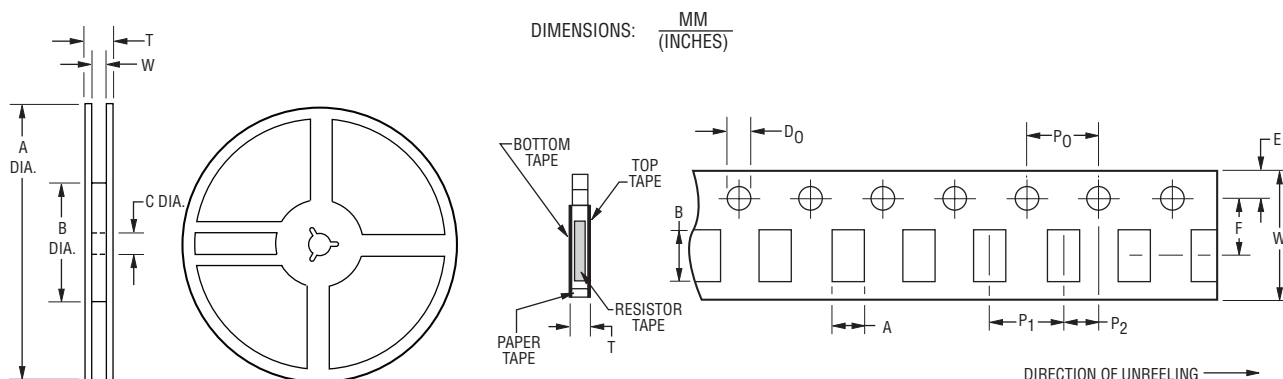
