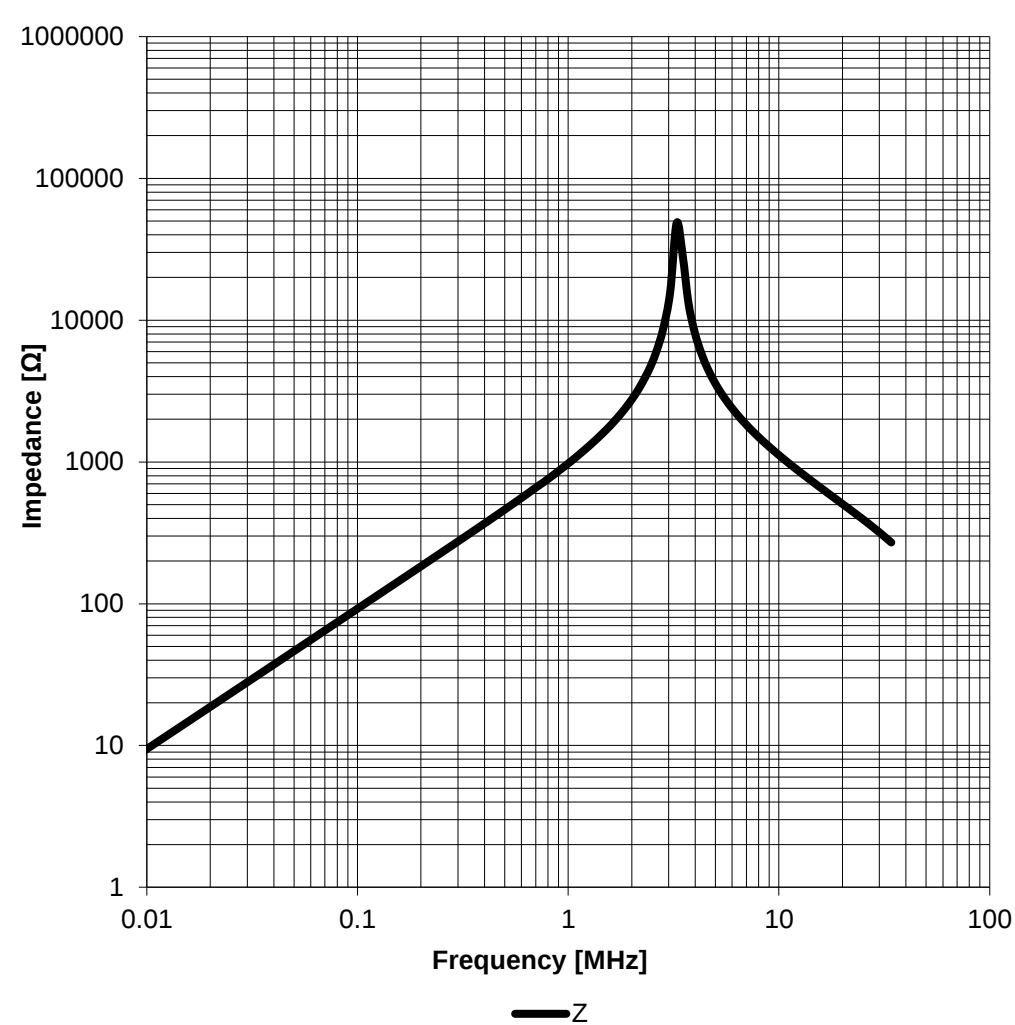

Soldering:
