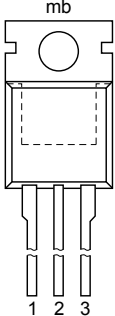

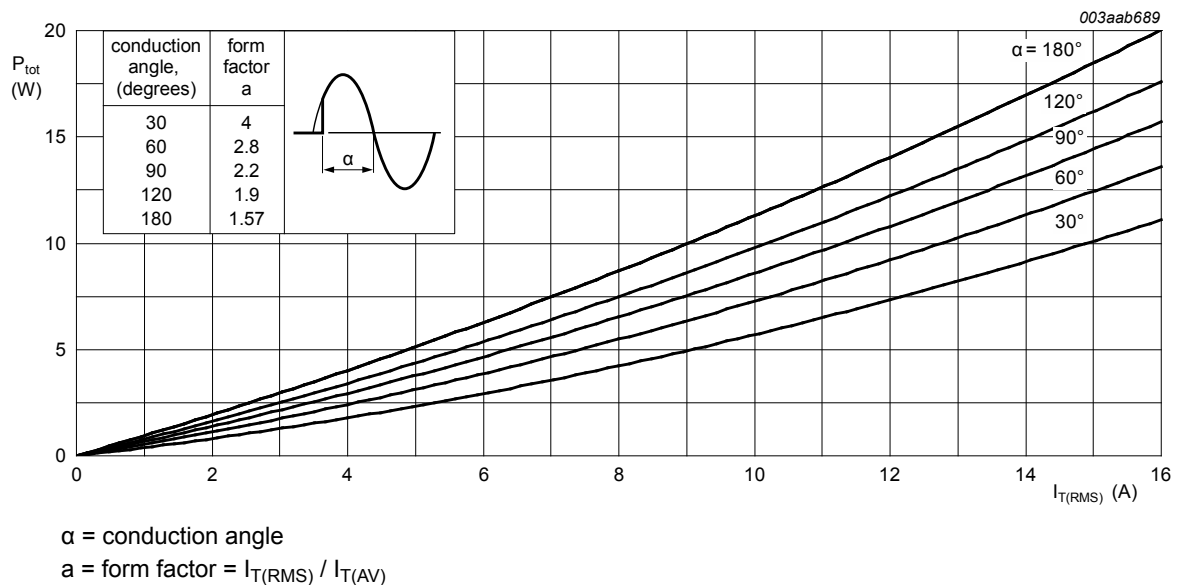


Fig. 1. Total power dissipation as a function of RMS on-state current; maximum values

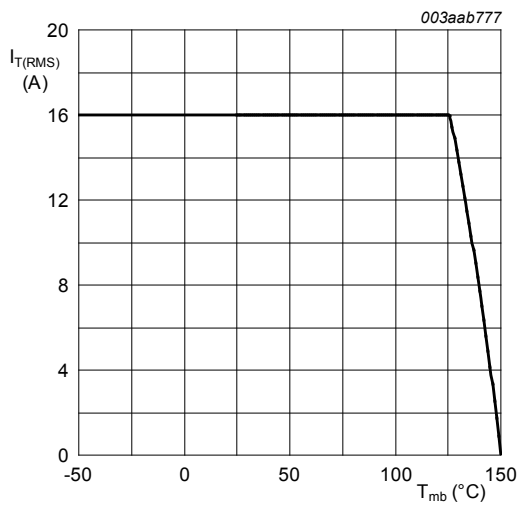
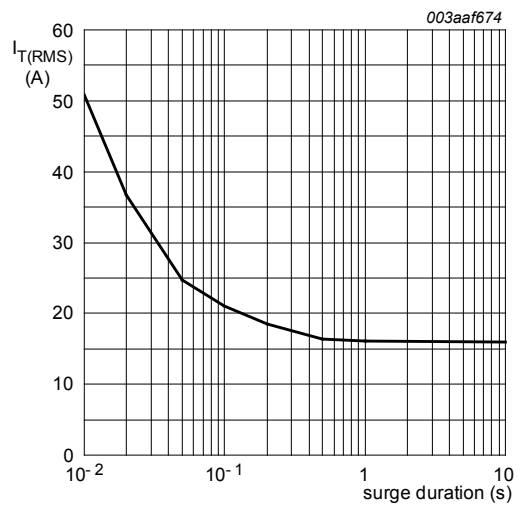
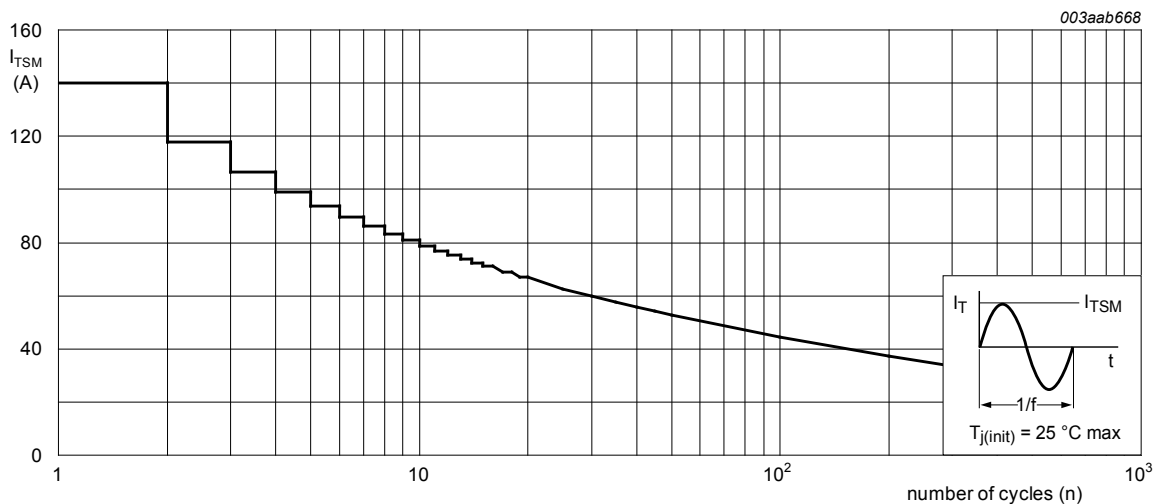


Fig. 2. RMS on-state current as a function of mounting base temperature; maximum values



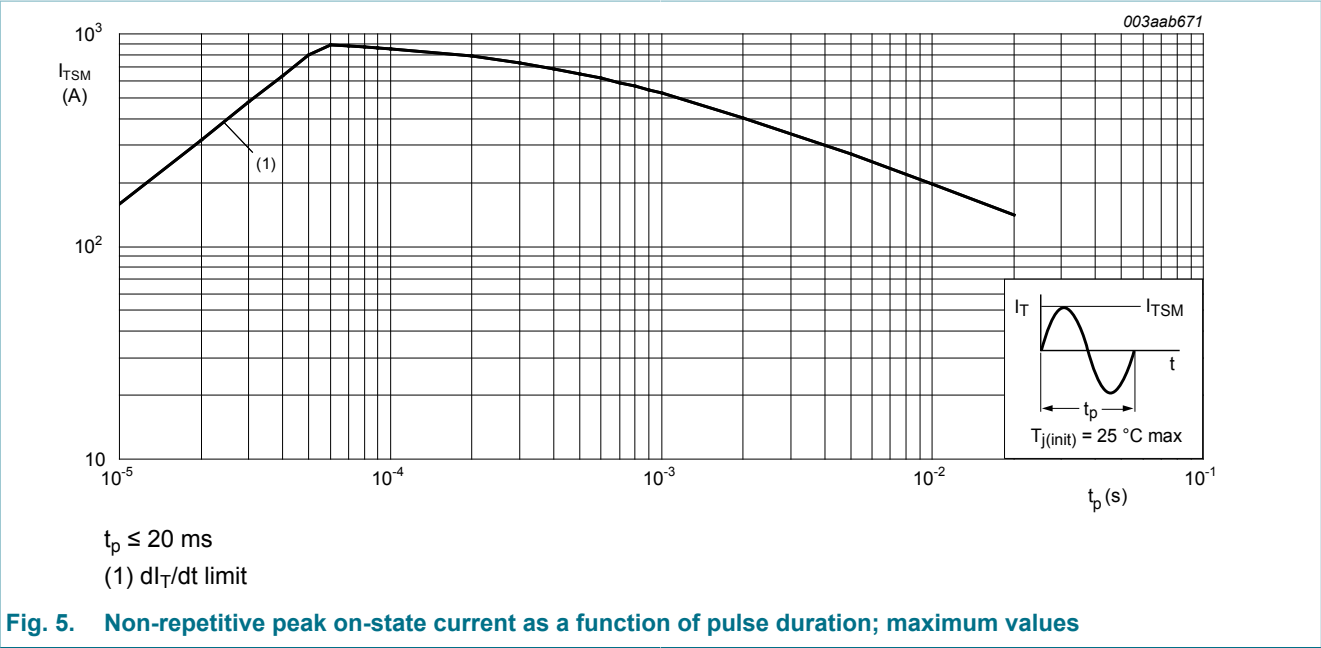
$f = 50 \text{ Hz}$; $T_{mb} = 126 \text{ }^{\circ}C$

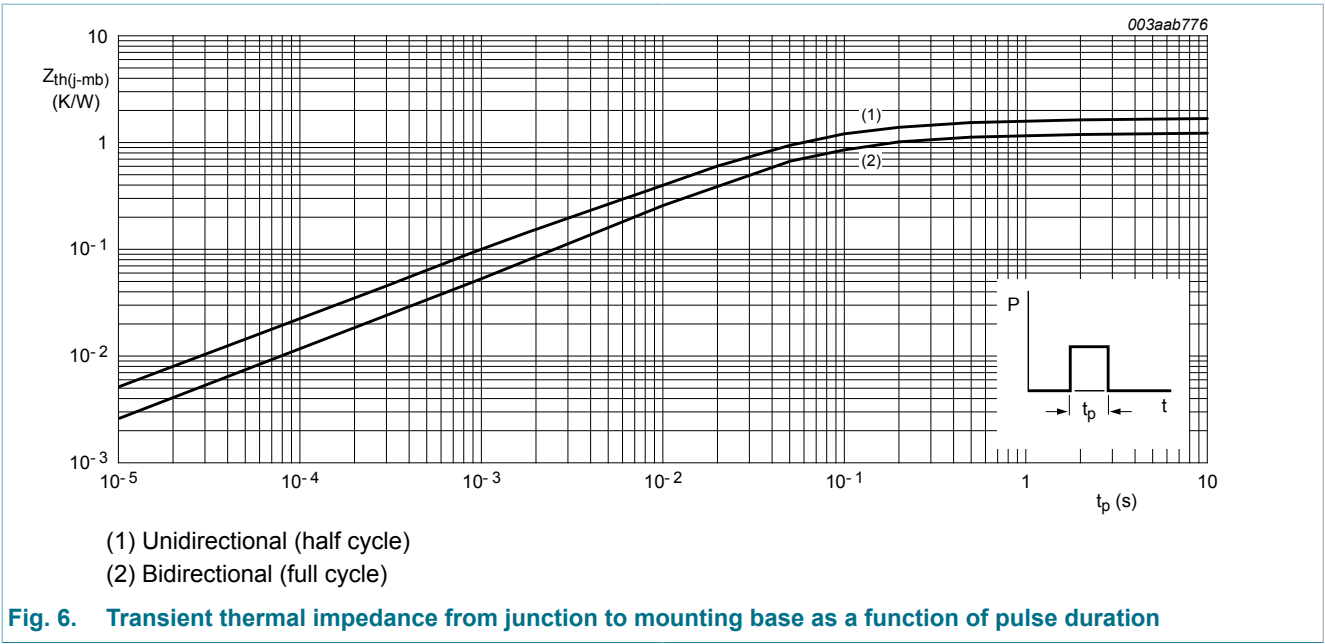
Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values

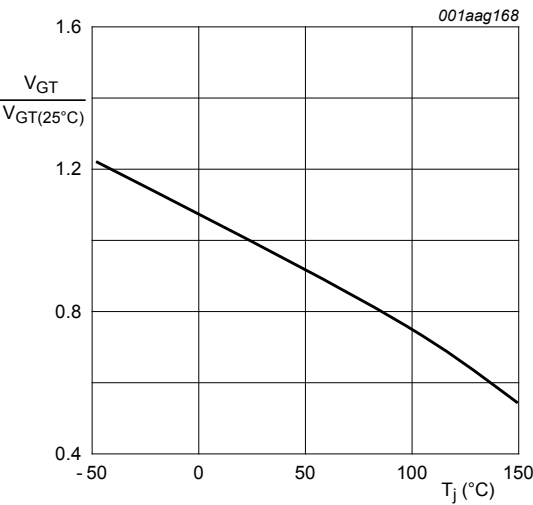


Fig. 11. Normalized gate trigger voltage as a function of junction temperature

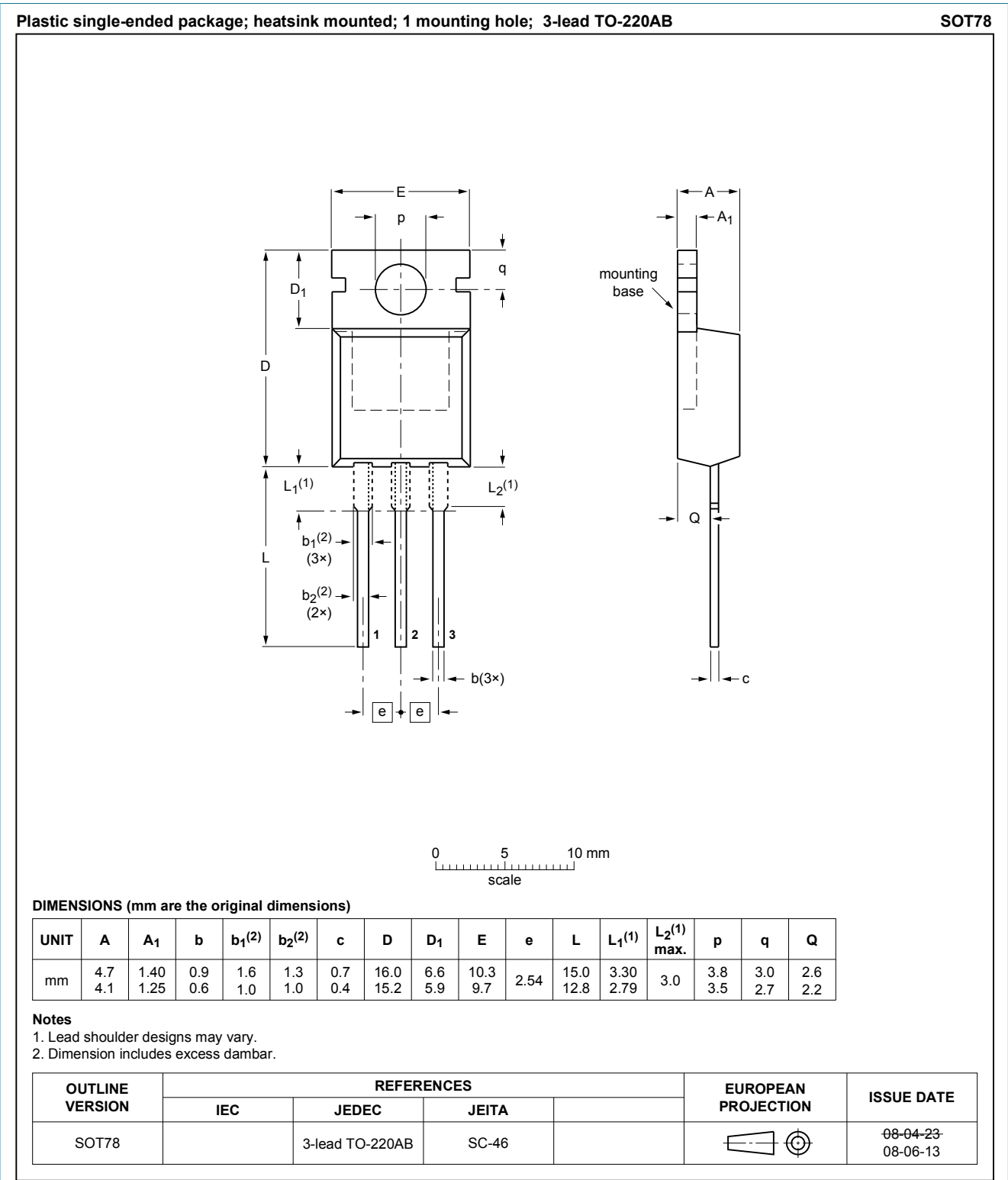


Fig. 12. Package outline TO-220AB (SOT78)
