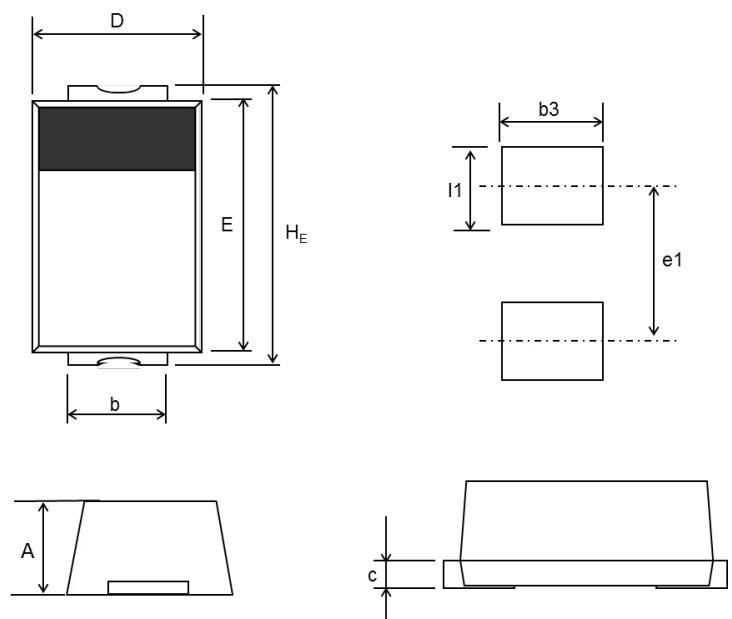

● Electrical Characteristic Curves

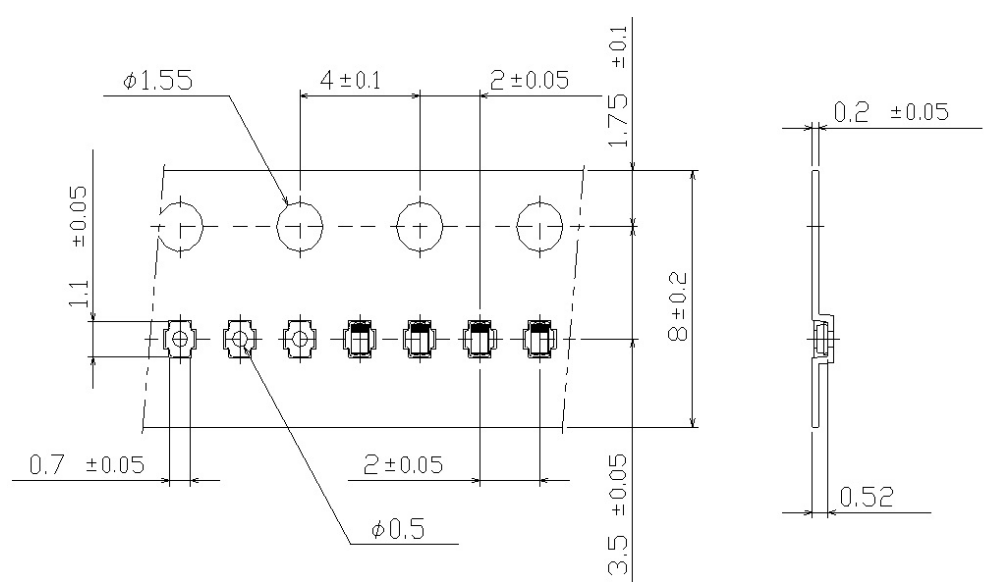
