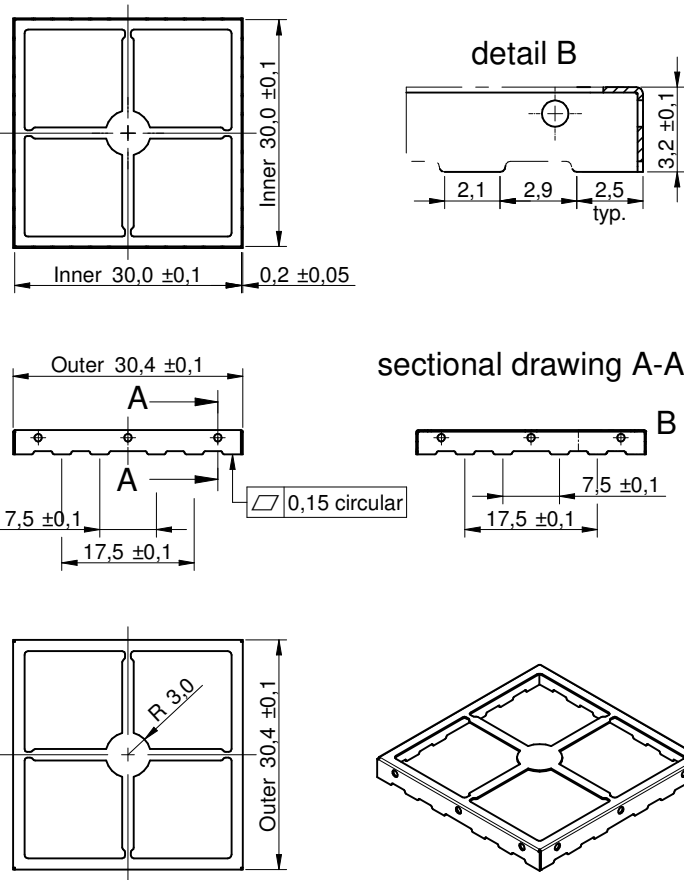
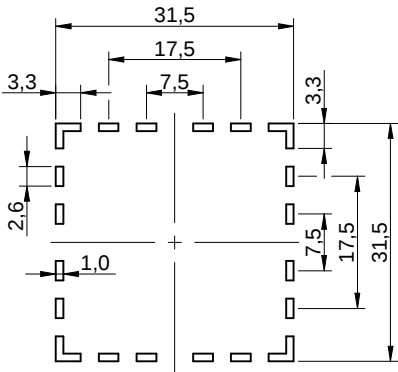

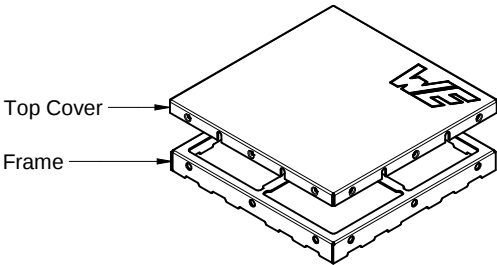


Recommended Land Pattern: [mm]

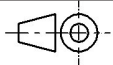

Soldering:

Cleaning and Washing:

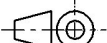
Packaging:

6. Product Life Cycle

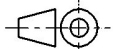
