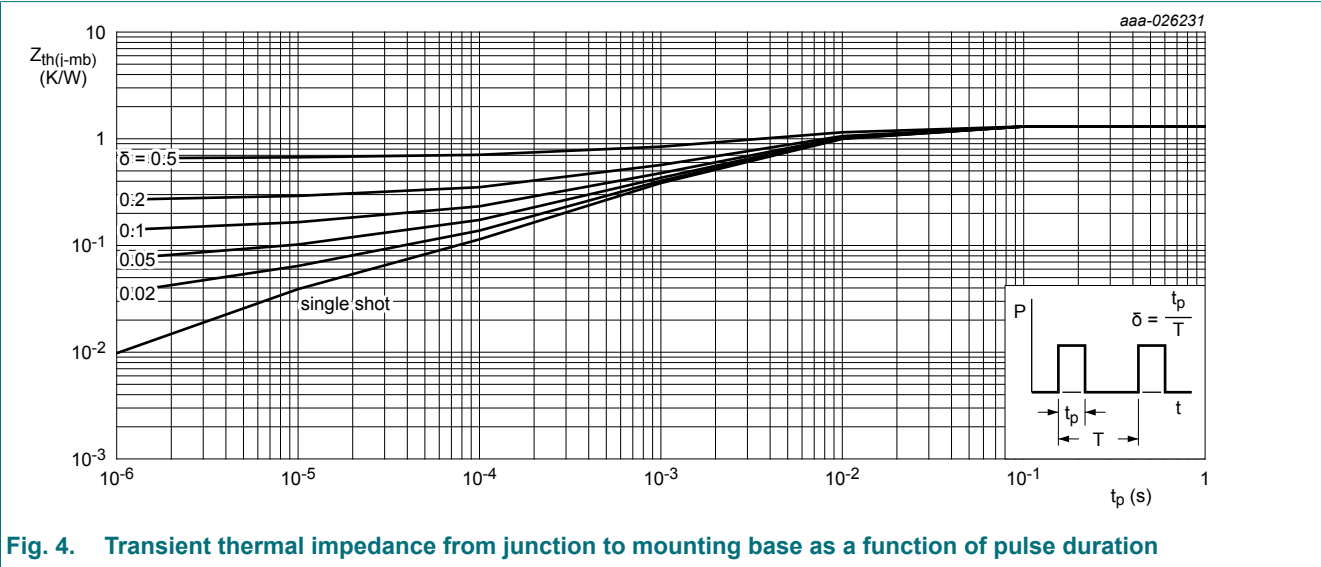




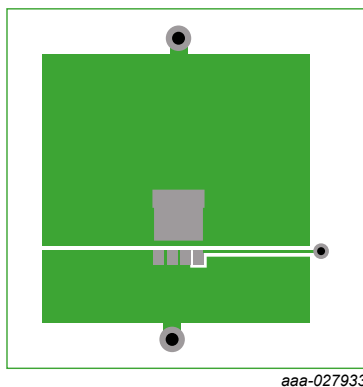

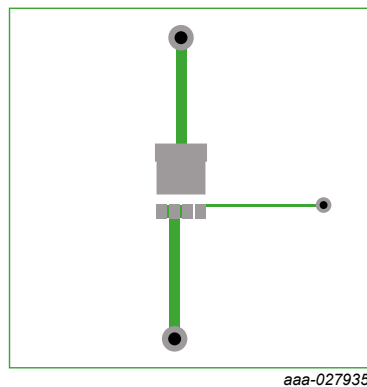


N-channel 40 V, 3.5 mΩ, 120 A standard level MOSFET in LPAK56 using NextPower-S3 Schottky-Plus technology

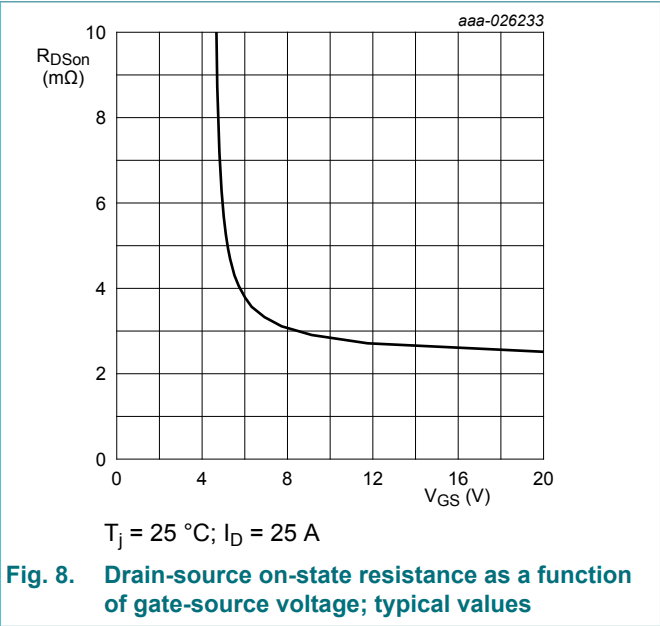
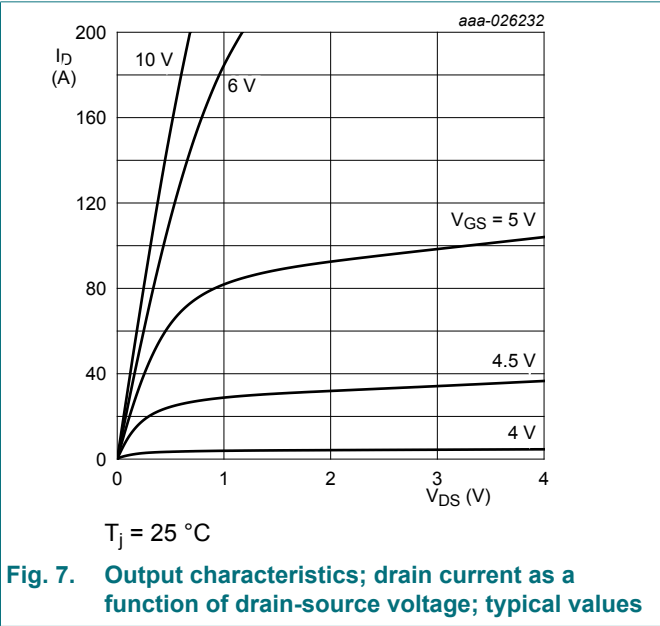

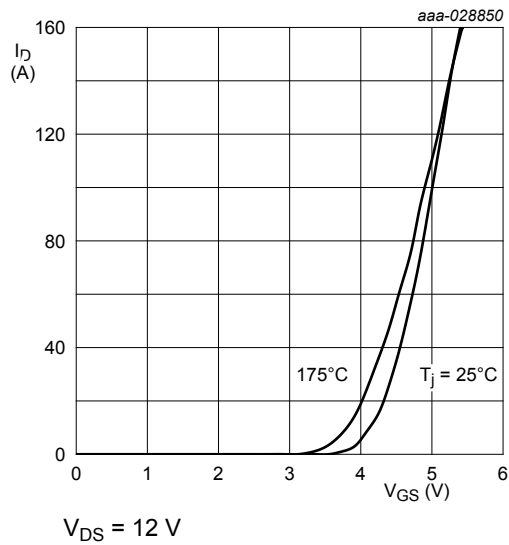


Fig. 9. Transfer characteristics; drain current as a function of gate-source voltage; typical values

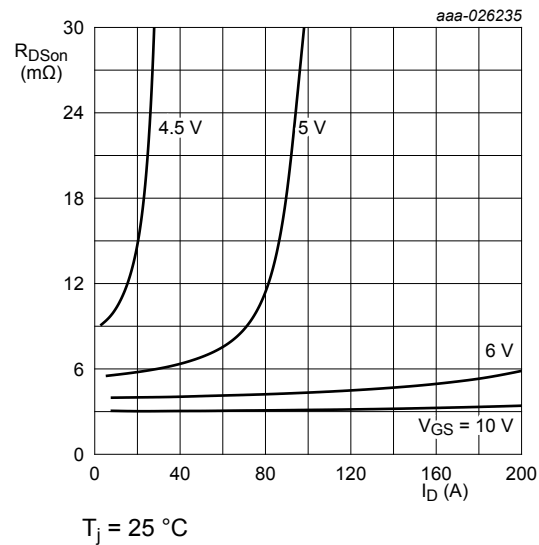


Fig. 10. Drain-source on-state resistance as a function of drain current; typical values

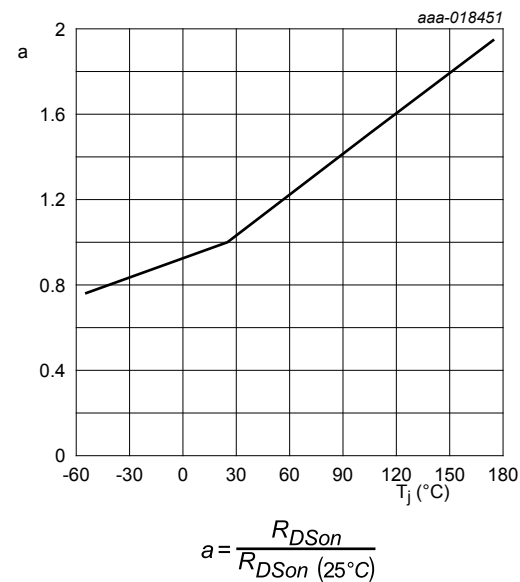


Fig. 11. Normalized drain-source on-state resistance factor as a function of junction temperature

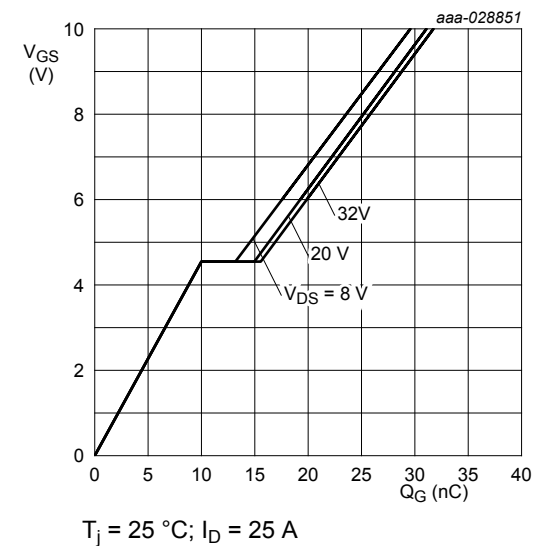
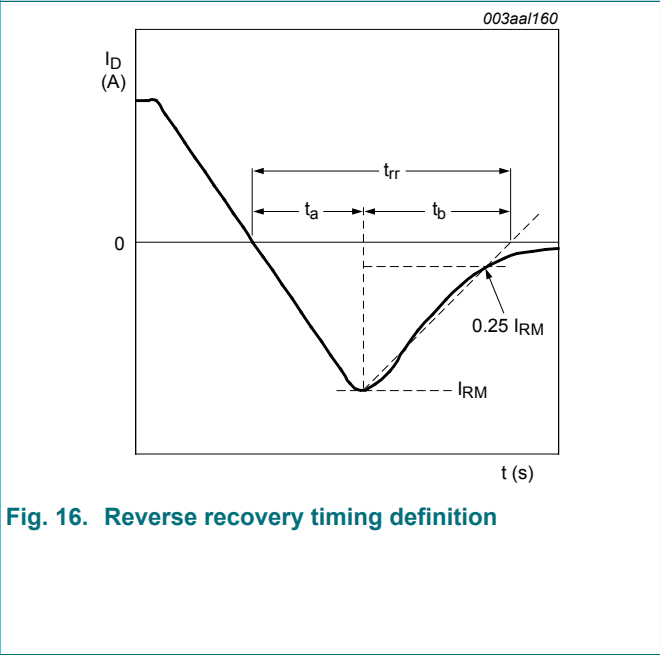
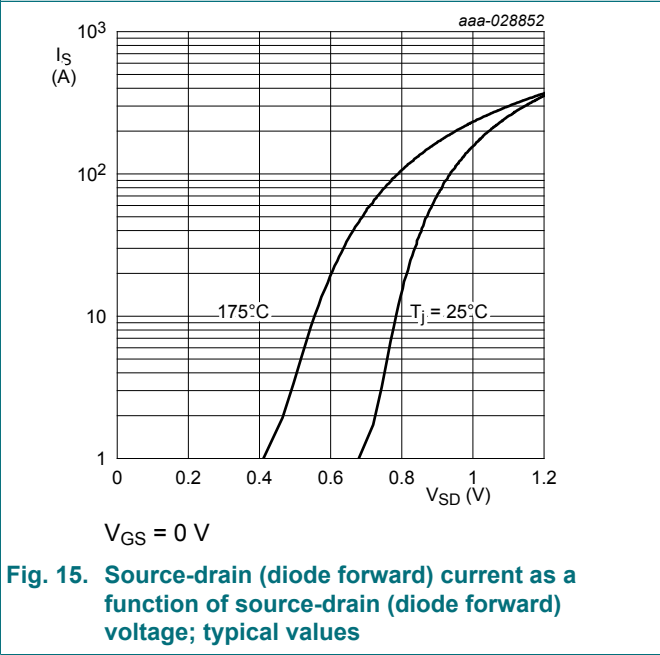
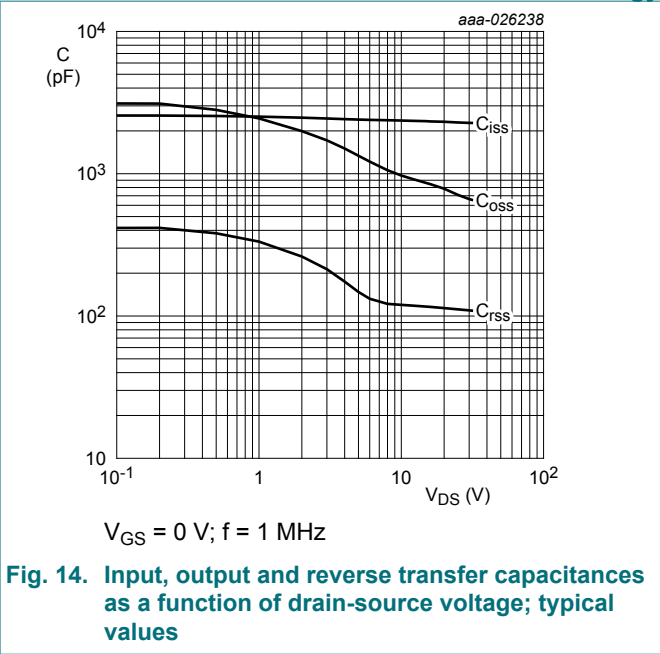
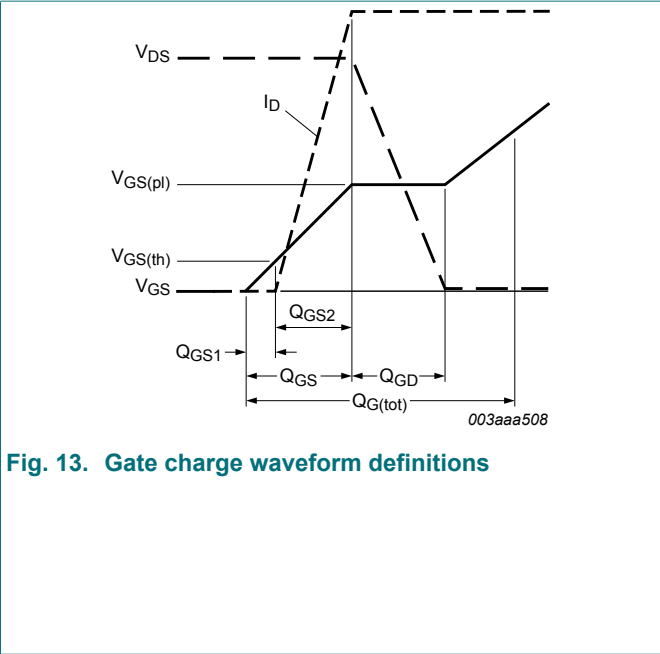


Fig. 12. Gate-source voltage as a function of gate charge; typical values

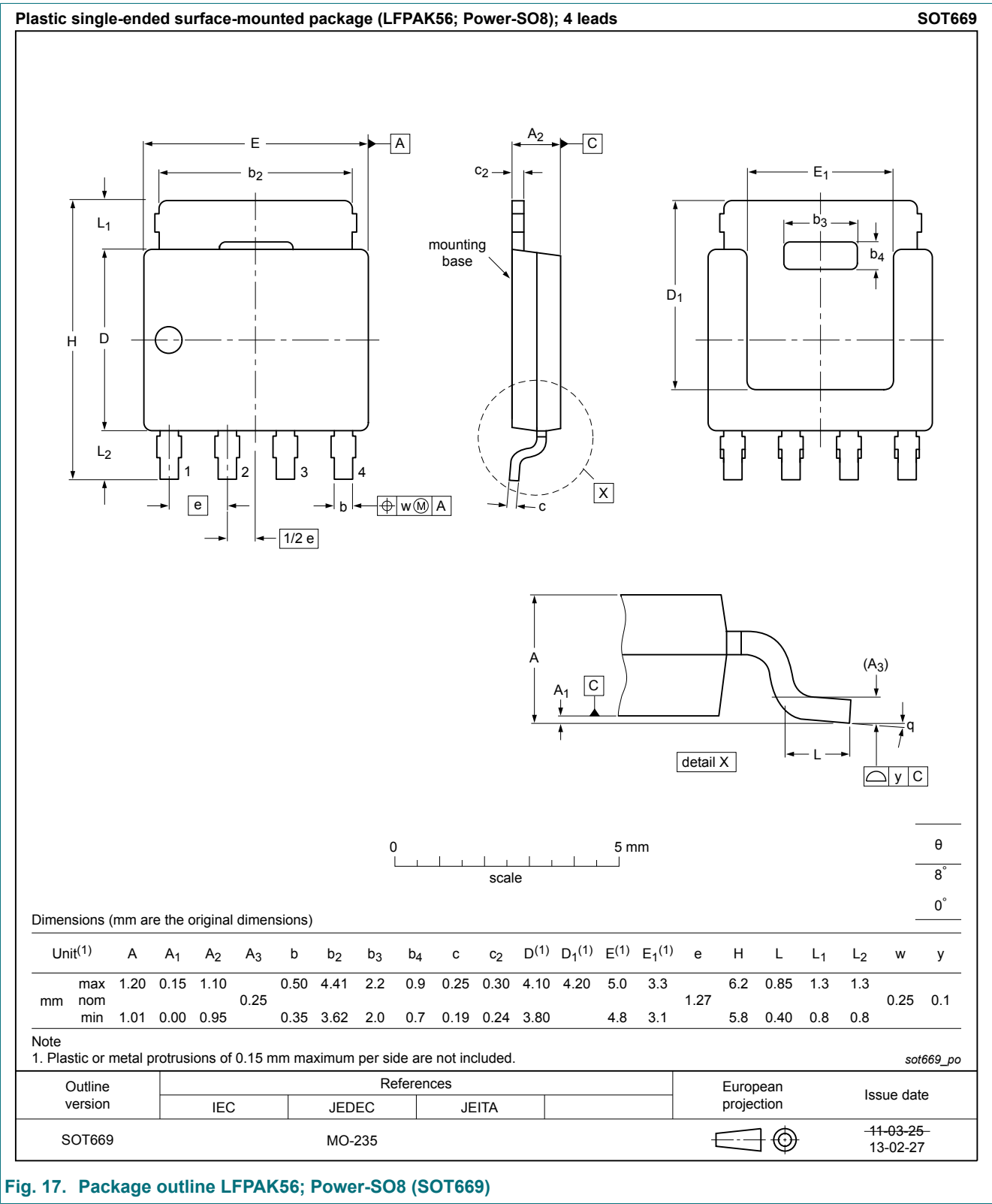
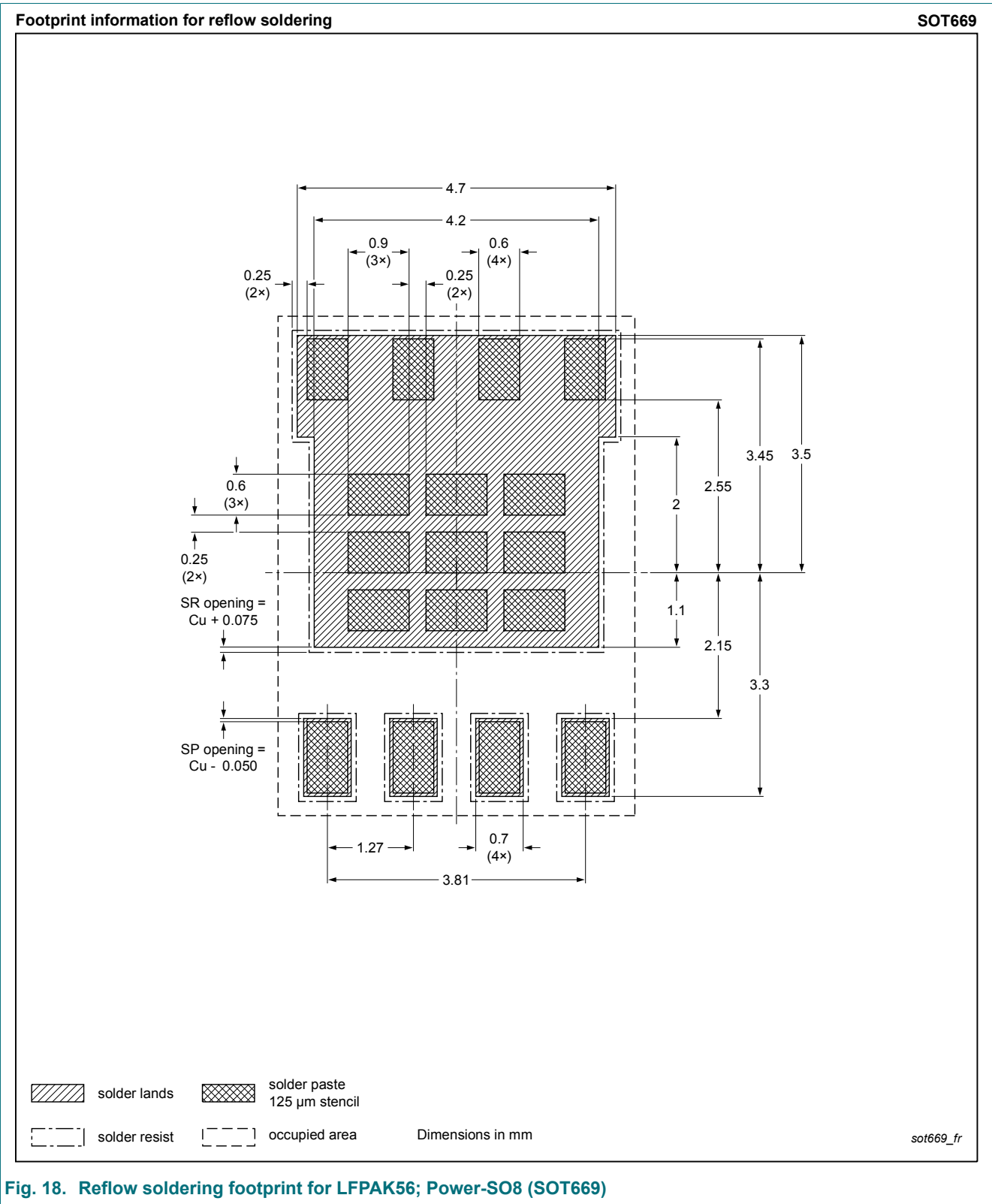
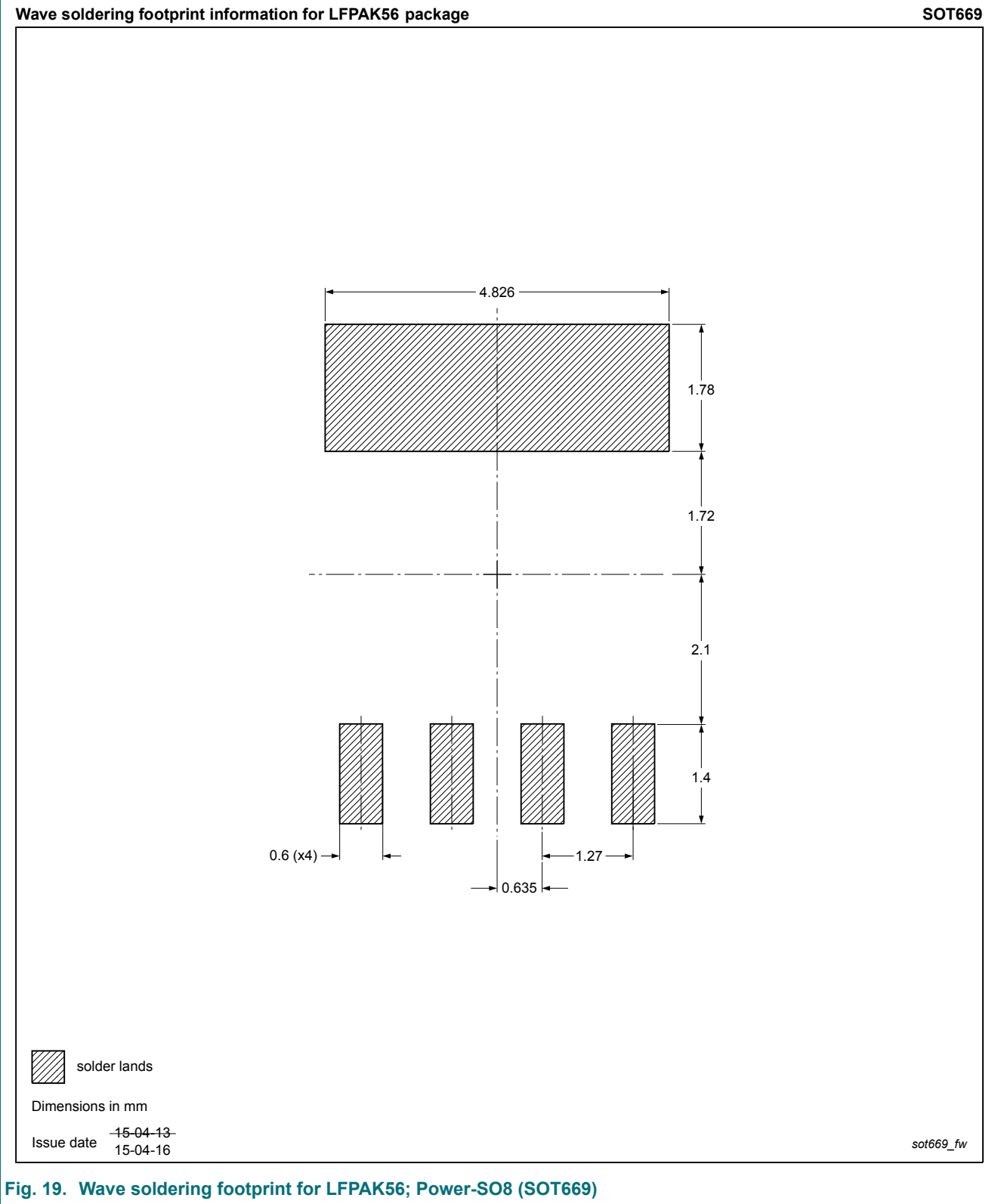


Fig. 17. Package outline LPAK56; Power-SO8 (SOT669)
