




Figure 1: Typical Forward Characteristics




Figure 3: Typical Reverse Characteristics




Figure 5: Current Derating Curves

Figure 6: Typical Junction Capacitance vs Reverse Voltage Characteristics




Figure 8: Typical Capacitive Energy vs Reverse Voltage Characteristics






Figure 9: Transient Thermal Impedance




Figure 10: Forward Curve Model




