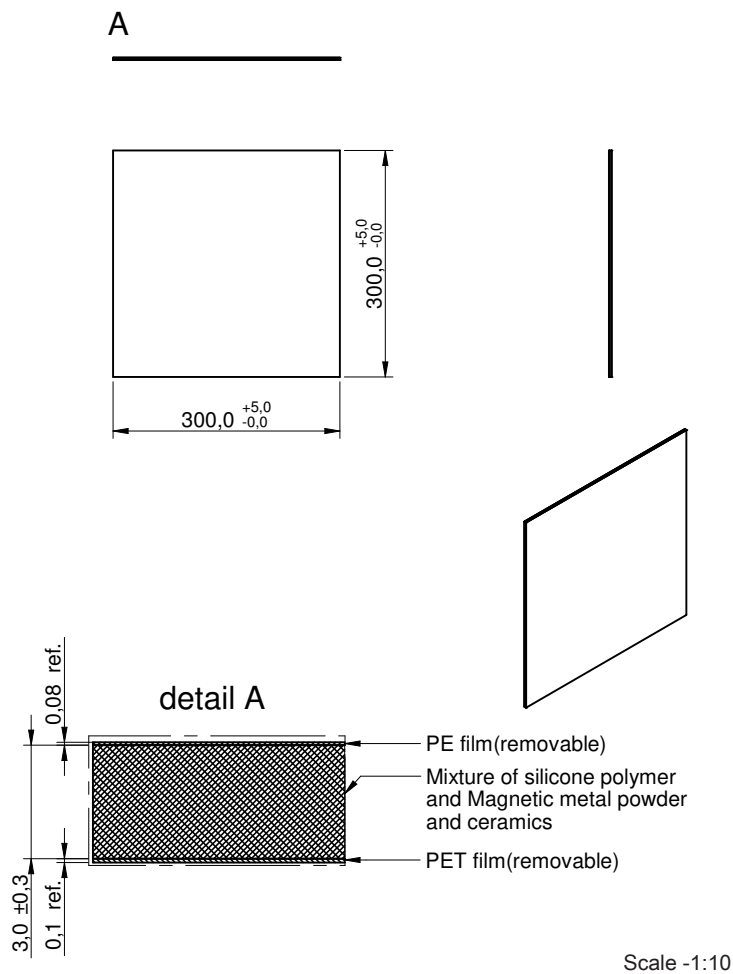

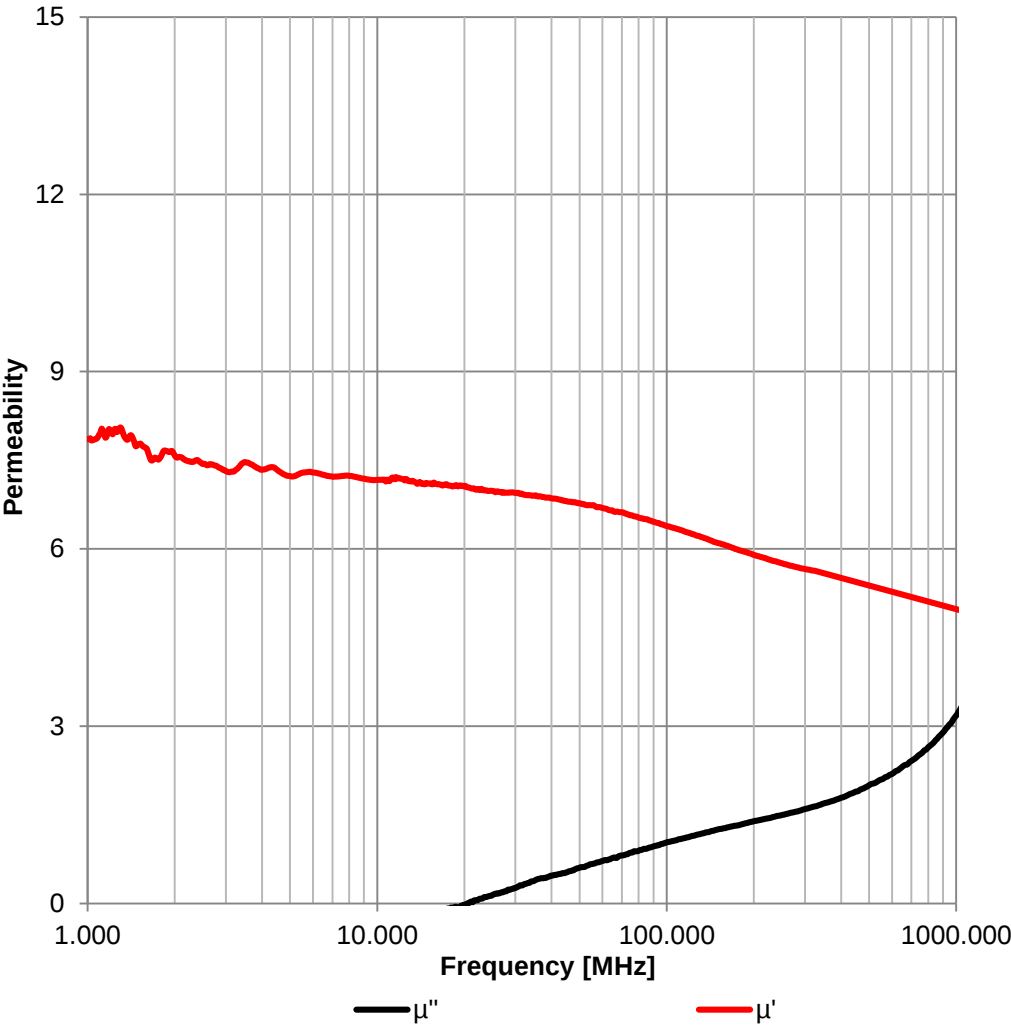

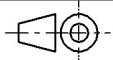

Product specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product..

Potting:

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Storage Conditions:

- Do not expose the components to direct sunlight.

- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

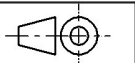
Packaging:

Handling:

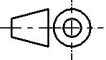
