Typical Attenuation:



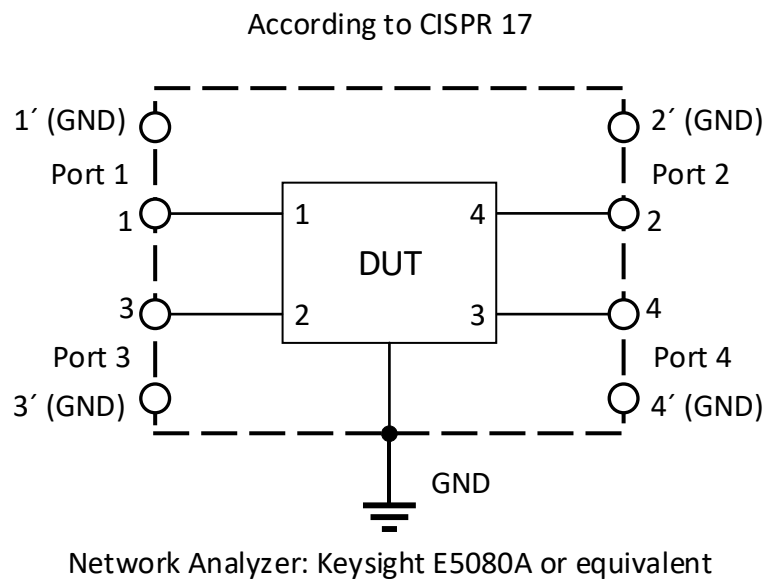
