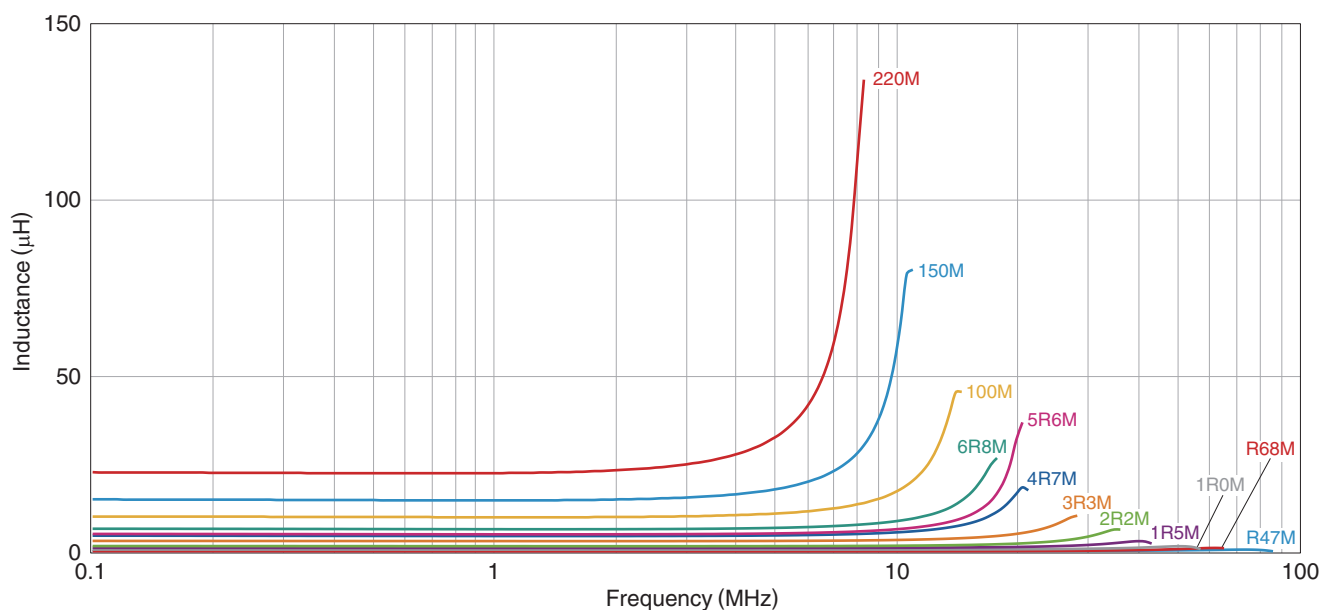

L FREQUENCY CHARACTERISTICS

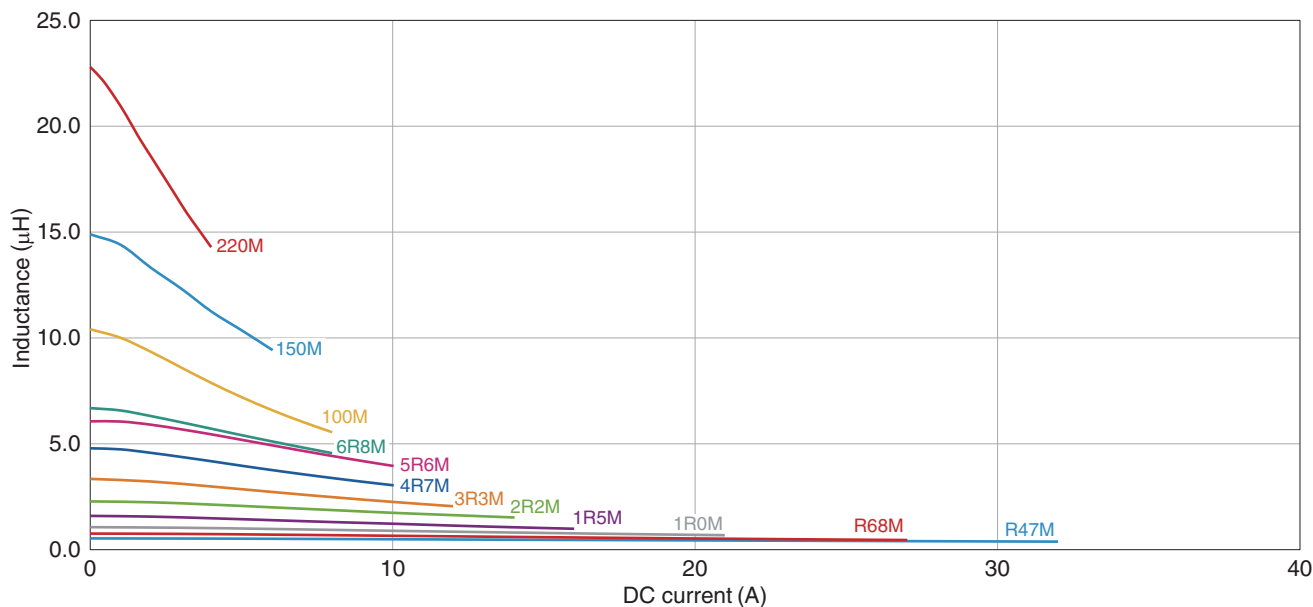
