Typical Temperature Rise vs. Current Characteristics:



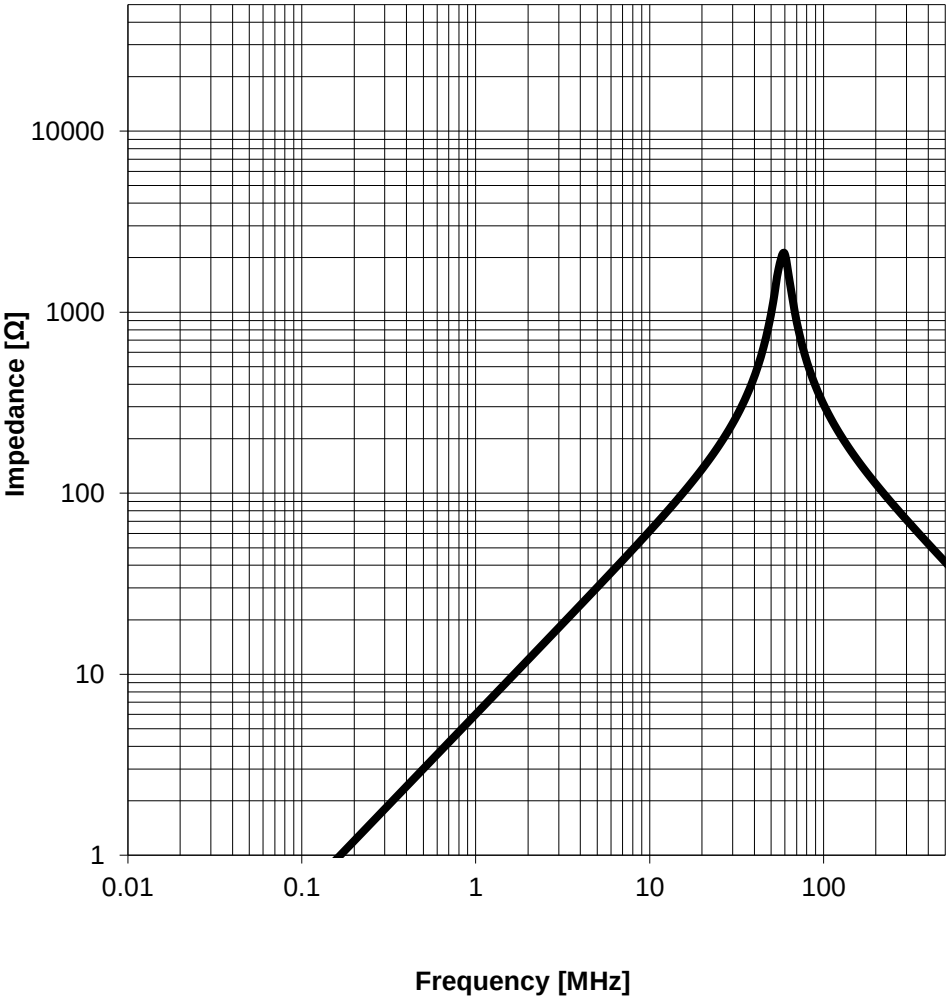
Typical Inductance vs. Current Characteristics:

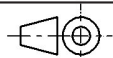

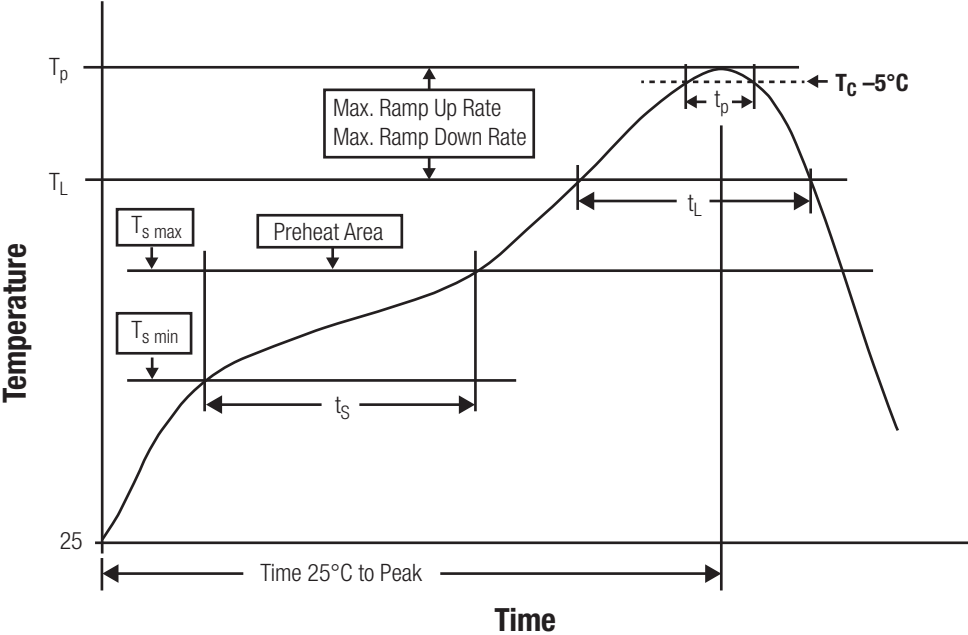

### 6. Product Life Cycle

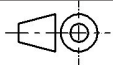
