Typical Temperature Rise vs. Current Characteristics:



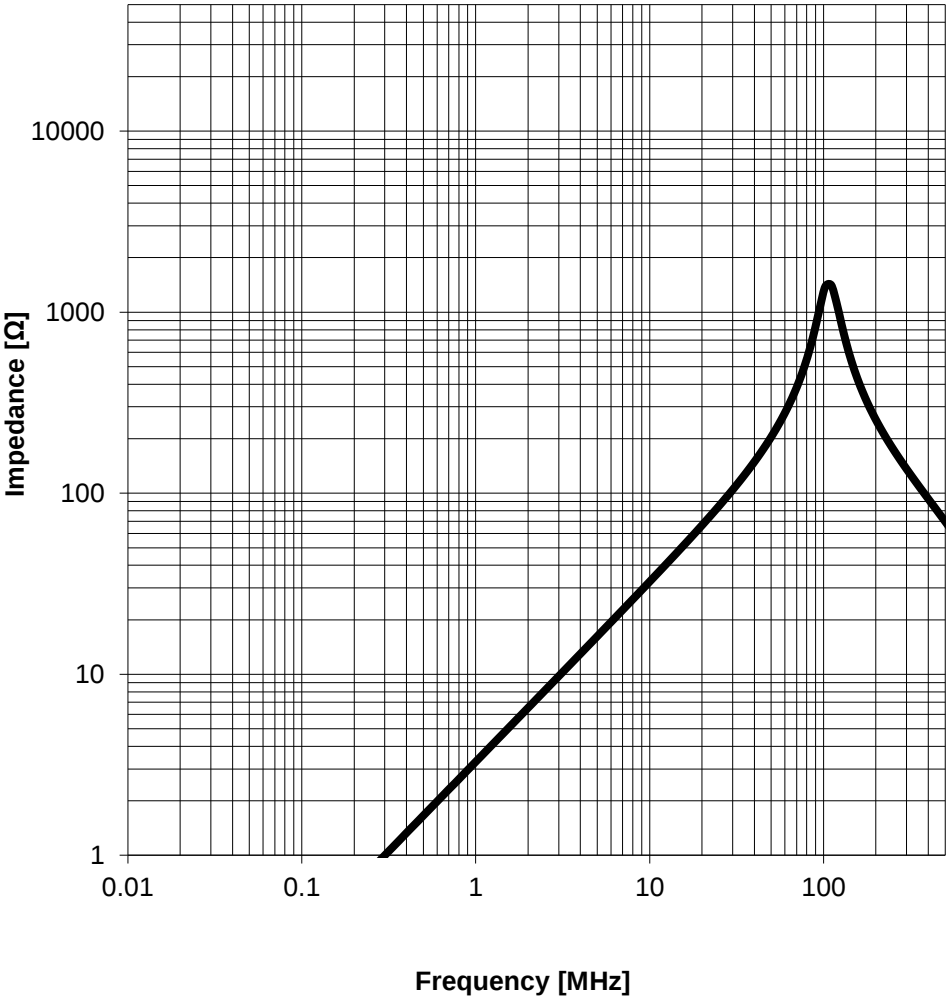
Typical Inductance vs. Current Characteristics:

### Soldering:

### Cleaning and Washing:

### Potting:
