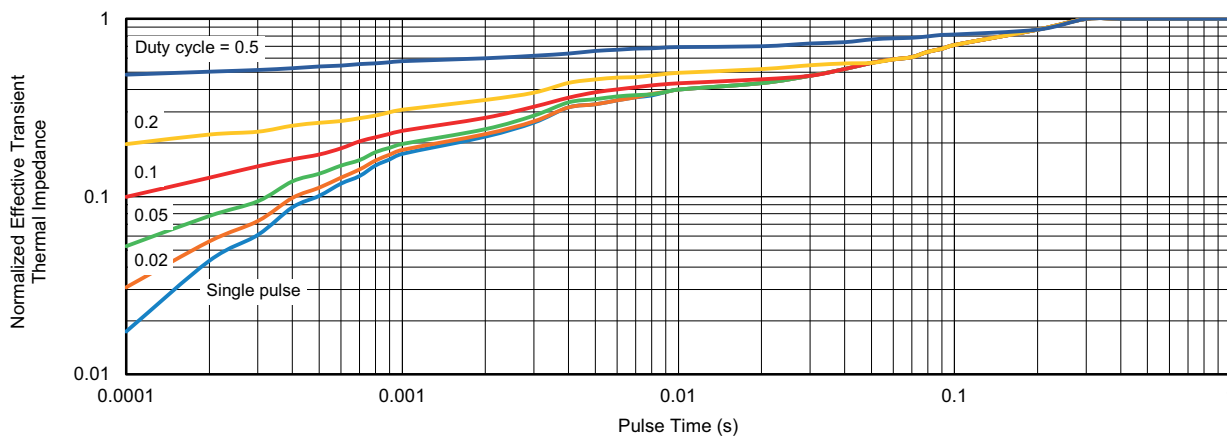
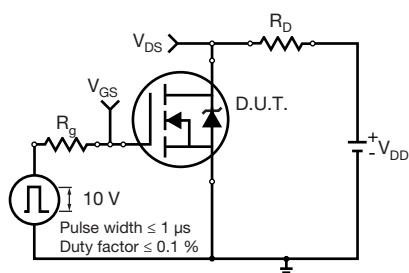
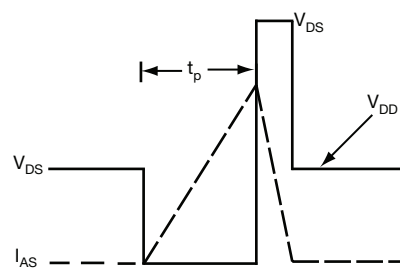
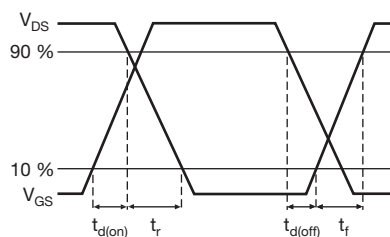
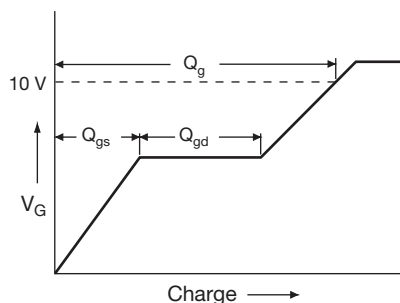
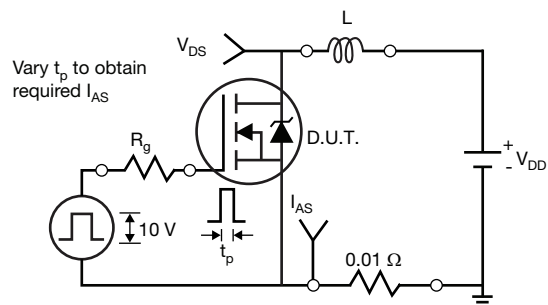
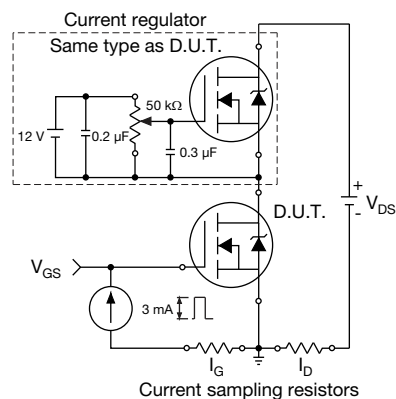
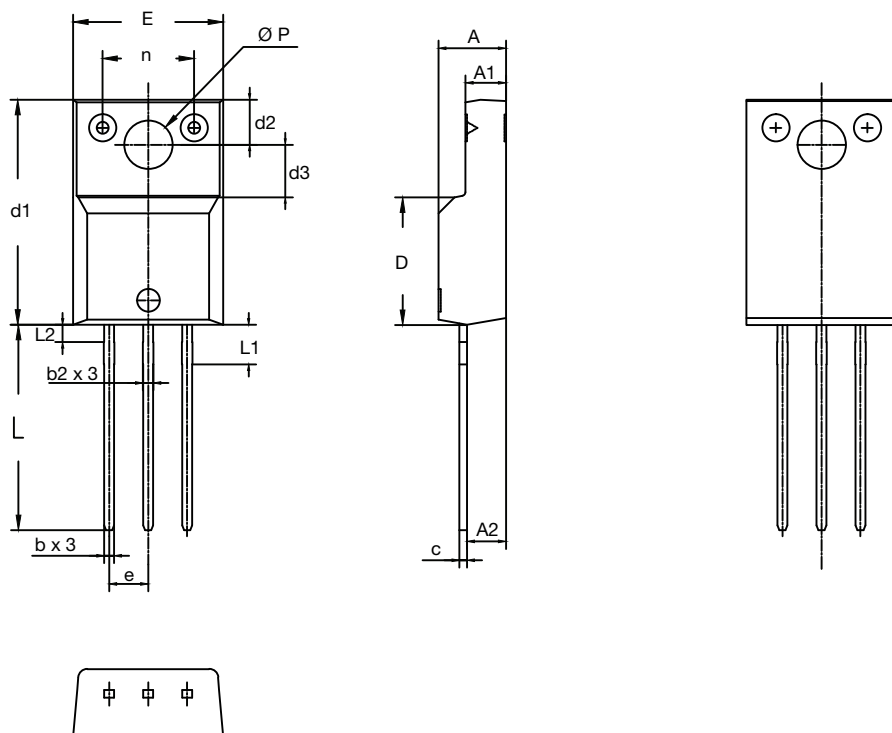

Fig. 12 - Normalized Transient Thermal Impedance, Junction-to-Case
