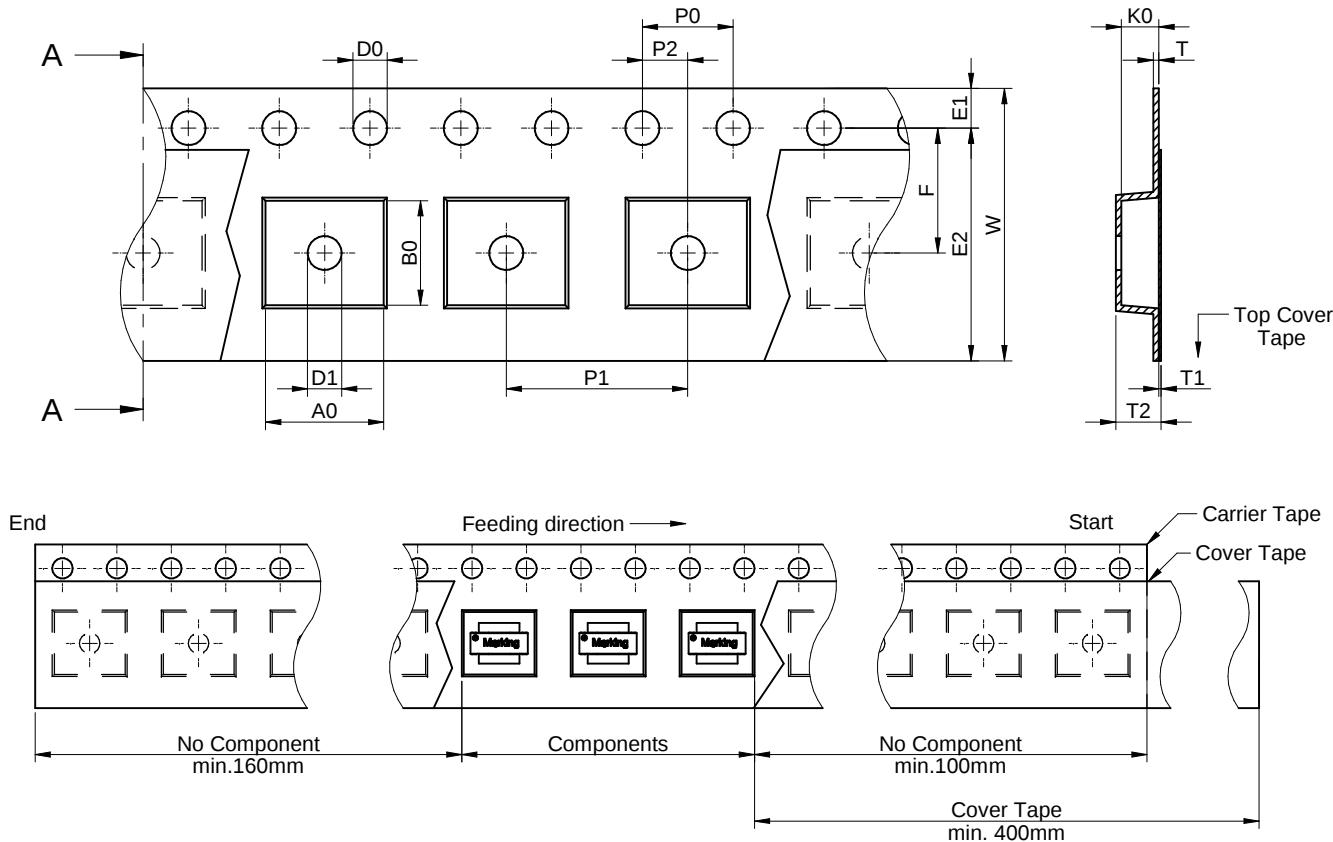
Typical Temperature Rise vs. Current Characteristics

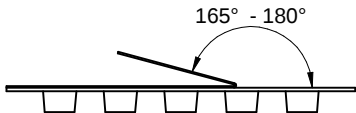

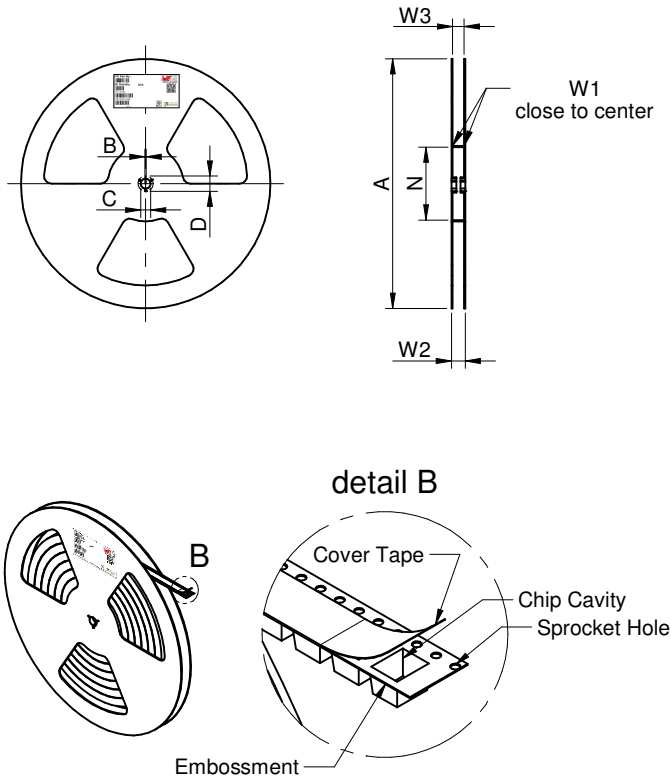

### Soldering:

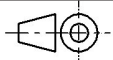
### Storage Conditions:

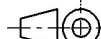
