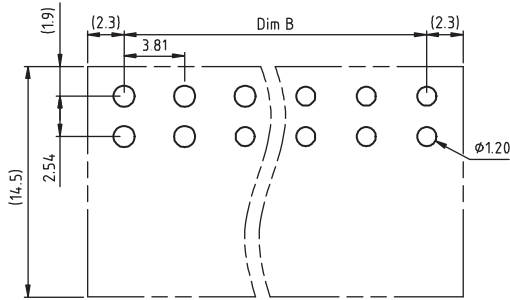


2P to 6P with wedge,

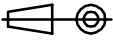

Storage Conditions: - The Connectors are considered MSL1 into closed original packaging and are not subject to storage time limits regarding the moisture sensivity but all products shall be used before the end of the period of 12 months based on the products date code, if not 100% solderability can't be warranted. Handling: - Do not repeatedly operate the connector with excessive force. It may damage or deforms the contact dome which results in malfunction. - In the case a product requires particular handling precautions, in addition to the general recommendations mentioned here before, these will appear on the product datasheet.
