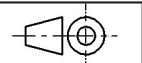
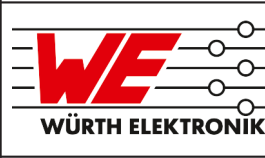
Storage Conditions:

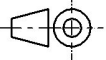
