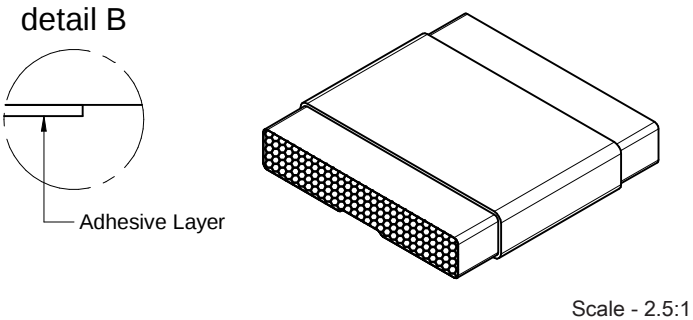
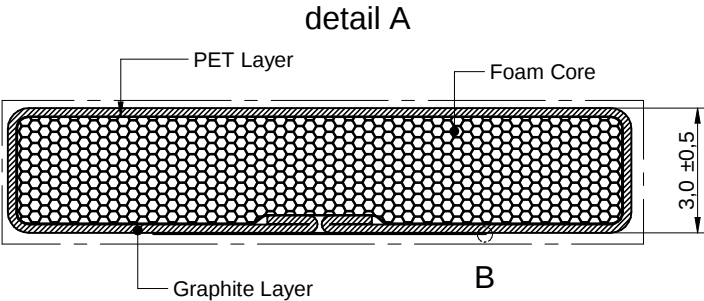
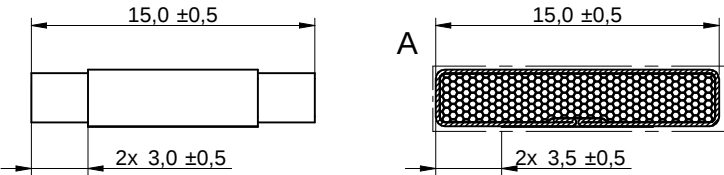

Product Specific:

Cleaning and Washing:
