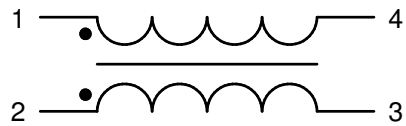

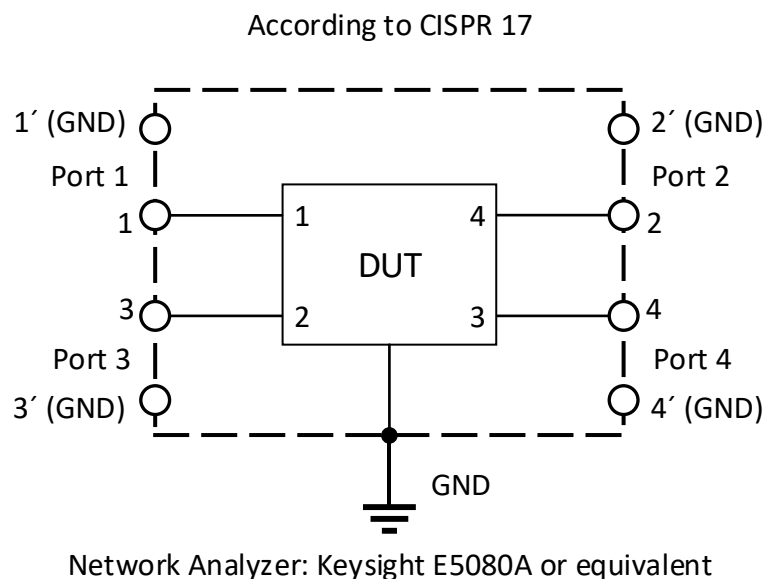


Typical Impedance Characteristics:

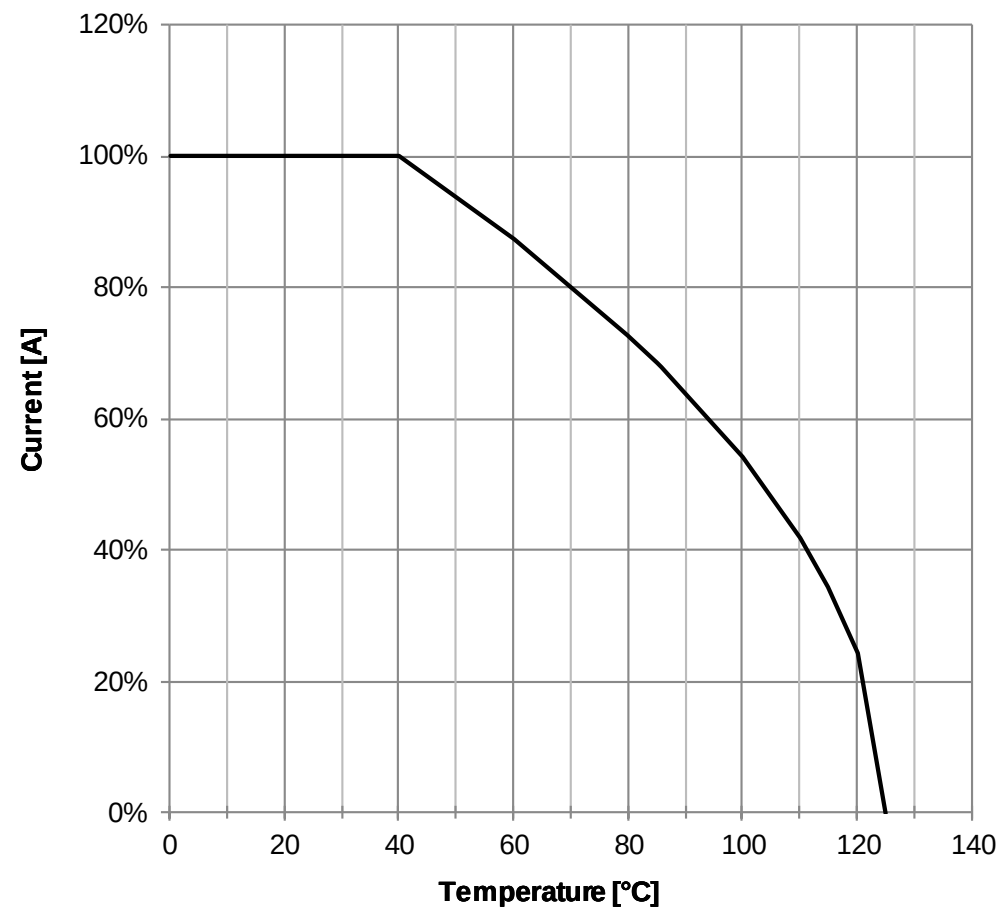

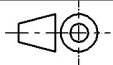
