Typical Temperature Rise vs. Current Characteristics:



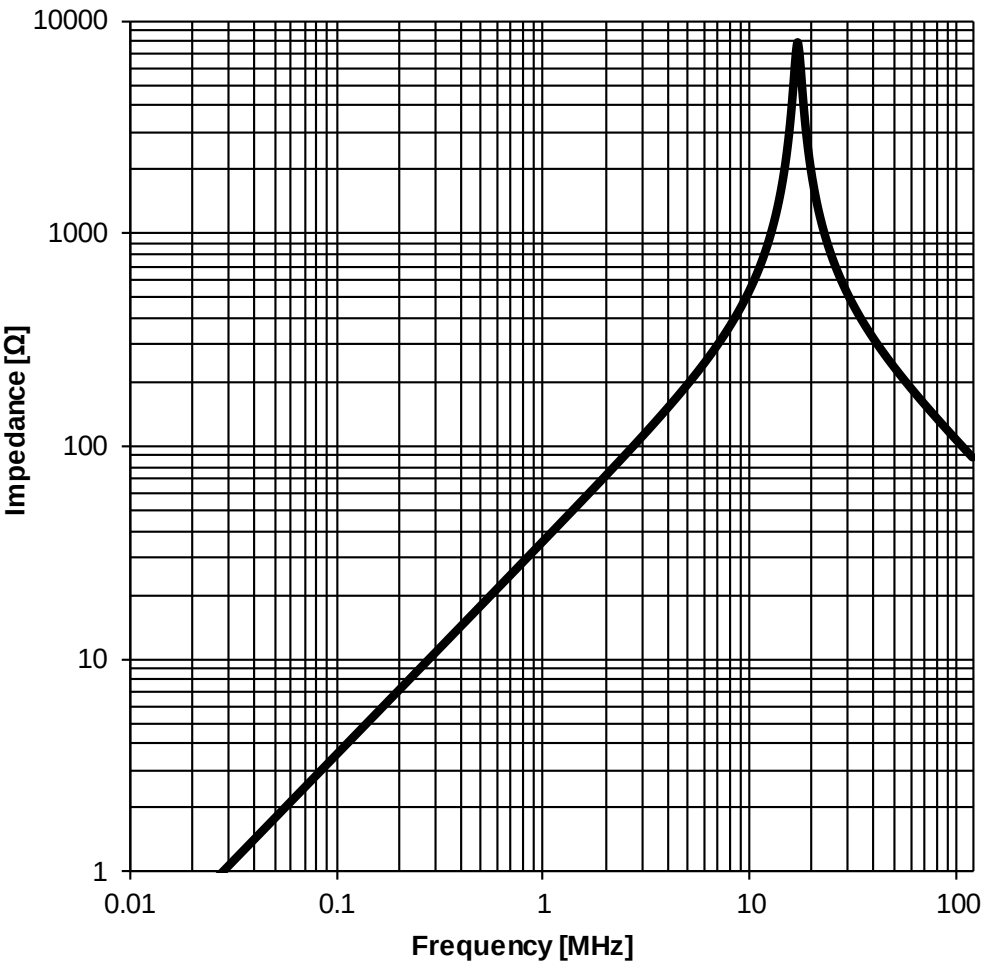
Typical Inductance vs. Frequency Characteristics:

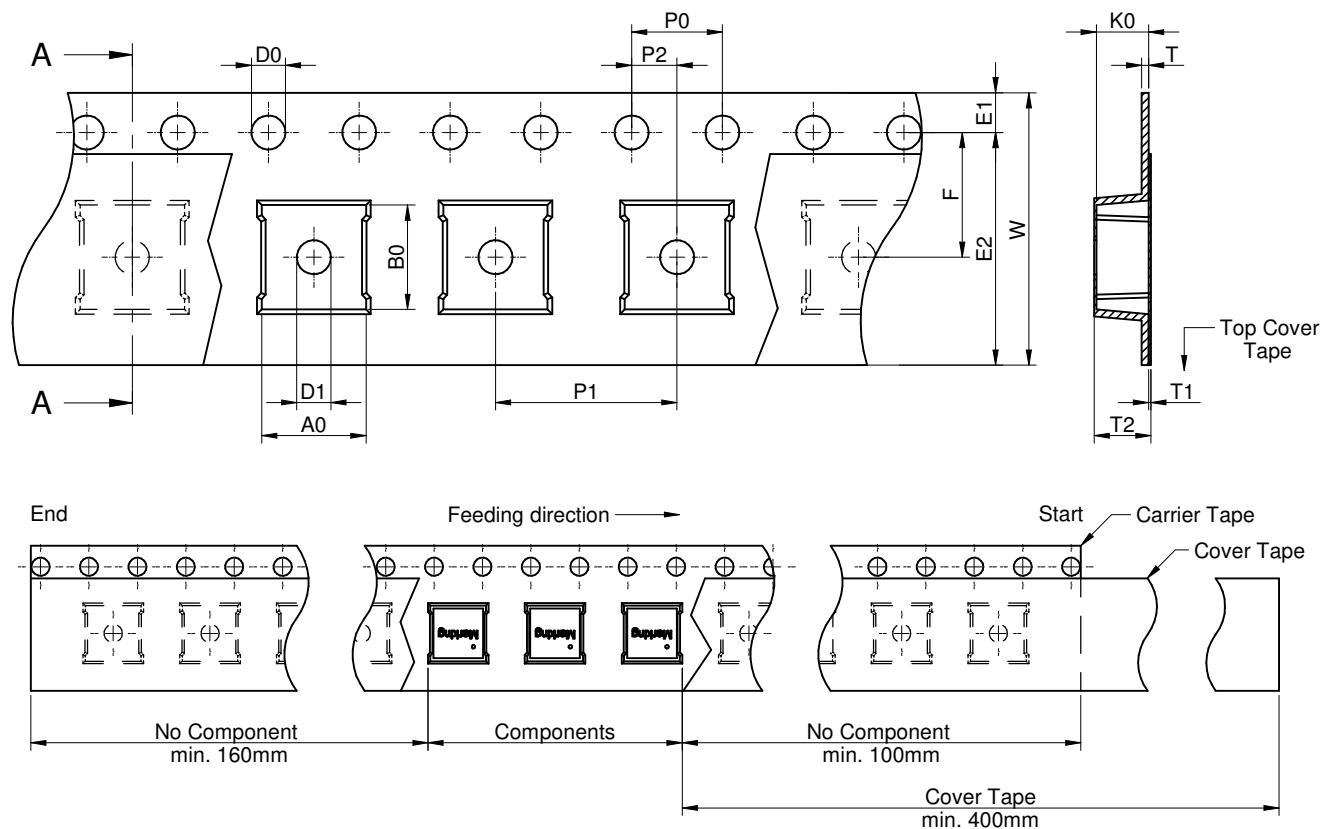
Typical Impedance Characteristics:
