Typical Attenuation:



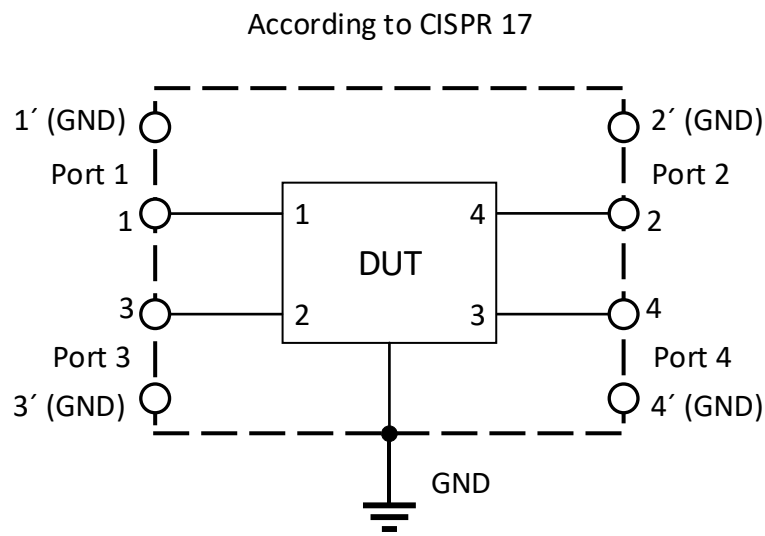
Typical Impedance Characteristics:

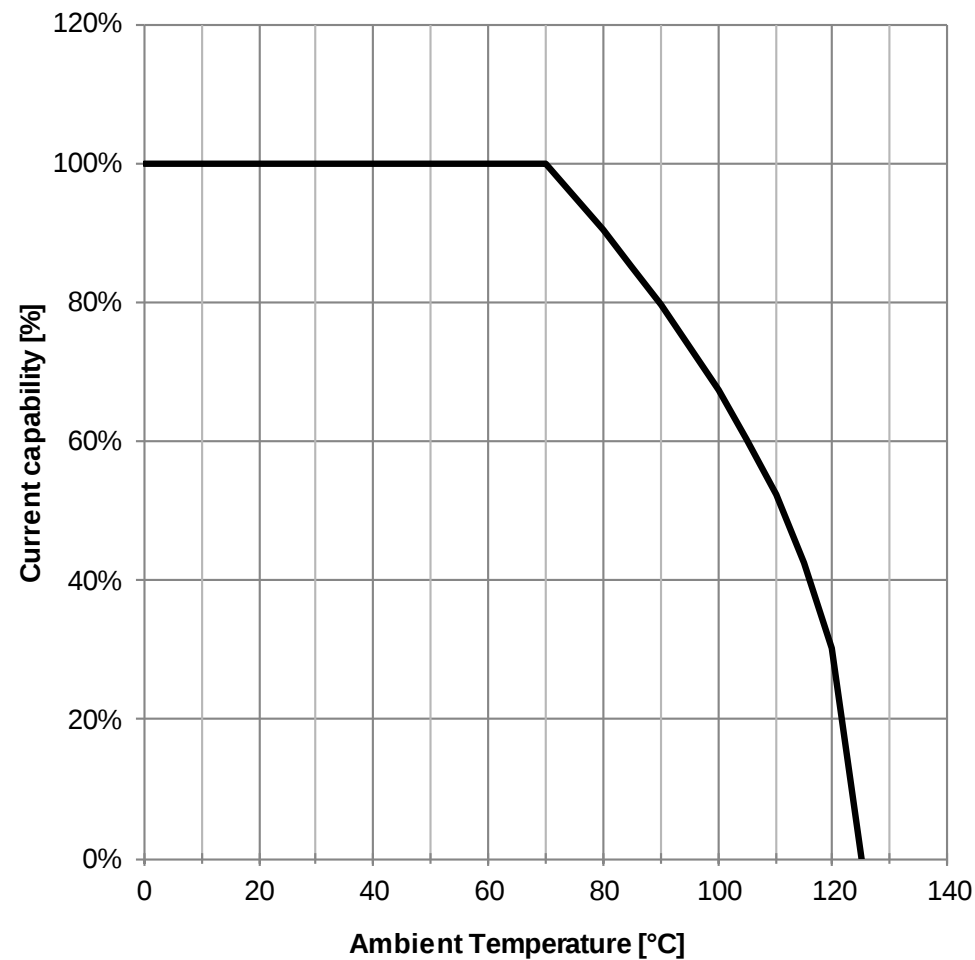

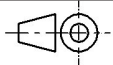

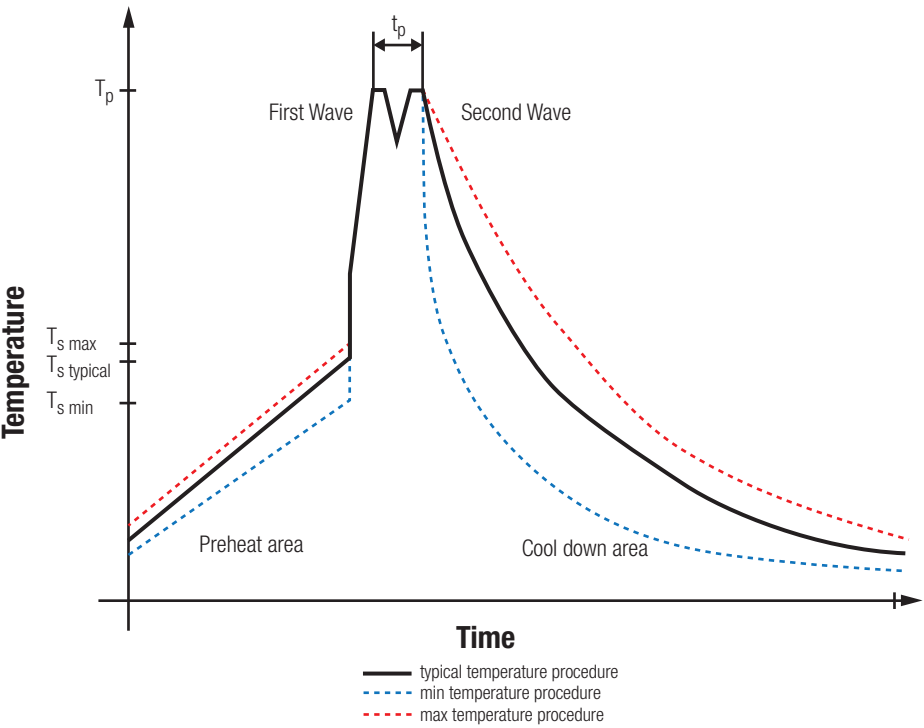
Derating Curve:
