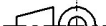

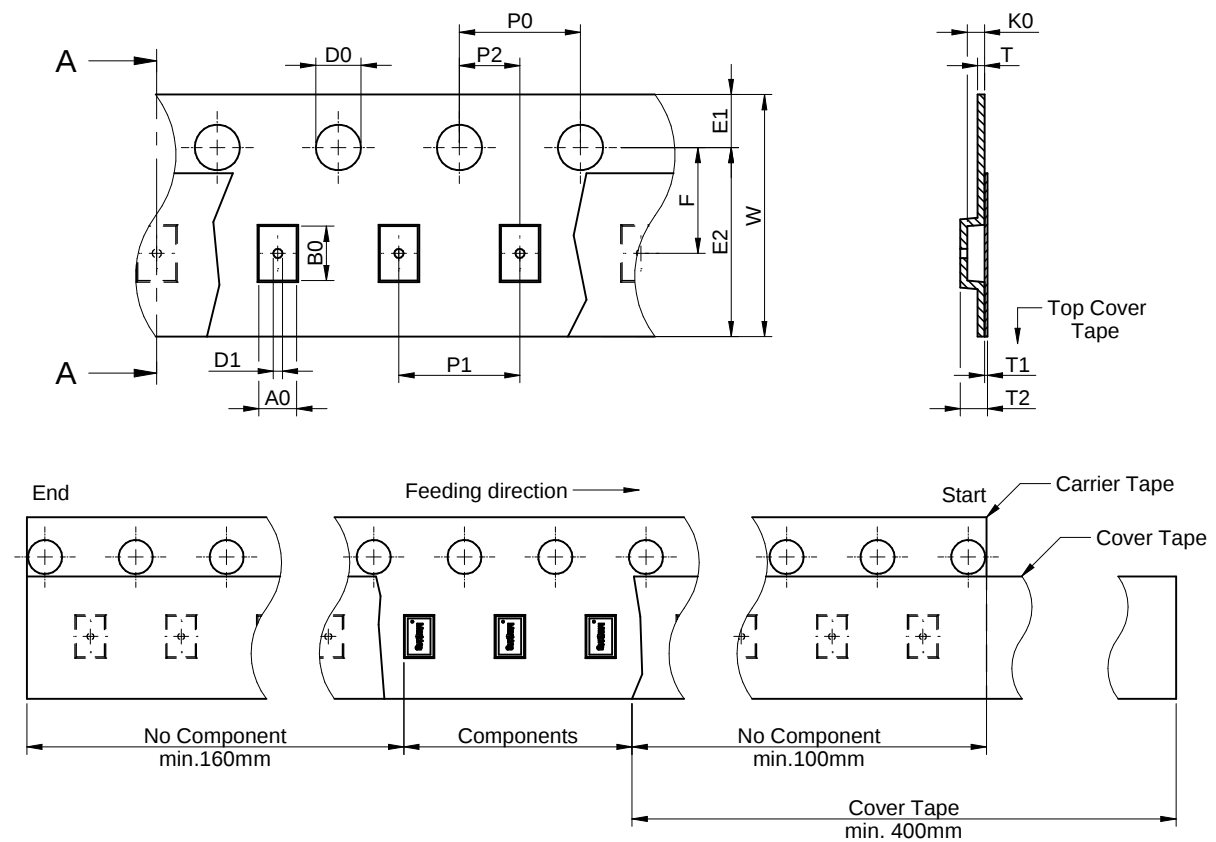
Variation of CX vs. VIO:

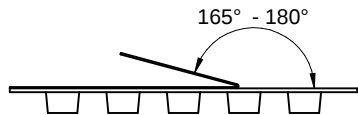

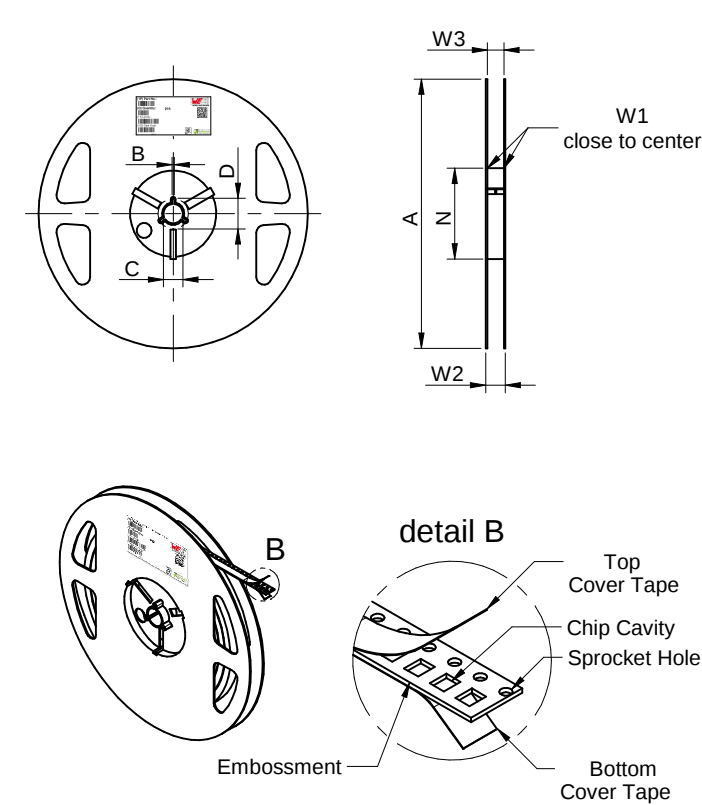

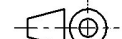
