Typical Attenuation:



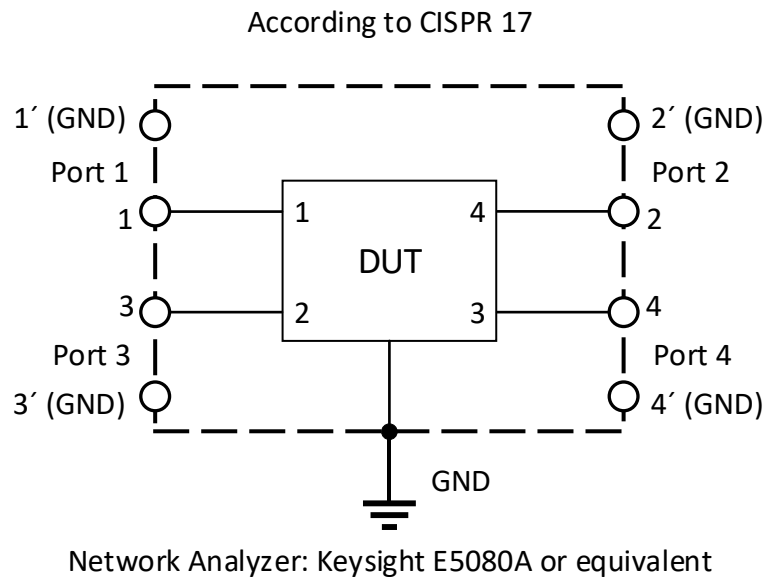

Soldering:
