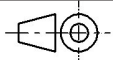

Typical Inductance vs. Frequency Characteristics:



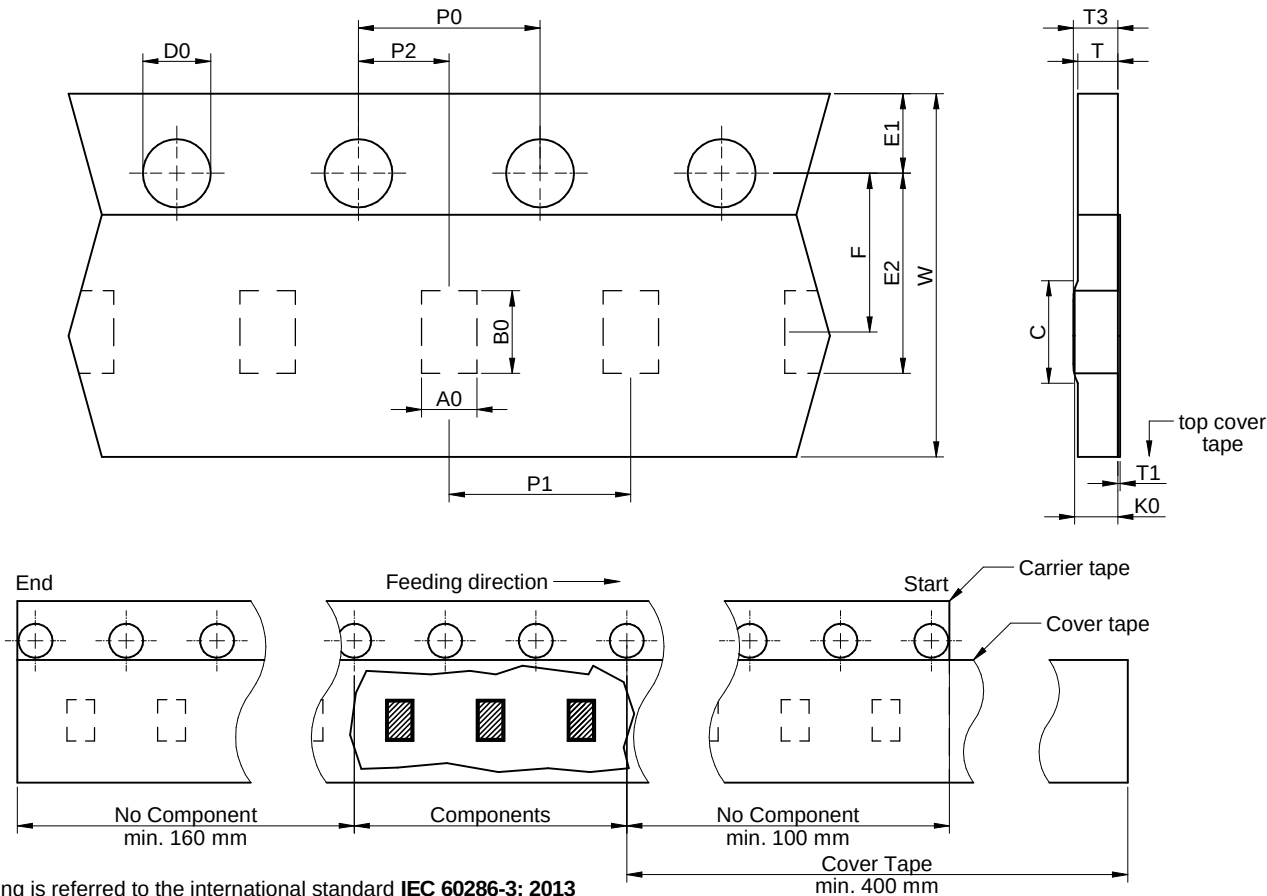
Q-Factor vs. Frequency:

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

Cleaning and Washing:

Potting:

Shrinking could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend a manual inspection after potting to avoid these effects.

Storage Conditions:

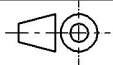
Packaging:

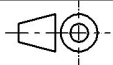
