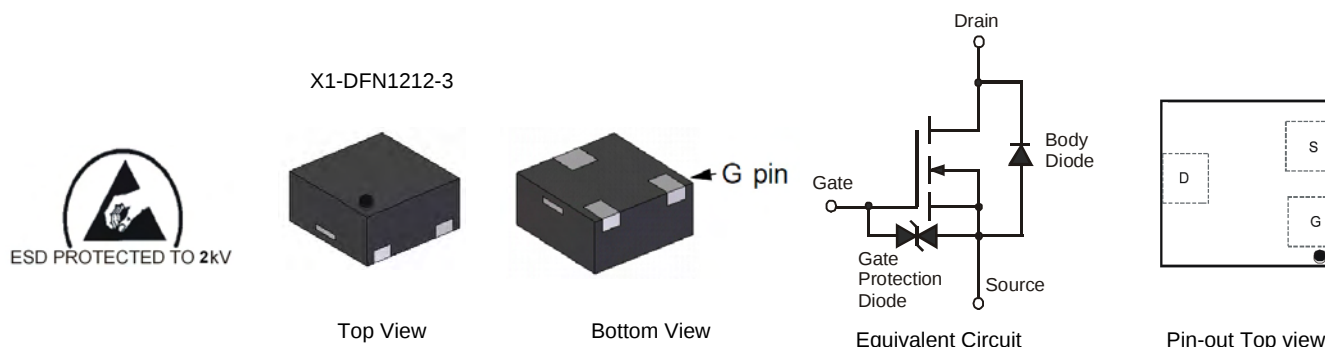

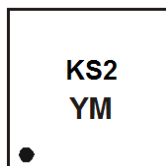

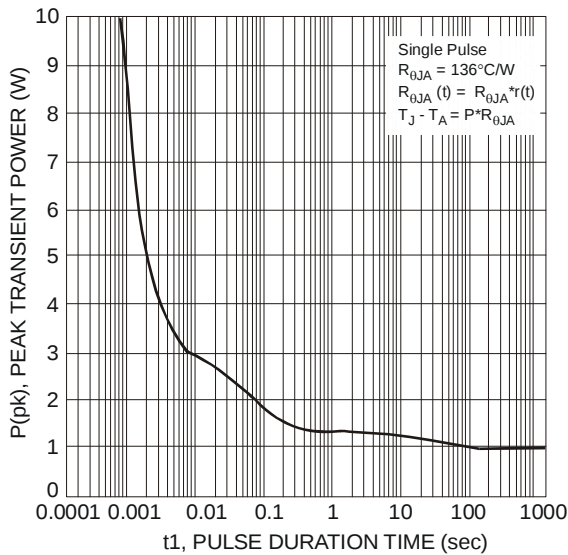


Fig. 1 Single Pulse Maximum Power Dissipation

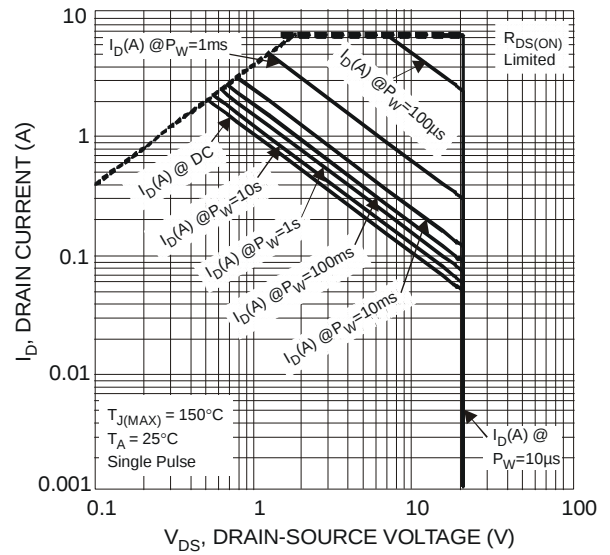
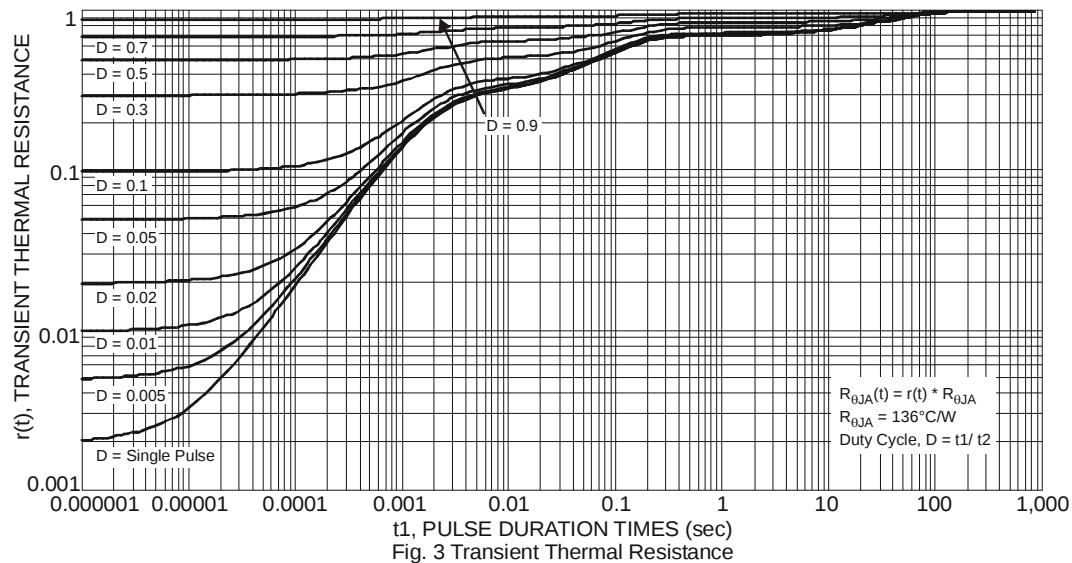


Fig. 2 SOA, Safe Operation Area

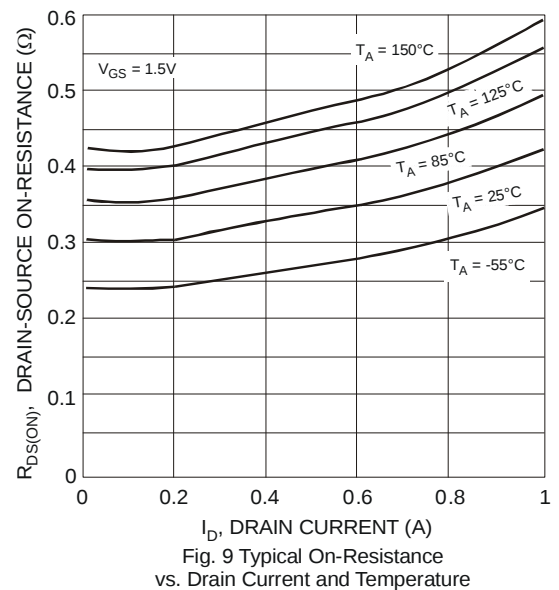
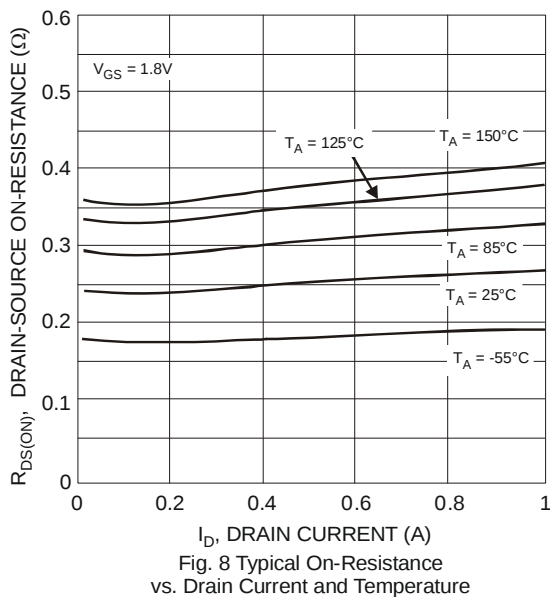
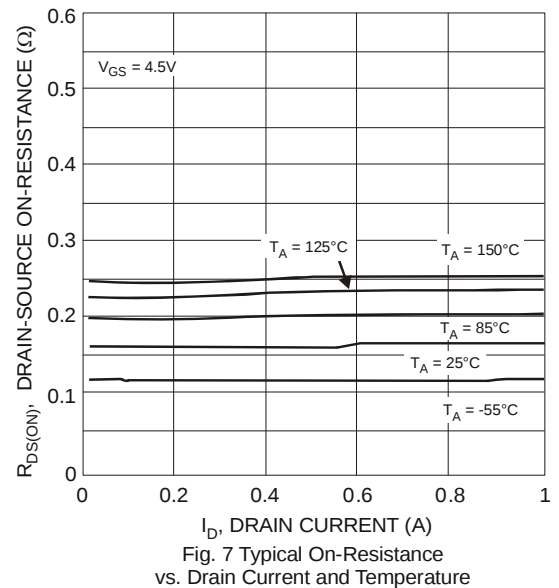
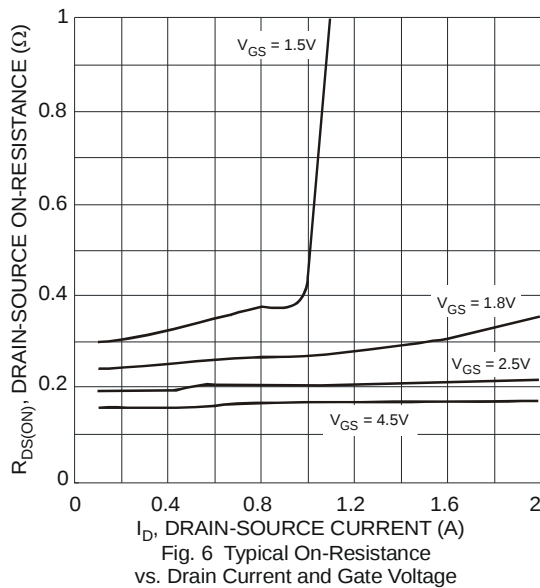
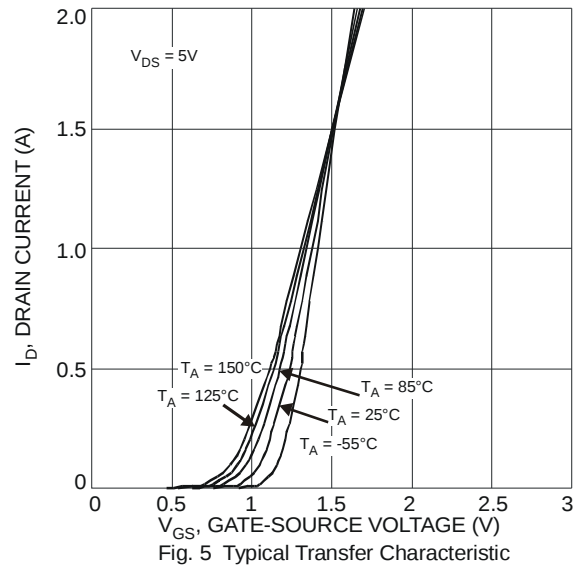
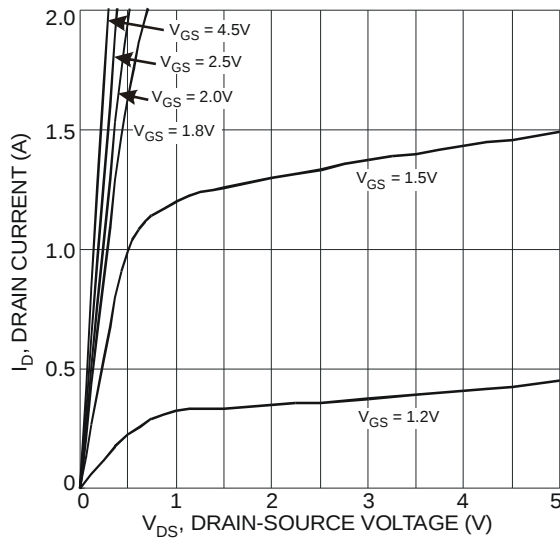

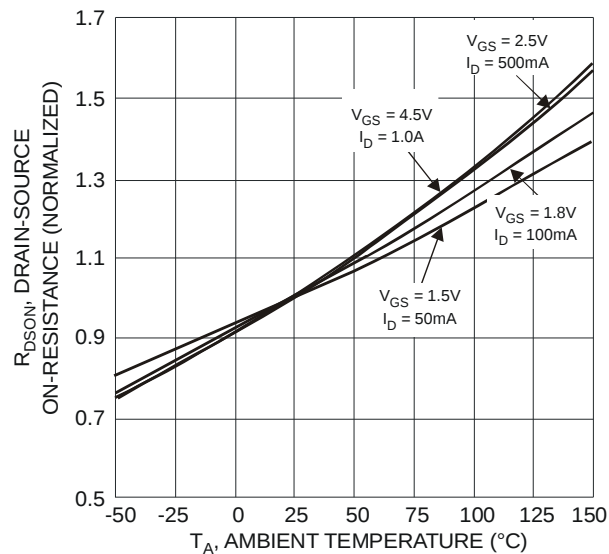


Fig. 10 On-Resistance Variation with Temperature

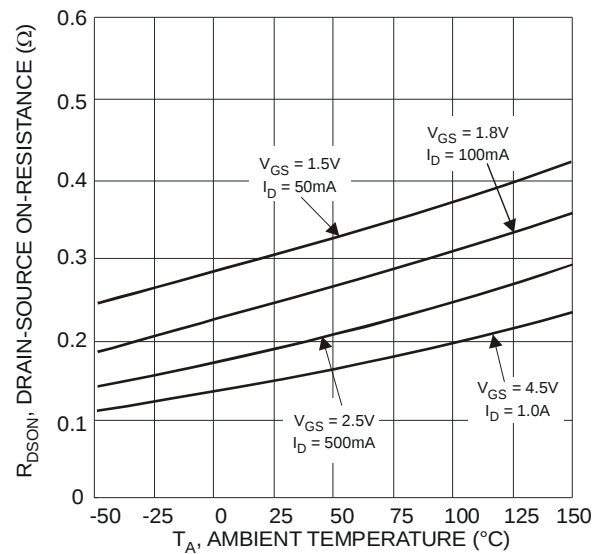


Fig. 11 On-Resistance Variation with Temperature

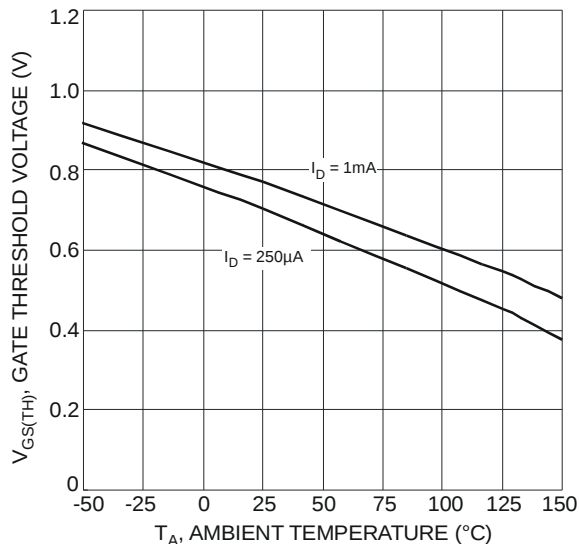


Fig. 12 Gate Threshold Variation vs. Ambient Temperature

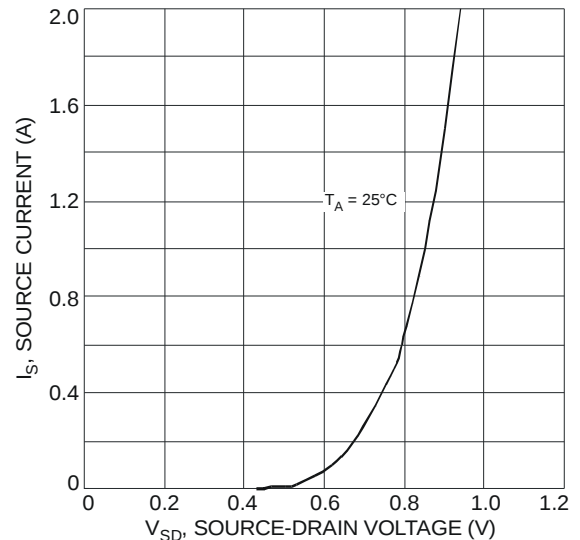


Fig. 13 Diode Forward Voltage vs. Current

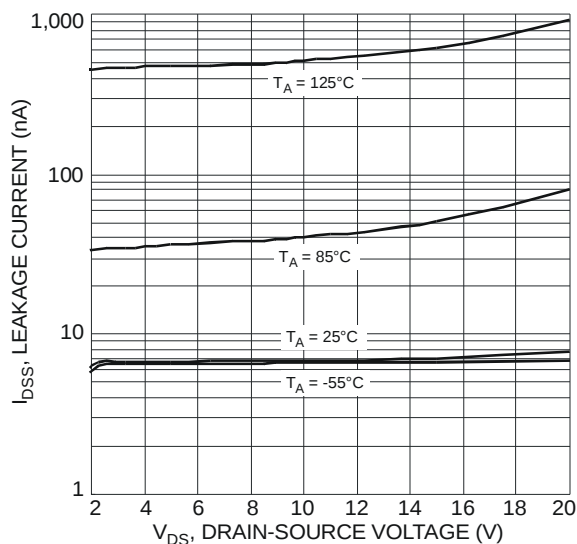


Fig. 14 Typical Leakage Current
vs. Drain-Source Voltage

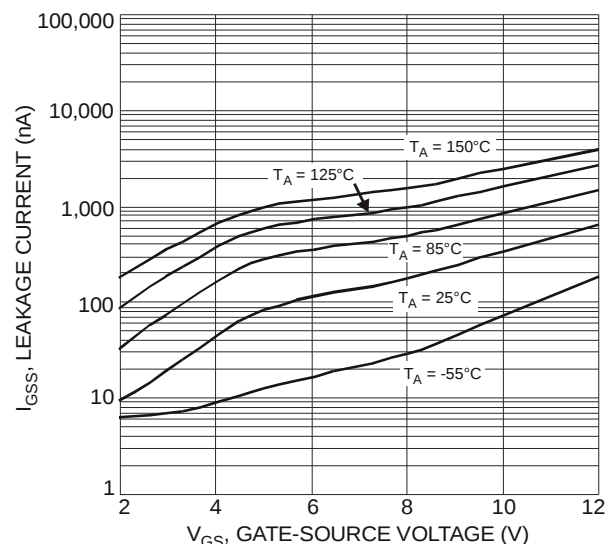


Fig. 15 Leakage Current vs. Gate-Source Voltage

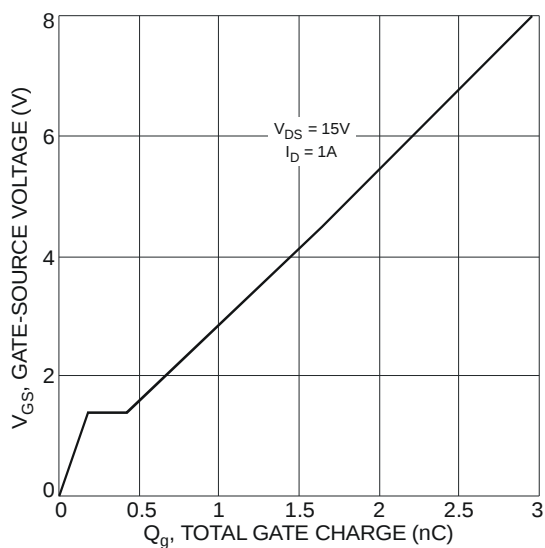
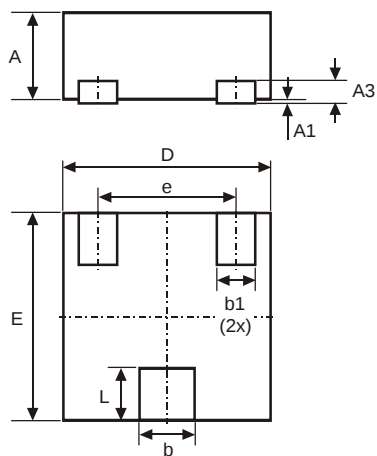


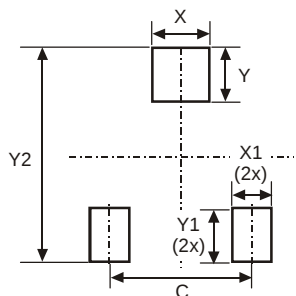
Fig. 16 Gate-Charge Characteristics
