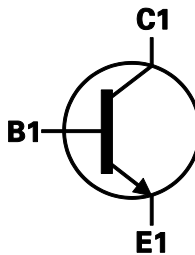

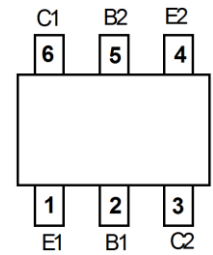
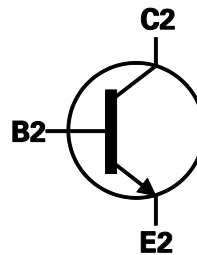

Pin-Out

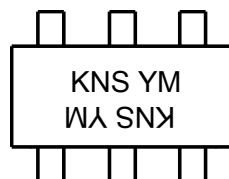

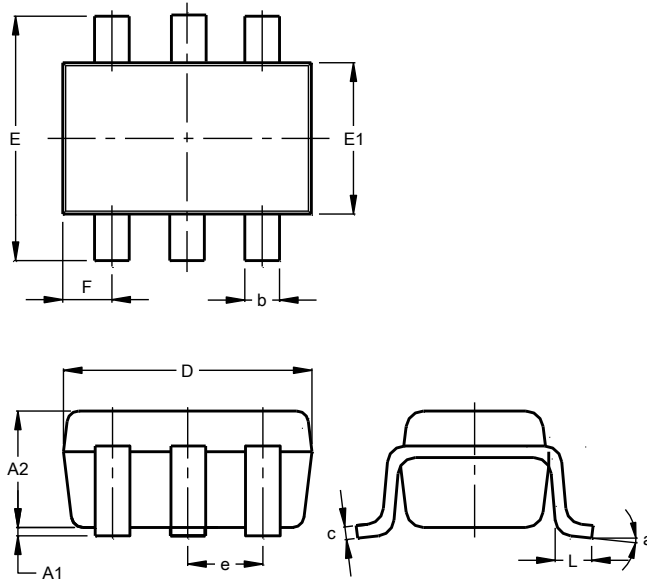
