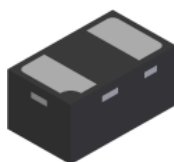

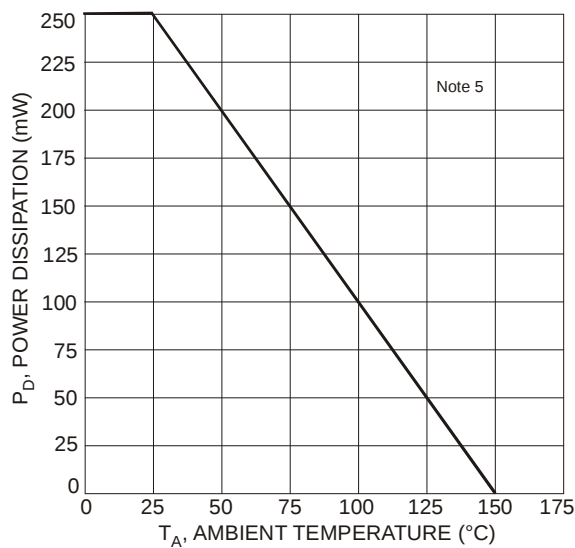


Figure 1 Power Derating Curve

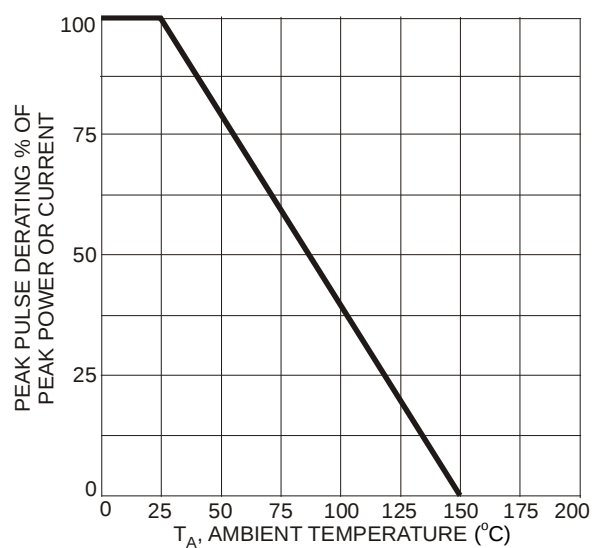


Figure 2 Pulse Derating Curve

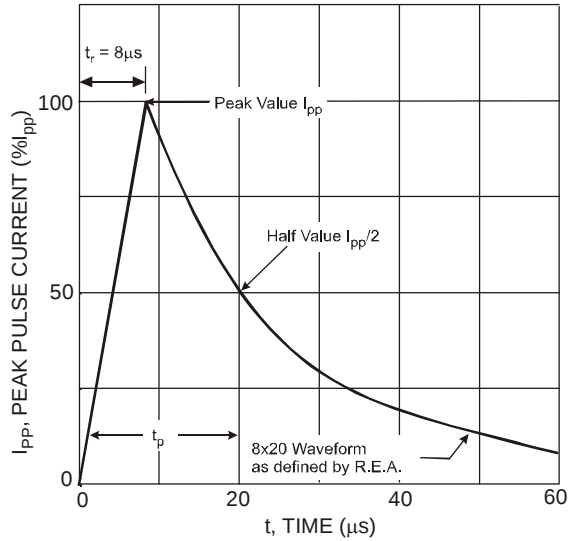


Figure 3 Typical 8 × 20μs Pulse Waveform

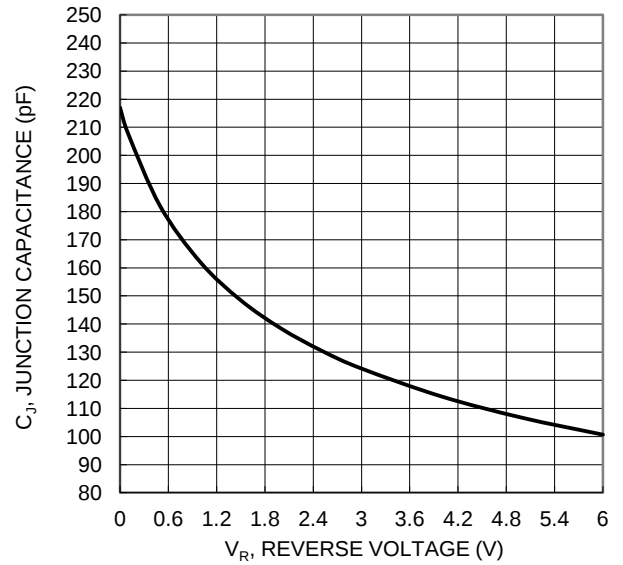


Figure 4 Typical Junction Capacitance

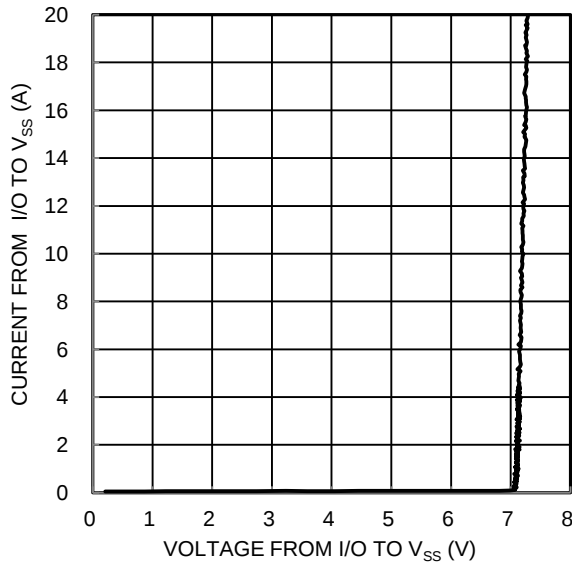


Figure 5 Current vs. Voltage

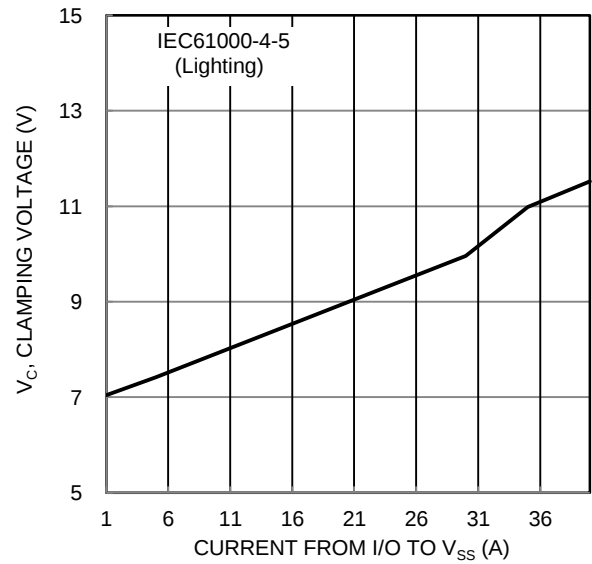
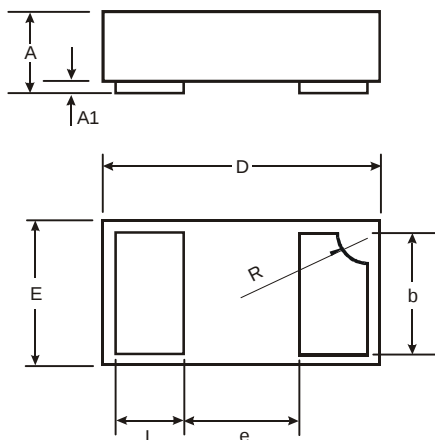


Figure 6 Clamping Voltage Characteristic

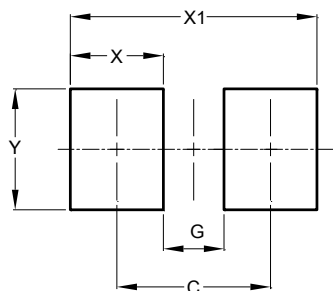
