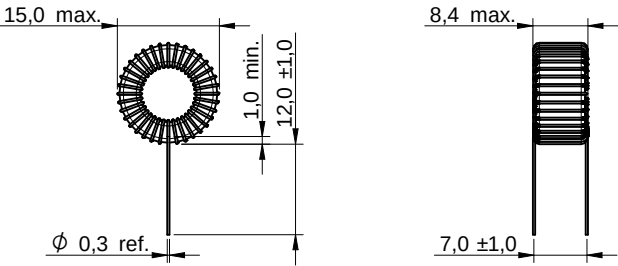
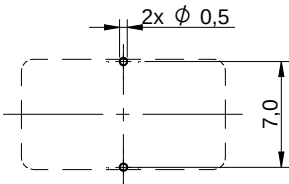


Recommended Hole Pattern: [mm]

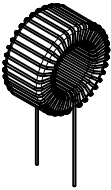

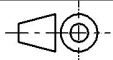

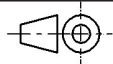
Packaging:

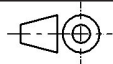
