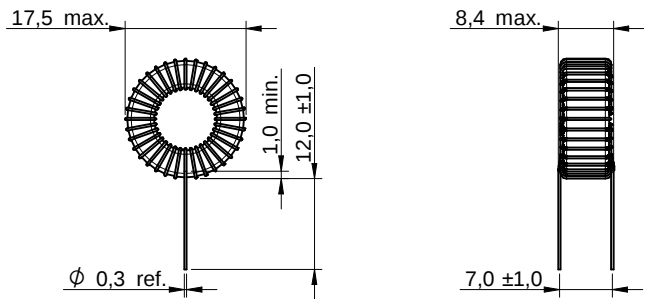
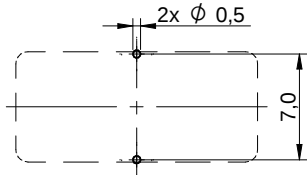

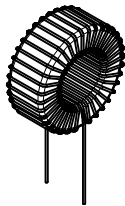


Recommended Hole Pattern: [mm]

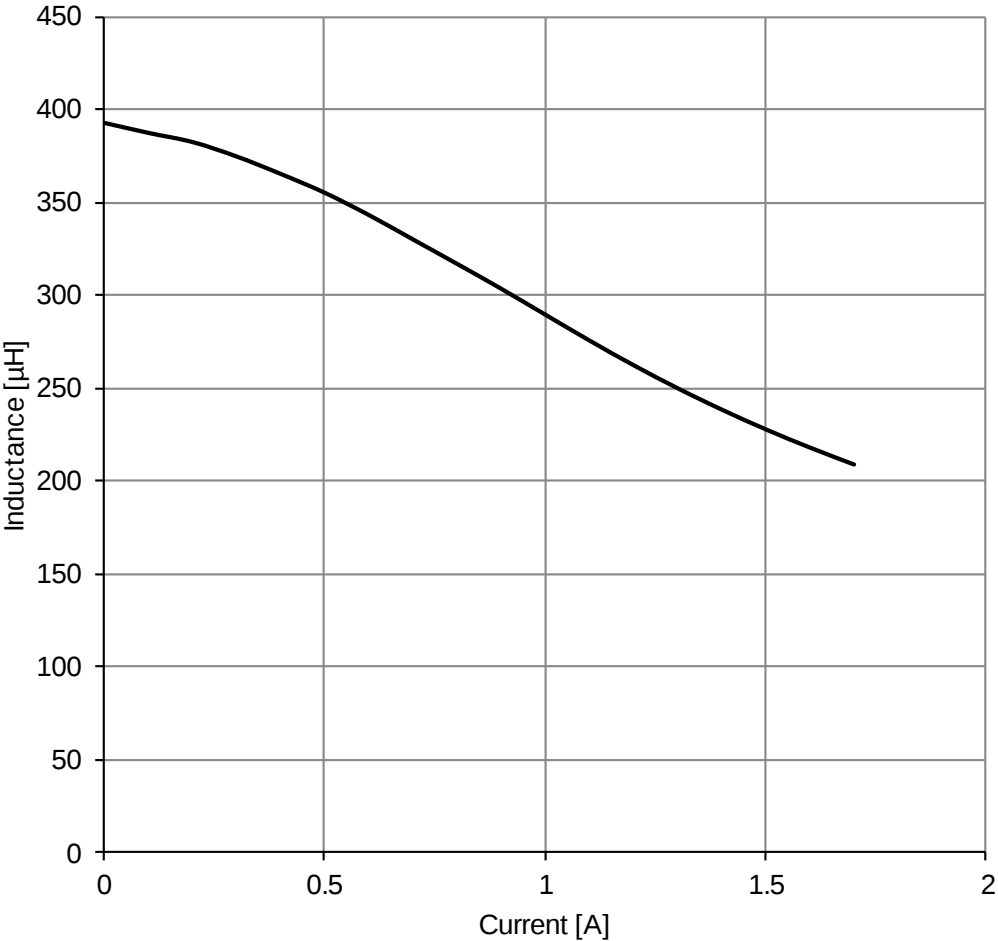

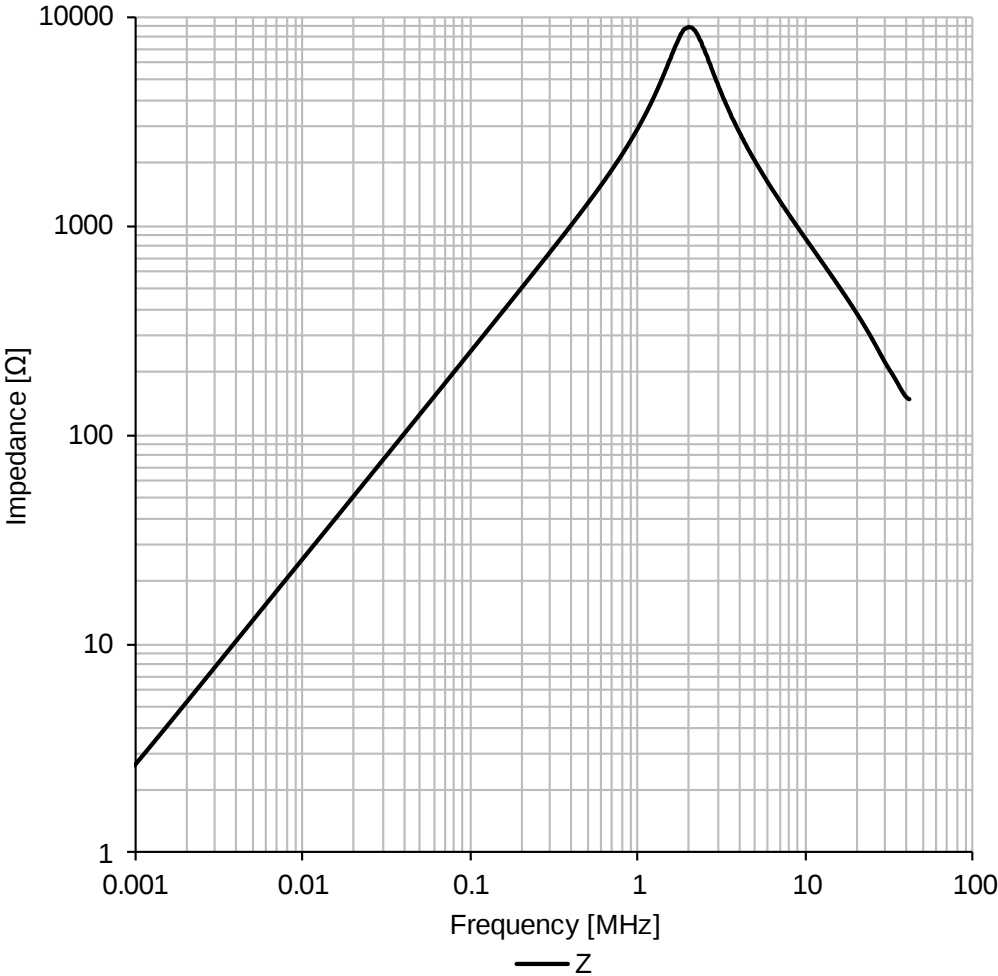

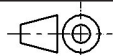

Typical Inductance vs. Current Characteristics:



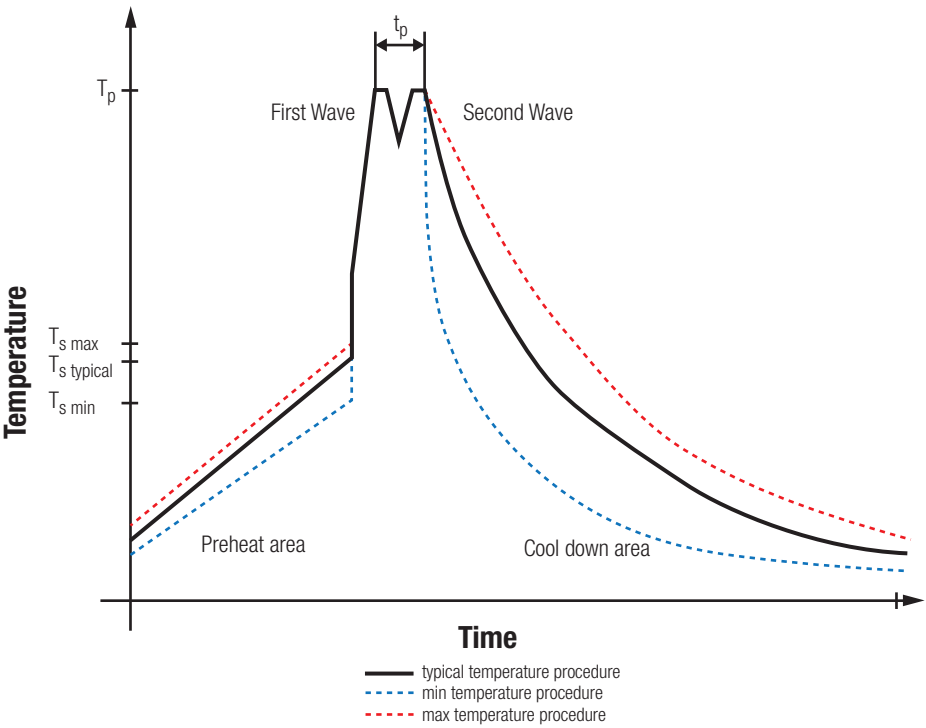
Typical Impedance Characteristics:

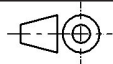

Product specific:

Soldering:

- • The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

Potting:

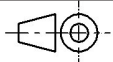
Packaging:
