Forward Clamping Voltage vs. Peak Pulse Current:



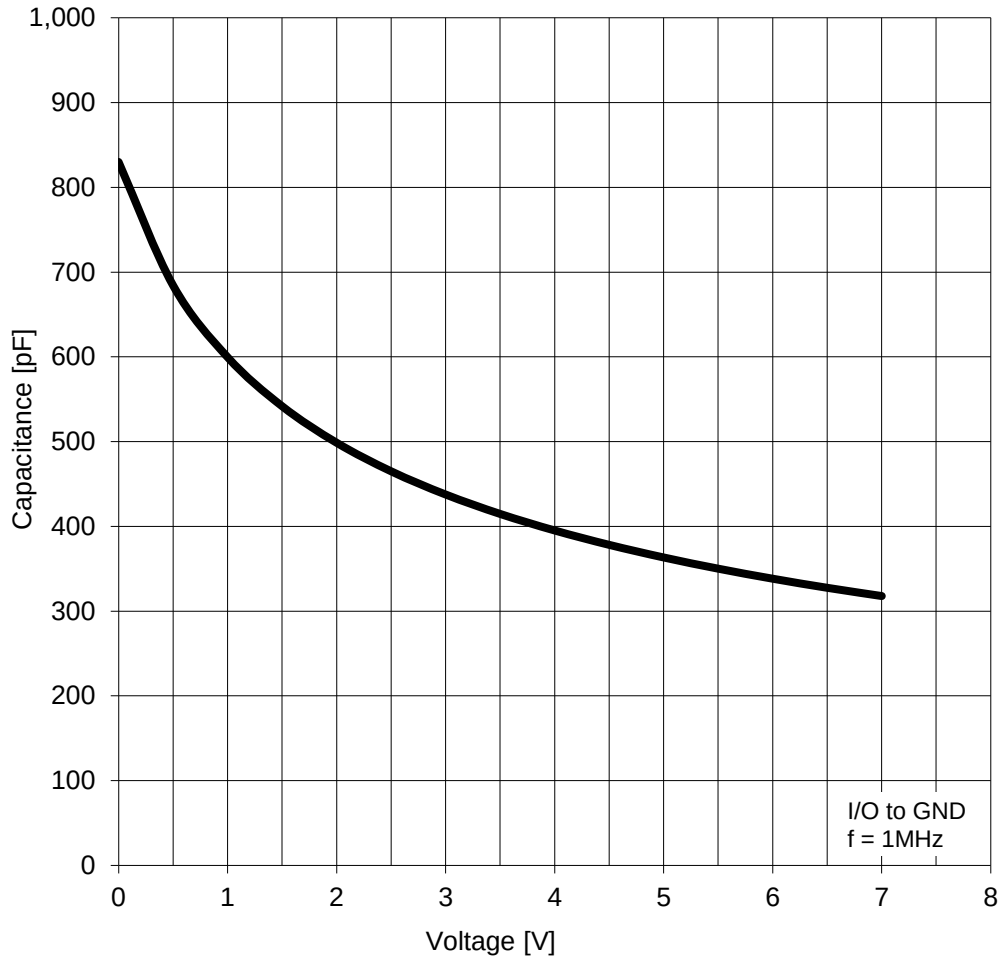
