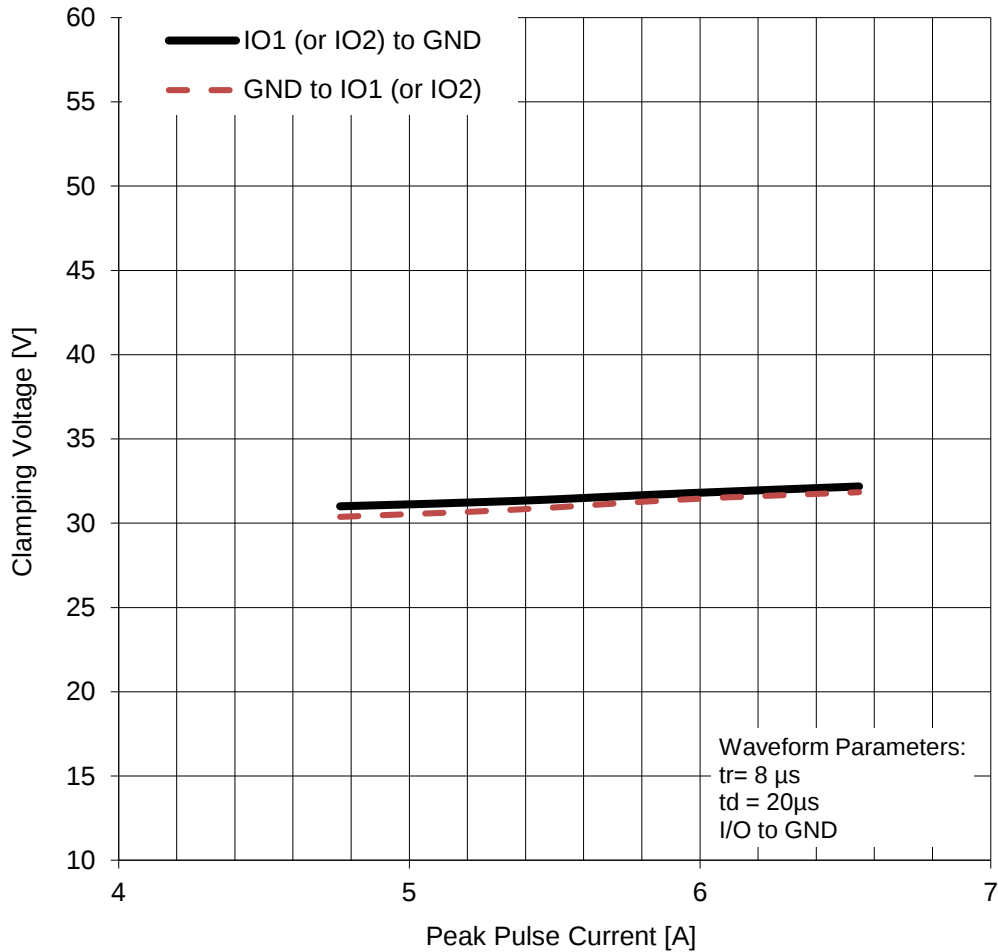

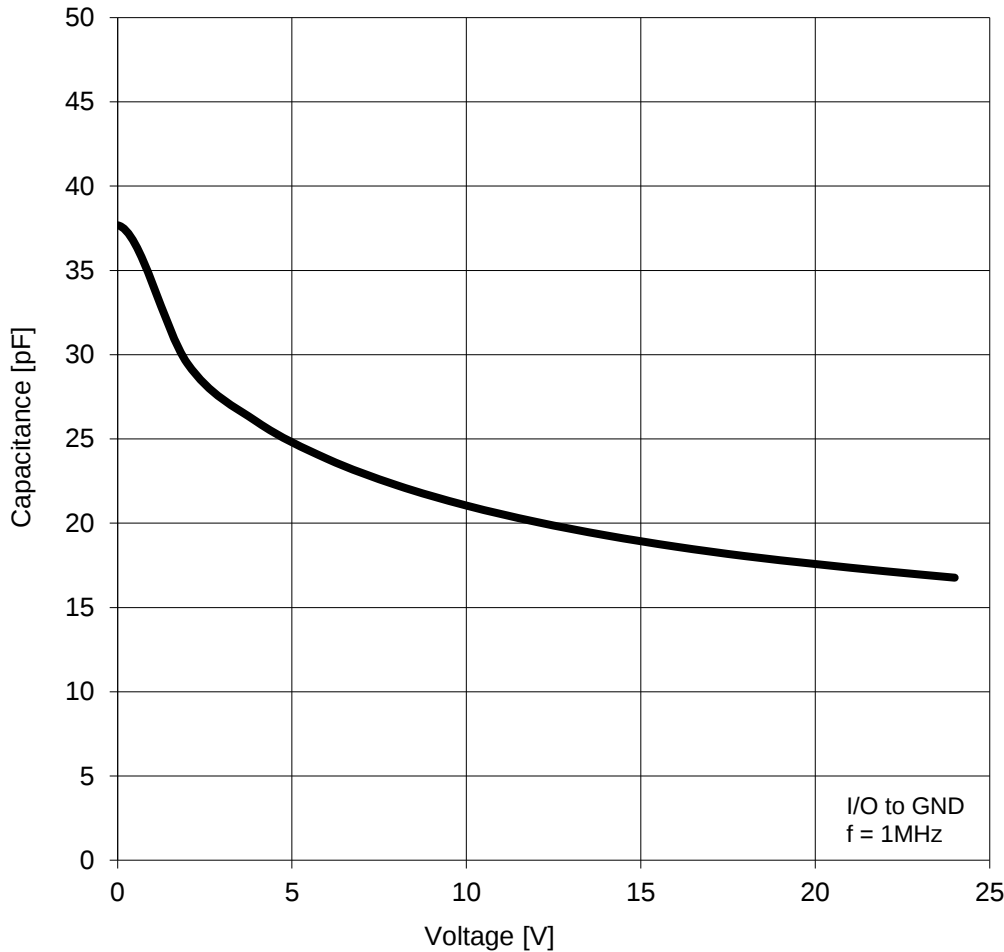
Transmission Line Pulsing (TLP) Measurement:



Clamping Voltage vs. Peak Pulse Current:



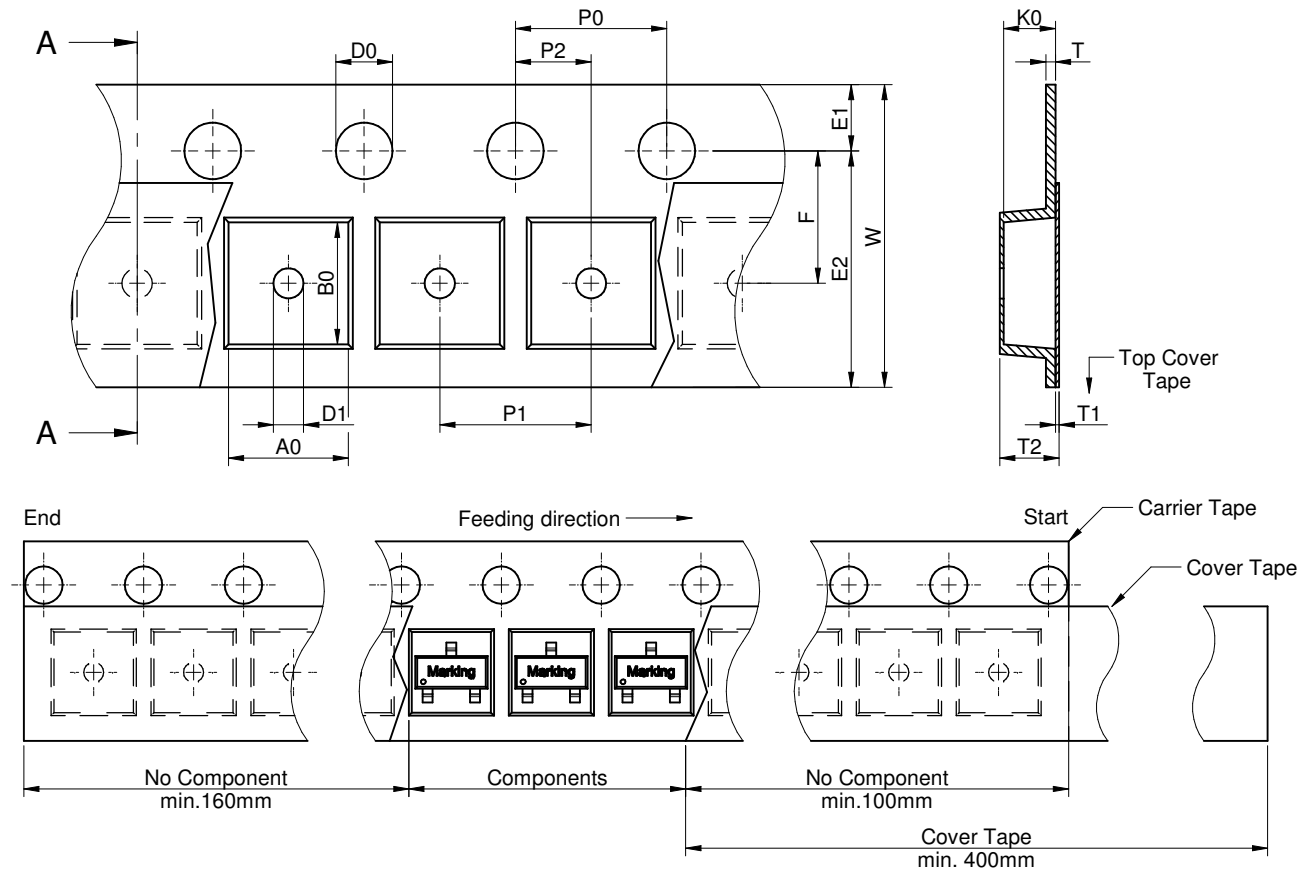
Variation of CIO vs. VIO:

In case of further queries regarding the PCN, the field sales engineer or the internal sales person in charge should be contacted. The basic responsibility of the customer as per Section 1 and 2 remains unaffected.

## 6. Product Life Cycle

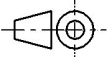
