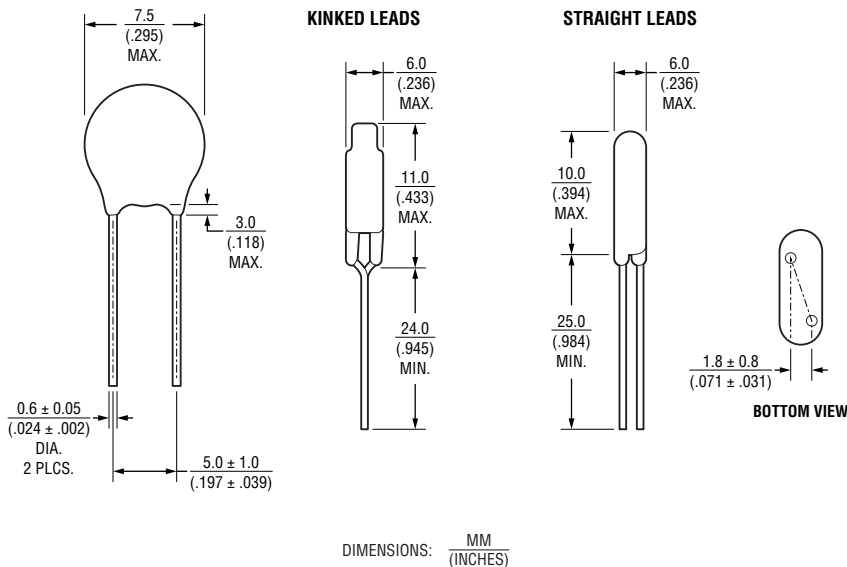

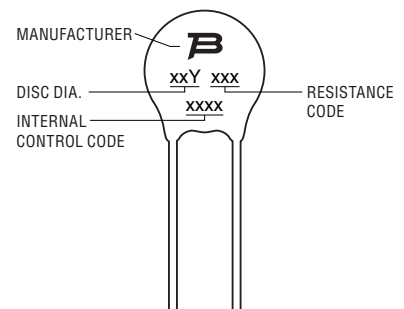

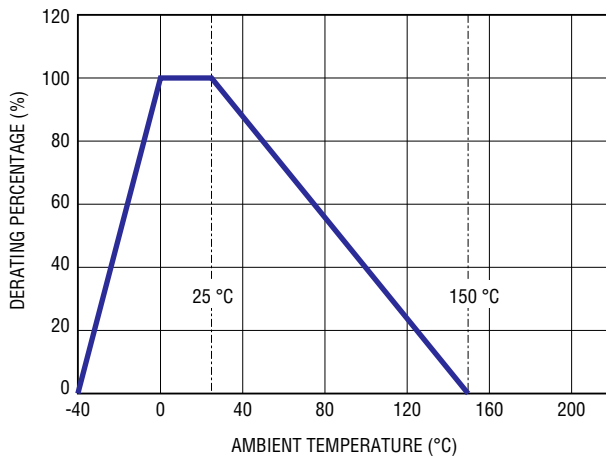

I_{max} Derating vs. Ambient Temperature Curves

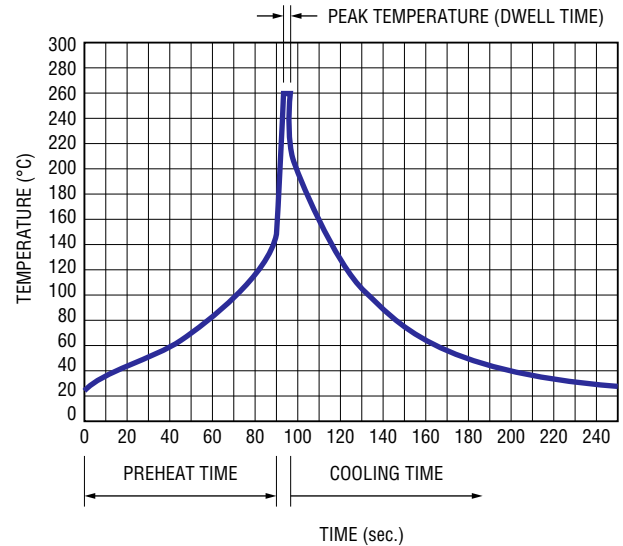
